Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of KBS Builders, Inc. 401(K) Plan, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the KBS Builders, Inc. 401(K) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan covers employees of KBS Builders, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings, and investments performance.

The Plan is a defined contribution plan established under the provision of section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC. The Plan is effective as of January 1, 2021. The Company contracted with Ascensus Trust Company to serve as Trustee of the Plan, and with the Vanguard Group Inc. through its agency relationship with Ascensus, LLC to provide participant recordkeeping and administrative services.

Eligibility

There are no age or service eligibility requirements to participate in the Plan. An employee is eligible to participate in the Plan immediately upon their hire date and may enter the Plan thereafter.

Participant Contributions

The Plan does not provide automatic pre-tax enrollment. Participants may choose to contribute their annual compensation, into a pre-tax deferral account and/or an after-tax Roth account, up to the maximum allowed by the Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans.

Employer Contributions

The Company may make discretionary matching contributions, profit-sharing contributions, and qualified nonelective contributions as determined by the Company, annually to the Plan. Profit sharing contributions and qualified nonelective contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. For the year ended December 31, 2024, no discretionary matching contributions, profit-sharing contributions, or nonelective contributions were made or declared.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of all assets attributable to their account. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan Administrator.

Notes Receivable from Participants

The Plan does not provide for loans. The existing participant loan balances and loan terms were established for loans which were transferred into the Plan upon Plan inception date.

The Plan was amended on October 8, 2023 to allow for participant loans with a subsequent amendment made on October 9, 2023 to remove the provision. There were no participant loan made during the year the year ended December 31, 2024.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum distribution, installment payments, direct rollover to an individual retirement account (IRA) or direct rollover to another employer's tax qualified plan. Active participants may withdraw any part of their account in a single sum in the event of undue financial hardship or attainment of age 59 ½. If the terminated participant's account is \$5,000 or less, the Plan may distribute the account balance in a lump sum without prior approval of the participant.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is vested in Company contributions based on the following schedule:

Forfeited Accounts

Generally, a participant's unvested portion of the Company contribution is forfeited upon termination of employment and can be used by the Company to pay Plan expenses or reduce matching contributions. Non-vested forfeited account balances at December 31, 2024 and 2023 were \$75 and \$1, respectively. For the year ended December 31, 2024, \$2,457 of forfeited amounts were used to pay plan expenses or reduce matching contributions.

Administrative Expenses

Expenses of the Plan, including legal, administrative, and advisory, are generally paid by the Company, with the exception of certain administrative expenses which are paid for by the Plan and allocated to the participants' accounts. Expenses that are paid by the Company are excluded from these financial statements.

Certain investment management fees and other charges paid to the Trustee are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as administrative expenses.

Plan Termination Provision

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become fully vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions are recognized in the period that contributions are due.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policy utilizing information provided by the Plan Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023, no allowance for credit losses has been recorded.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Valued at fair value by discounting to related cash flows based on current yields of similar instruments with comparable durations.

NOTE 5 - CORRECTIVE DISTRIBUTIONS PAYABLE

At December 31, 2024 and 2023 , a liability of \$19,991 and \$ 19,467, respectively, was recorded for the amounts refundable to participants for the contributions that exceeded the limits imposed by IRS nondiscrimination requirements.

NOTE 6- PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments and notes receivable are managed by Ascensus Trust Company. Ascensus Trust Company is the Trustee as defined by the Plan and, therefore, these transactions are considered to be exempt party-in-interest transactions. Administrative expenses paid by the Plan to Ascensus Trust Company and other service providers are considered to be exempt party-in-interest transactions.

NOTE 7 - TAX STATUS

The IRS has informed the Plan sponsor by a letter dated June 30, 2020, for the prototype plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying financial statements.
