Notes to Financial Statements

Note 1: Description of Plan

The following description of the Puritan Medical Products Company LP 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Puritan Medical Products Company (the "Company") who have thirty days of service and have reached the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Prior to September 2022, the Company's name was Hardwood Products Company LP. In September 2022, the Company went through a spinoff transaction and as a result of the spinoff, the name of the Company was changed from Hardwood Products Company LP to Puritan Medical Products Company LP. Effective November 21, 2022, the plan was amended to change the Company name and change the name of the Plan from Hardwood Products Company 401(k) Plan and Trust to Puritan Medical Products Company LP 401(k) Plan. On March 13, 2025, the Plan was retroactively amended to allow Hardwood Products, LLC as an adopting employer for the period September 1, 2022 through December 31, 2022. Effective January 1, 2023, this provision was removed from the plan as Hardwood Products, LLC was spun off into their own Plan. In 2024, plan assets were transferred out of this plan into the Hardwood Products Co., LLC 401(k) Plan in the amount of \$3,173.

Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants are also allowed to make Roth elective deferral contributions, which are after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and if they do not choose a different percentage, the percentage will be automatically increased each May 1 by 1%, up to a maximum percentage of 10%. Contributions are automatically invested in a designated fund until changed by the participant. The Plan also follows the Qualified Automatic Contribution Arrangement Safe Harbor provision. Under this provision, the Company match is 100% of the first 1% of compensation that a participant contributes to the Plan, plus 50% of the participants contributions between 1% and 6% of compensation. The Company match contribution for the year ended December 31, 2024 was \$399,450. All contributions are funded on a payroll period basis. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of plan earnings (losses), and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants become fully vested after two years of credited service, as defined by the Plan.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Interest rates on notes outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Note terms generally cannot exceed five years, unless the note is for the purchase of a principal residence, in which case the note terms may exceed five years. Principal and interest are paid ratably through monthly and weekly payroll deductions.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant may also elect to receive a series of substantially equal payments over a fixed period of whole years or a specified dollar amount each year. If the participant's balance does not exceed \$1,000, the Plan administrator may automatically distribute the balance as a lump sum distribution. If the account balance does not exceed \$5,000 (\$7,000 effective January 1, 2024), but is greater than \$1,000, the plan administrator may automatically distribute the balance, but must transfer the balance into an IRA on behalf of the participant, absent participant consent. Provided certain conditions are met, the participants may also be entitled to a distribution upon attaining age 59½. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$1,235 and \$98,995, respectively. Forfeited nonvested amounts may be used by the Plan to pay plan expenses, to reduce future Company contributions, or reallocated to participants in accordance with the plan document. During the year ended December 31, 2024, \$105,553 of forfeited nonvested amounts were used to reduce Company contributions and \$1,421 of forfeited nonvested amounts were used to pay administrative expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract (FBRIC)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments based on the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 12, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 3: Fair Value Measurements (Continued)

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts: Valued at the NAV of the underlying investments held by the collective investment trust, as reported by the fund house or other investment provider. The underlying investments are valued and published daily and transact at that price.

Note 4: Guaranteed Investment Contract With Insurance Company

The Plan invests in a traditional, fully benefit-responsive guaranteed investment contract with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, as custodian of the group annuity contract, which was issued by the Principal Life Insurance Company. The Principal Fixed Income Guaranteed Option (PFIGO) is a single group annuity contract with a fixed rate of interest. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The general account assets of Principal Life Insurance Company back these guarantees. All contributions received pursuant to the contract are maintained in Principal Life Insurance Company's general account.

Note 4: Guaranteed Investment Contract With Insurance Company (Continued)

The account is credited with earnings based on the guaranteed rate and reduced by any payments for participant withdrawals, administrative fees, or transfers. The Principal Fixed Income Guaranteed Option provides a guaranteed minimum interest rate of 1.00%. The interest crediting rate is reset every six months.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measure attributable to that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to equity wash provisions.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$689,633 and \$926,340, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator does not believe that any events that meet the required threshold to limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract permits the Plan sponsor to terminate the contract with a 12-month written irrevocable advance notice or 5% surrender charge.

Note 5: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee of the Plan.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the investment services during the plan year ended December 31, 2024 were offset against total investment income. The Plan also pays various service providers, including Principal Life Insurance Company, for fees associated with administrative services to the Plan. These transactions also qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The Company adopted a nonstandard pre-approved plan document with an IRS opinion letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
