Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Craddock Oil Company, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Craddock Oil Company, Inc. Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Craddock Oil Company, Inc, BlueSky Corporation, and What a Combo (collectively, the "Company"). Employees who have at least one year of service and are at least twenty-one years of age are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of their eligible pre-tax compensation, as defined by the Plan and subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also transfer amounts representing distributions from other qualified defined benefit or defined contribution plans, subject to regulatory requirements. The Company matches 100 percent of the first 3 percent of base compensation, plus an additional 50 percent of the contributions that exceed the first 3 percent of base compensation that a participant contributes to the Plan not to exceed 5 percent of the participant's compensation. Additional discretionary profit-sharing amounts may be contributed at the option of the Company's Board of Directors. There were no discretionary profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain limitations. The Company made matching contributions of \$195,990 for the year ended December 31, 2024.

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant compensation is earned.

Participant Accounts

Each participant's account is credited with the participant's contributions and (a) the Company's contributions, (b) an allocation of Plan earnings and losses, and (c) an allocation of forfeitures of employer profit-sharing contributions. Each participant account is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions or rollover contributions plus actual earnings thereon. A participant becomes fully vested in any employer matching or profit-sharing contribution amounts and related earnings thereon upon the participant's attainment of normal retirement age of 65, death, or disability during employment.

Payment of Benefits

On termination of employment for reasons other than death, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial distribution as requested by the participant. For termination of employment on account of death, a participant's beneficiary will receive the entire value of the vested interest by end of the fifth anniversary of the participant's death. In-service withdrawals can be made once the participant has reached age 59½, as defined in the Plan document and subject to regulatory requirements.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of the present value of their vested account balance, or the total balance up to \$10,000, whichever is less. Note terms range from 1 to 5 years or possibly longer if borrowed for the purchase of a primary residence. Participants may refinance their loans if it meets the requirements for refinancing under IRS regulations. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. The notes bear interest at rates ranging from 3.25 percent to 8.50 percent for the year ended December 31, 2024. Principal and interest are paid through payroll deductions from each regular paycheck.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their Company contributions and earnings thereon.

Forfeitures

Participant forfeitures of non-vested contributions can be either reallocated to the remaining participants based upon their relative account balances or used to offset future Company matching contributions or pay administrative expenses of the Plan. As of December 31, 2024, and 2023, there were no unallocated forfeitures from non-vested accounts. During the year ended December 31, 2024, there were no forfeitures used to offset Company contributions.

Administrative and Investment Management Expenses

Administrative expenses of the Plan, to the extent the Company does not pay such expenses, are paid by the Plan. Expenses that relate solely to a specific participant are assessed against such participant as provided in the Plan document. Fees paid by the Plan or assessed against participants of the Plan totaled \$26,319 for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Information Certified and Provided by American United Life Insurance Company ("American United")

The information pertaining to the Plan's investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including the associated investment income and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by American United, the custodian of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts held by the Plan are invested in domestic and international stocks, mutual funds or fixed securities. These are primarily valued at net asset value per share based on quoted market prices of underlying investments (Level 2).

Stable value fund: Stable value fund held by the Plan is a fixed investment in a group annuity investment product that determines fair value of its investments using the market approach and provides the declared interest rate as of the end of the Plan year. The use of quoted prices for identical assets and matrix pricing or other similar techniques are examples of market approaches. Fund value is based on an actuarial formula as defined under the terms of the contract (Level 2).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions and Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The Plan holds units or shares of pooled separate accounts and a stable value fund issued by American United. American United is the custodian as defined by the Plan and therefore, these transactions and the Plan's payment of administrative fees to American United qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses including investment management fees of the Plan are paid directly by the Company.

Note 6. Income Tax Status

The Company has adopted a prototype Plan sponsored by Craddock Oil Company, Inc. which received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The prototype plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

Note 7. Risks and Uncertainties

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date these financial statements were available to be issued.

Effective March 7, 2025, the Company transitioned its service provider from American United Life Insurance Company to Principal Financial Services. The transition does not affect the financial statements as of December 31, 2024, but will impact administrative processes going forward.
