## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Coker Tire Company 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1 - DESCRIPTION OF PLAN**

**General**

Coker Tire Company (the Company) established the Coker Tire Company 401(k) Profit Sharing Plan (the Plan) on January 1, 1982. During 2024, the Plan was merged with the Zip Products Inc 401(k) Profit Sharing Plan and Trust. Assets and participants from the Zip Products Inc 401(k) Profit Sharing Plan and Trust were transferred into the Plan effective February 22, 2024. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that covers all full-time employees of the Company, except non-resident aliens. The Plan requires participants be 21 or older and have 60 days of entry service for eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan and in accordance with applicable sections of the Internal Revenue Code (IRC). Additionally, Roth elective deferral contributions may be up to 100 percent of annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has an automatic enrollment feature, and a qualified automatic contribution arrangement that begins at three percent and increases by one percent each year until it is capped at 7 percent. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and mutual funds as investment options for participants. The Company matches 100 percent of the first three percent of participant deferrals and 50 percent of the next four percent of participant deferrals for a total employer match of 5 percent. Additional amounts may be contributed by the Company at its discretion. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant accounts are also charged a transactional administrative fee for certain distributions and other activity as specified in the service agreements. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after six years of credited service.

**Forfeited Accounts**

Forfeited accounts may be used to reduce Plan administrative expenses, reduce Plan contributions, or be relocated to participants' accounts. Forfeitures of \$51,033 were used to reduce employer contributions for the year ended December 31, 2024. At December 31, 2024, forfeited non-vested accounts totaled \$13,297 for the Plan.

**Payment of Benefits**

On termination of service due to termination, death, or retirement, a participant may elect to take a lump-sum distribution or rollovers into a new plan. Account balances less than \$5,000 can be distributed by the Company without participant election. Amounts less than \$1,000 will be provided with a lump-sum distribution upon termination. A participant may also receive an in-service withdrawal upon attaining age 59 ½. In addition, hardship distributions are permitted if certain criteria are met. Benefits are recorded when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Administrative Expenses**

Administrative expenses are the responsibility of the participants. Participants are also charged administrative fees for transactions such as withdrawal processing fees and qualification fees for qualified domestic relations orders. Plan expenses are allocated proportionally among all participants, with each individual's share being dependent on the specific investments and transactions involved.

**Subsequent Events**

The Company evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the net asset value per share as reported at the close of each business day. The fair value is considered readily determinable.

*Pooled Separate Accounts:* These investments are non-registered accounts offered through a group annuity contract. Assets allocated to the separate accounts can include, but are not limited to, stocks (both domestic and foreign), bonds, mortgages, real estate, mutual funds, other separate accounts, and cash or cash equivalents as specified in the separate account's investment policy. Principal Life Insurance Company owns the underlying investments in the separate accounts. The plan only owns units of participation. The value of a separate account is the market value of the underlying assets of the separate account plus income accrued but not yet received less operating expenses accrued but not deducted, if any.

*Common/Collective Trust:* Valued at the NAV per share at the close of each business day as reported by each fund. The fair value is derived daily from the exchange where the underlying securities are primarily traded. The fair value is considered readily determinable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of valuation methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - RELATED-PARTY TRANSACTIONS**

Certain Plan investments are pooled separate accounts and mutual funds managed by Principal Life Insurance Company, the certifying entity of the Plan. These transactions qualify as party-in-interest transactions.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE 7 - TAX STATUS**

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - CERTIFYING ENTITY CERTIFICATION**

The following is a summary of the unaudited information, included in the Plan's financial statements and supplemental schedules that was prepared or derived from information prepared by Principal Life Insurance Company, the certifying entity of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained a certification from Principal Life Insurance Company that such information is complete and accurate.

*Statements of Net Assets Available for Benefits* – all items and amounts.

*Statement of Changes in Net Assets Available for Benefits* – all items and amounts except for contributions, benefits paid to participants, administrative expenses, and transfers.

*Supplemental Schedule* – all items and amounts.

**NOTE 9 - SETTING EVERY COMMUNITY UP FOR RETIREMENT ENHANCEMENT (SECURE 2.0)**

In December 2022, SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2025 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

**NOTE 10 - PLAN MERGER AND ALLOCATION OF TRANSFERRED ASSETS**

On February 22, 2024, the Plan received assets totaling \$2,314,545 from a merged plan, Zip Products Inc. 401(k) Profit Sharing and Trust. These transferred assets were recorded in an unallocated holding account pending reconciliation and allocation to participant accounts. The assets represented participant balances from the merging plan that were temporarily held until participant-level information could be verified.

The allocation of the transferred assets to participant accounts was completed on March 12, 2024. This temporary unallocated balance did not affect the total net assets available for benefits as of December 31, 2024, but individual participant account balances were updated upon allocation.

Included with the plan merger was one participant loan that was issued prior to the merger and carries an interest rate of 4.25%. Payments will continue, as originally agreed until satisfied. Interest income on this loan has been included with Interest and Dividends on the statements of changes in net assets available for benefits. As loans are not permitted in this plan, there will be no future participant loans issued.
