### Report on the Audit of the Financial Statements

We have performed an audit of the financial statements of Jaco Oil Company 401(K) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Plan Description

The following description of the Jaco Oil Company 401(k) Retirement Plan (the "Plan") of Jaco Oil Company (the "Company") provides only general information. Participants should refer to the Basic Plan Document and Adoption Agreement that is incorporated by reference therein ("the Plan document") for a more complete description of the Plan's provisions.

a. General

The Plan, established June 2, 1994 as amended, is a defined contribution plan covering substantially all full-time employees of the Company who have completed one year of service, as defined in the Plan document, and attained the age of twenty-one. Employees covered by a collective bargaining agreement, leased employees and nonresident aliens who do not receive any earned income are not eligible to participate in the Plan. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The purpose of the Plan is to provide eligible employees a qualified plan which meets the requirements of Section 401(a) and 401(k) of the Internal Revenue Code (the "Code").

b. Trustee and Plan Administrator

Fidelity Management Trust Company (the "Trustee") executes investment transactions for the Plan. Certain Plan investments are shares of mutual funds managed by Fidelity Investments. The Company acts as Plan administrator (the "Plan Administrator").

c. Contributions and Withdrawals

Participants may contribute from 1 to 60 percent of their compensation annually, subject to certain limitations of the Code. Participants may change these percentages as of the first day of each month. Participants who have attained or are expected to attain age 50 before the close of the taxable year will be permitted to make Catch-Up Contributions of up to 100% but not less than 75% of compensation to the Plan, subject to limitations of the Code.

Participants are permitted to irrevocably designate that a portion or all of the deferral contributions made are Roth 401(k) contributions that are includable in the participant's gross income at the time deferred. Any participant who is still employed by the Company may elect to have any part of their account balance, which is fully vested, and not part of an outstanding loan balance designated Roth contributions.

An eligible employee who is entitled to receive a distribution that is eligible for rollover to a qualified plan under the Code may elect to contribute all or any portion of such distribution to the Plan directly from such eligible retirement plan without regard to the age and Eligibility Service requirements.

The Company makes a non-discretionary employer matching contribution equal to ten percent of the employees' contribution up to a maximum of \$500. The Company also made discretionary employer matching contributions equal to forty percent of employees' contribution. 2024 Plan year-end employer matching contributions were funded on January 22, 2025.

1. Plan Description (continued)

c. Contributions and Withdrawals (continued)

A participant must be employed as of the last day of the Plan year to be eligible for any matching contribution made for that Plan year. Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's non-discretionary matching contribution; (b) the Company's discretionary matching contribution, and (c) Plan earnings and losses.

The Company may contribute an amount which it designates as a Qualified Nonelective Employer Contribution ("QNEC") for any permissible purpose. QNEC shall be allocated to all Participants who were eligible to participate in the Plan at any time during the Plan Year and are Non-Highly Compensated Employees in the ratio which each such Participant's "testing compensation", as defined in Subsection 6.01(s) of the Plan Document, for the Plan Year bears to the total of all such Participants' "testing compensation" for the Plan Year. The QNEC must be 100% vested. The Plan failed the annual ADP and ACP compliance tests in 2024 and 2023. It must either return to participants' contributions in excess of amounts allowed by the IRS or make a protective contribution to avoid Plan disqualification. The Company funded QNEC contributions of \$212,202 and \$71,358 on March 24, 2025 and March 13, 2024, respectively.

Participants may make hardship withdrawals from their deferral and any rollover contributions made, upon demonstrating immediate financial need, as defined in the Plan document.

d. Benefits

Upon termination of service, a participant, or his or her beneficiary, may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The forms of payment are lump-sum distributions or annual installments.

e. Vesting

Participants are immediately vested in their contributions plus the actual earnings thereon. Participant's vest in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon based on years of continuous service. A participant vests 20 percent per year of service and is 100 percent vested after five years of service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,730 and \$446 (unaudited), respectively. These accounts will be used to reduce future employer contributions and costs of administering the Plan.

f. Investment Options

The Plan provides for participant-directed investment options and fee based managed accounts primarily offered by Fidelity Institutional Retirement Services Company, Inc. Participants may choose from permitted registered investment funds in which to invest their account balances, with the ability to change their options daily. The Company periodically makes changes to the investment funds offered in the Plan.

1. Plan Description (continued)

f. Investment Options (continued)

Investment securities are exposed to various risks, such as market, interest rate and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

g. Notes Receivable from Participants

Participants may borrow from their accounts the lesser of \$50,000 or 50-percent of the vested account balance. Loans bear interest at an agreed-upon percentage based on prevailing market rates, currently 5%. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 30 years. Principal and interest is paid ratably through monthly payroll deductions. Participant loans that are held by terminated employees are immediately due and payable, and the participant is deemed to have received a taxable distribution. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50%, with various maturities through January 2051.

Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024.

h. Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. A significant subsequent event is disclosed at Note 9.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

c. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan and are included in these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

d. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. Summary of Significant Accounting Policies (continued)

d. Investment Valuation and Income Recognition (continued)

The investments are reported at fair value. The Trustee certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

e. Net Appreciation in Fair Value of Investments

Net appreciation in fair value of investments is based on the market value of the assets at the beginning of the Plan year or at the time of purchase for assets purchased during the year and the related fair values on the day the investments are sold with respect to realized gains and losses, and on the last day of the Plan year with respect to unrealized gains and losses. Net realized and unrealized appreciation is recorded in the accompanying Statement of Changes in Net Assets Available for Benefits as net appreciation in fair value of investments.

f. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

g. Payment of Benefits

Benefits are recorded when paid.

3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023

- Net appreciation in fair value of investment, interest and dividends, and interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024
- Investments, as shown in the Schedule of Assets (Held at End of Year) as of December 31, 2024

The Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the Plan has the ability access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets.
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments held at December 31, 2024 and 2023 were Level 1 investments.

#### 5. Tax Status

The Plan received a favorable renewed determination letter from the Internal Revenue Service (the "IRS") dated June 30, 2020, indicating that the Plan is designed in compliance with the qualification requirements of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100 percent vested in employer contributions.

#### 7. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan engages in certain transactions involving the Trustee, a party-in-interest as defined by ERISA. These transactions involve investing in mutual funds managed by a subsidiary of the Trustee.

10. Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals related to the 2024 plan year were not remitted to the Plan within the timeframe required by the Department of Labor. The Company remitted lost earnings to participant accounts during 2024.
