## INDEPENDENT AUDITORS' REPORT

To the Trustees of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit Financial Statements

We have performed audits of the financial statements of Metal-Fab Inc. Employees Retirement Plan, an employee benefits plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Metal-Fab Inc. - The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Metal-Fab Inc. Employees Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. December 31, 2024 and 2023

### 1. DESCRIPTION OF PLAN

The following description of Metal-Fab, Inc. ("Company") Employees Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan. Employees who are at least 21 years old can elect to become active participants in the Plan following the completion of 1 year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year, participants may make voluntary contributions to the Plan from 1% to 75% of their compensation up to the maximum allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employee Roth contributions are permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct investment of their accounts into various investment options offered by the Plan; however, participants are limited to one transfer every thirty days for each investment. The Company has the option to contribute a discretionary amount of matching contributions to the Plan. Company profit-sharing contributions for active participants with at least 1,000 hours of service are discretionary as determined by the Company's executive leadership. Contributions are subject to certain limitations.

**Participant Accounts.** Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, Plan earnings and are charged with an allocation of administrative expenses. Allocations are based on participant contributions, compensation, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service, upon normal retirement age, or upon death or disability while still employed by the Company.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest from 5.25% to 10.50%, as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits.** Upon termination of service, death, disability or retirement a participant may receive a lump sum payment. However, if the participant's vested interest in his or her account does not exceed \$1,000, a lump sum distribution may be made. If the participant's vested interest in his or her account is greater than \$1,000 but does not exceed \$5,000, an automatic distribution can be made as a direct rollover to an individual retirement plan. An account balance of \$5,000 or more may be left in the Plan or paid to the participant if so elected.

**Forfeited Accounts.** Participants who leave the service of the Company before becoming fully vested in the plan forfeit the non-vested portion of the Company's matching and discretionary contributions previously credited to the participants' account, plus actual earnings thereon. Forfeited accounts are used to reduce administrative expenses and future employer matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's Investments are stated at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investments companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

The Plan's Principal Stable Value Fund is held in a common collective trust. The fair value of this investment is determined by reference to the trust's underlying assets. Shares of common collective trust funds are valued using valuation methods prescribed by Principal Trust Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments in pooled separate accounts are stated at fair value. Fair value of each pooled separate account is determined at the close of each business day based on market value. The value of the Account is expressed in "units". The "unit value" is the dollar value of one unit and is determined at the close of each business day by dividing the value of the entire Account by the total number of units in the Account. See Note 6 for a discussion of fair value measurements.

Contributions to the Account increase the number of units. Withdrawals from the Account decrease the number of units. The increase or decrease in number of units is determined by dividing the amount of the contribution or withdrawal by the unit value for the day the transaction is made. The value of the customer's account on any date is determined by multiplying the number of units held by the unit value at the close of the business day.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

**4. ADMINISTRATION OF THE PLAN**

Certain administrative functions are performed by employees of the Company. No employee receives compensation from the Plan. Some administrative expenses for the Plan are paid directly by the Company.

**5. TAX STATUS**

The Plan has adopted the prototype plan of Principal Life Insurance Company. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) pronouncement, Auditing Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid recordkeeping fees to the plan custodian of \$73,169 and \$67,664 for the years ended December 31, 2024 and 2023, respectively. Certain Plan investments are shares of pooled separate accounts managed by Principal Trust Company, who is the custodian of the Plan assets and, therefore, these transactions qualify as party-in-interest transactions. The Plan has various service providers and these providers are considered parties in interest.

#### 8. NONEXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. The Company remitted all employee contributions to the Plan within the required time period for the year ended December 31, 2024.

#### 9. FORFEITED ACCOUNTS

During the years ended December 31, 2024 and 2023, forfeitures of employer matching non-vested accounts were \$1,985 and \$4,489, respectively. At December 31, 2024 and 2023, unallocated forfeiture accounts totaled \$-0-. Forfeitures are used to reduce employer match contributions.

#### 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 11. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

#### 12. SUBSEQUENT EVENTS

Management has evaluated all subsequent events since December 31, 2024 through September 18, 2025, the date of the independent auditor's report. There have been no subsequent events that would require changes to the accompanying financial statements or disclosures therein.
