Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Jake's, Inc. Employees' Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Liquidation Basis of Accounting

As further discussed in Note J to the financial statements, the Plan entered into a sale transaction with U.S. Foods on January 10, 2025. As a result, Plan management made the determination to terminate the Plan as of January 9, 2025, and changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jake's, Inc. Employees' Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to the Financial Statements

A. Description of the Plan

The following brief description of the Jake's, Inc. Employees' Profit Sharing Plan (plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The plan is a defined contribution plan covering all employees of Jake's, Inc. (the "company") except union employees. Eligible employees must be age 21 or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute up to the maximum amount allowed by law. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The plan includes an auto-enrollment whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and will increase 1% per year up to 10% of compensation. All employees who are eligible to make elective deferrals under this plan and who have attained the age of 50 before the close of the plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the Code.

Each plan year, the company, in its sole discretion, may make employer matching contributions. The matching contribution will be allocated among all eligible participants on a pro rata basis using a fraction calculated by dividing each participant's matched employee contributions by the total participant matched employee contributions for all eligible participants. The total amount of the matching contributions will not exceed 10% of compensation. Additionally, each year the company, in its sole discretion, may make a profit sharing. The company's profit-sharing contribution will be allocated among all eligible participants on a pro rata basis. An eligible participant must be employed by the company on the last day of the plan year in order to receive a profit-sharing contribution.

Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in the current market value of their contributions to the plan plus actual earnings thereon. Vesting in the company's matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants not fully vested receive rights to the company's contributions as follows:

On December 31, 2024, all participants became 100% vested.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Hardship distributions are permitted by the plan.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Forfeitures

Accumulated forfeitures are available to pay administrative expenses and fund company contributions to the plan. Accumulated forfeitures for 2024 and 2023 were \$32,456 and \$33,389, respectively. Forfeitures of \$52,294 were used during 2024.

B. Summary of Significant Accounting and Reporting Policies

Basis of accounting

The financial statements are maintained on the liquidation basis of accounting for the year ended December 31, 2024 and the accrual basis of accounting for the year ended December 31, 2023 in accordance with U.S. generally accepted accounting principles.

B. Summary of Significant Accounting and Reporting Policies – Continued

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note C for a discussion of fair value measurements.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

Certain administrative expenses of maintaining the plan are paid by the company. Contract administrative fees are paid by the plan.

Subsequent events

The plan has evaluated subsequent events through October 08, 2025, the date the financial statements were available to be issued.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability. The plan distributed the excess contributions to the applicable participants during the subsequent year.

C. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The mutual funds are reported at Level 2 investments since they are included in pooled separate accounts. There have been no changes in methodologies used for investments measured at fair value nor transfers between levels.

D. Related Party Transactions and Party-In-Interest Transactions

During 2024 and 2023, the plan investments were pooled separate accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions.

E. Plan Termination

The company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. See Note J for further information.

F. Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan's tax counsel believe that the plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Custodial Certification

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by John Hancock Life Insurance Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a.* Total investments as shown in the accompanying statements of net assets available for benefits of \$12,120,787 as of December 31, 2024, and \$11,362,395 as of December 31, 2023.
- b.* Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$1,430,658 for the year ended December 31, 2024.
- c.* All investment-related information in the accompanying supplemental Schedule H, Line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

I. Failure to Timely Transmit Participant Contributions

The Company failed to remit to the Plan certain participant contributions and loan repayments during 2023 (\$32,317) and 2022 (\$53,134) totaling \$85,451, within the period prescribed by the DOL's regulations. Plan officials adopted stricter oversight in this area and made contributions to the affected participants' accounts to compensate those participants for potential lost earnings and corrected the prohibited transaction by filing Form 5330 Return of Excise Taxes Related to Employee Benefit Plans.

J. Liquidation Basis of Accounting

On January 10, 2025, the Plan sponsor's operations were sold and all employees became employees of the surviving company. Plan assets will continue to be held on behalf of participants and their beneficiaries until distributed in accordance with the Plan terms. Contributions under the Plan are permanently discontinued as of January 9, 2025. Participants shall be 100% vested in their accounts. Management determined the liquidation basis of accounting was appropriate at December 31, 2024.

The assets of the Plan have been fair valued based on the market at year end. Income and expense cannot be reasonably estimated through termination and have not been accrued in these financial statements. Income from investments along with the corresponding investment fees of the plan and fees for distributions will be reported annually. Management cannot reasonably determine when all participants will request their distributions.
