December 31, 2024 and 2023

1. Description of Plan

The following brief description of the Mt. Ogden Eye Center, LLC (the “Company”) Profit Sharing 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering all employees of the Company. Employees are eligible for participation upon hire. Employees are eligible for employer matching and profit sharing after one year of service. Entry dates for employee and employer contributions are on the first day of each month. The Plan is subject to the provisions of ERISA. Plan management is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to Plan management.

Contributions. Participants may elect to defer a percentage of earnings as either pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions to various investment options offered by the Plan. The Company may make a discretionary matching contribution and/or a profit-sharing contribution to the Plan. During the year ended December 31, 2024, Company contributions totaled \$732,481. Contributions are subject to certain IRS limitations.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and Company discretionary matching contributions and profit-sharing contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

1. Description of Plan (continued)

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans bear interest at a rate of one percentage point over prime rate. Loans must be repaid within five years. All loans are secured by the participant's account and, regardless of term, become due and payable upon termination of the participant's employment.

Payment of Benefits. Distributions and withdrawals are generally payable upon termination, financial hardship, total disability, death, or the attainment of the normal retirement age of 65. Distributions may be made in either a single lump-sum payment, or in partial withdrawals of at least \$1,000. Participants are eligible to begin receiving distributions of all vested account balances when reaching 59 ½ years of age.

Forfeited Accounts. Forfeitures on unvested portions on company matching contributions may be used to pay Plan expenses or offset future employer contributions. During the year ended December 31, 2024, forfeitures of \$12,893 were used to offset Company contributions and no forfeitures were used to offset Plan fees. As of December 31, 2024 and 2023, there were unallocated forfeitures of \$44,078 and \$12,297, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

3. Information Certified by the Plan's Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee and recordkeeper of the Plan.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on quoted redemption values on the last business day of the Plan year.

Insurance company contracts: Valued at the daily rate which is a blend of the contract's rate of return and the liquidity component's daily rate based on the contract value which is based on the provisions of the contract.

5. Investment Contract with Insurance Company

The investment options of the Plan at December 31, 2024 and 2023 included a Key Guaranteed Portfolio Fund (“KGPF”). This fund is a general account product of Empower Annuity Insurance Company of America (“EAIC”). As a general account product offered through the group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of EAICA.

The KGPF credits interest daily to the group contract holder on a portfolio basis. The crediting interest rate may change or stay the same each quarter. The quarterly crediting rate applies to all money deposited in the group contract holder’s KGPF account, regardless of when it was deposited. A participant may transfer their account balance in the KGPF to any other investment option offered under the Plan at any time, with no restrictions or penalties because the KGPF is designed to be a plan’s only capital preservation option.

6. Party-in-Interest Transactions

Certain plan investments are shares of group annuity contracts issued by Great-West Life & Annuity Insurance Company, an affiliate of the trustee, Great-West Trust Company, LLC, and therefore, these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from the prohibition transaction rules under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Tax Status

In an opinion letter dated November 14, 2022, the Internal Revenue Service ruled that the Defined Contribution Pre-Approved Plan adopted by the Company qualifies under Internal Revenue Code ("IRC") Section 401 and is, therefore, not subject to tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor ("DOL"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Reconciliation of Financial Statements to Form 5500

The 5500 has been prepared on the cash basis and does not include receivables due to the Plan at December 31, 2024 and 2023. The following is a reconciliation of net assets available for benefits per the financial statements at December 31, 2024 and 2023, to Form 5500:
