INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Colectivo Coffee Roasters, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Colectivo Coffee Roasters, Inc. Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions, as further described in Note 1 to the financial statements, covering the years and periods ended December 31, 2024 and 2023, stating that the investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Colectivo Coffee Roasters, Inc. Retirement Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 21, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - Colectivo Coffee Roasters, Inc. is the plan sponsor, employer and plan administrator. Prior to April 18, 2024, Newport Trust Company was the plan trustee that held custody of the plan's investment assets and Newport Group, Inc. was the third party administrator that maintained plan documents, recordkeeper that maintained participant investment records and tax counsel that performed various compliance tests. The two Newport entities are collectively referred to as "Newport". Effective April 18, 2024, Ascensus Trust Company ("Ascensus") assumed all of Newport's responsibilities as a result of a merger between Newport and Ascensus.

Effective December 16, 2024, Fidelity Management Trust Company assumed the role of plan trustee the holds custody of the plan's investment assets and Fidelity Workplace Services, LLC assumed the role of the third party administrator that maintains plan documents, tax counsel that performs various compliance tests and recordkeeper that maintains participant investment records. The two Fidelity entities are collectively referred to as "Fidelity." Wealth Enhancement Group is the plan's investment advisor.

In connection with the transition from Ascensus to Fidelity, all plan assets were transferred out of Ascensus prior to December 31, 2024. Substantially all assets were received by Fidelity on January 3, 2025. All other transferred were received by Fidelity prior to December 31, 2024. As a result, the statement of net assets available for benefits as of December 31, 2024 reflects these amounts as noninterest-bearing cash in transit.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in fair value of investments bought, sold and held during the years, are reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - The plan invests in mutual funds that are valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trust - The common/collective trust held by the plan is a direct filing entity and is valued at its NAV. The NAV is used as practical expedients to estimate fair value and is generally based on the fair values of the underlying investments held by the common/collective trust less its liabilities. The practical expedient would not be used if it is determined to be probable that the common/collective trust would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General - The plan was established as a defined contribution plan on January 1, 2003. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible once they have completed one year of service, defined as 1,000 service hours, and have reached age twenty-one. An employee can enter the plan on the earlier of the January 1 or July 1 following the date the employee has satisfied the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- Participants may contribute a percentage of their compensation subject to certain limitations (employee elective deferral contributions). The plan also permits Roth elective deferral contributions.
- Rollover contributions are accepted by the plan from other qualified plans.
- Employer safe harbor matching contributions are made by the employer equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation that a participant contributes to the plan. Such contributions are remitted coinciding with each payroll.
- Employer nonelective contributions may be made at the employer's discretion. There were no such contributions in 2024 or 2023.

Participant accounts - Each participant's account is credited with employee elective deferral contributions, rollover contributions and an allocation of the employer's contributions. Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Participants are allowed to transfer funds between the various investment options daily, stop their deferral each payroll and change their deferral percentage each January 1 and July 1.

Vesting - Participants are always 100% vested in their entire account balances.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death or disability. In-service withdrawals can commence upon attaining the age of 59½. Distributions are made in the form of a single lump sum. In addition, hardship withdrawals are permitted under certain circumstances as defined in the plan document.

Administrative expenses - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for distribution processing fees and nonparticipant directed charges for service and administrative fees. The nonparticipant directed charges are allocated to participants on an account value basis.

Notes receivable from participants - Loans to participants are not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investment options are managed by the custodians. The custodians also provide certain administrative services to the plan pursuant to service agreements between the plan sponsor and custodians and therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the plan to the custodians were \$10,000 in 2024 and \$8,000 in 2023. In addition, the custodians receive indirect compensation from mutual fund providers for services provided to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan for administrative services. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA.

5. INCOME TAX STATUS

Effective December 16, 2024, the plan adopted a Fidelity non-standardized pre-approved profit sharing plan. that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenues Code. Prior to December 16, 2024, the plan was operating under an Newport Group Inc. non-standardized pre-approved profit sharing/money purchase/coda plan that received a favorable opinion letter on June 30, 2020. There were no functional changes to the plan as a result of this adoption. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.
