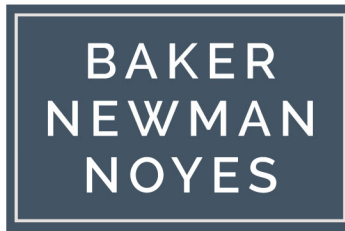

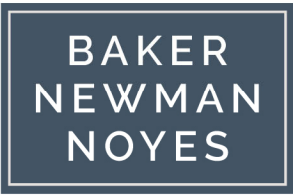

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of Plan

The following description of the Irving USA Employees 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Irving Oil Terminals, Inc. (the Company) who have three months of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Security Act of 1974* (ERISA).

Effective January 1, 2023, Irving Oil Investments Corporation merged with and into Irving Oil Terminals, Inc., and Irving Oil Terminals, Inc. became the employer of the employees of Irving Oil Investments Corporation. Effective May 1, 2023, Highland Fuel Delivery, LLC and Irving Oil Marketing, Inc. merged with and into Irving Oil Terminals, Inc., and Irving Oil Terminals, Inc. became the employer of Highland Fuel Delivery, LLC and Irving Oil Marketing, Inc. employees. All of the employees of Irving Oil Terminals, Irving Oil Investments Corporation, Highland Fuel Delivery, LLC and Irving Oil Marketing, Inc. were previously eligible to participate in the Plan.

As a result of the above mergers, Irving Oil Terminals, Inc. became the Plan Sponsor in place of Irving Oil Investments Corporation.

Eligibility

Eligible employees include all regular full-time employees of the Company who are not covered under a collective bargaining agreement (CBA). Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following completion of three months of service.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

1. Description of Plan (Continued)

The Company contributes a safe harbor match of 100% of the first 3% of eligible compensation that an eligible participant contributes to the Plan, plus 50% of the amount of a participant's elective deferrals in excess of 3%, but limited to 5% of the participant's compensation. Non-safe harbor matching contributions and additional profit sharing amounts may also be contributed at the discretion of the Company. During the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions of \$2,203,553 and \$2,060,919 to the Plan, respectively. During the years ended December 31, 2024 and 2023, the Company made non-safe harbor matching contributions of \$64,695 and \$74,463 to the Plan, respectively. The Company did not make any profit sharing contributions to the Plan during the year ended December 31, 2024 or 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's profit sharing contribution, and (b) plan earnings (losses). Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are vested immediately in their voluntary contributions and the Company safe-harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing and non-safe harbor matching contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 25% per year beginning with the first year of service. Participants become fully vested after four years of service.

Forfeitures are used to reduce future Company contributions. At December 31, 2024 and 2023, forfeited nonvested amounts available were not material.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.75% to 10.00%, which are commensurate with local prevailing rates determined by the Plan Administrator, and maturity dates through 2039. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, retirement, death or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant may also elect to receive their benefit in installments as long as their vested interest exceeds \$5,000. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

Trust Fund Management

Charles Schwab Trust Bank is the Trustee of the Plan's investments and notes receivable from participants.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Participant contributions are recorded in the period in which payroll deductions are made; employer matching, profit sharing and safe harbor contributions are recorded in the same period as corresponding participant contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in total investment income.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Events occurring after the statements of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the carrying value per share, which materially approximates the fair value of the underlying investments due to their short-term nature.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 60 days' notification in order to ensure that securities' liquidation will be carried out in an orderly business matter.

Collective Trust Fund – Vanguard Retirement Savings Trust

The Plan invests in a collective trust fund called the Vanguard Retirement Savings Trust. The Vanguard Fiduciary Trust Company serves as Trustee to the Trust. The Trust provides for the collective investment of assets of tax- exempt pension and profit-sharing plans. The Trust invests solely in the Vanguard Retirement Savings Trust Master Trust. The underlying investments of the Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds and trusts. The issuers' ability to meet these obligations may be affected by economic developments in their respective companies and industries.

The Vanguard Retirement Savings Trust seeks to provide current and stable income, while maintaining a stable share value of \$1. The fund seeks to achieve its objective by diversifying among high-credit-quality investments and investment contracts that are structured to smooth market gains and losses over time. The fund provides for daily redemptions by the Plan at reported net asset value, with no advance notice requirements or unfunded commitments.

4. **Information Prepared and Certified by the Trustee**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Charles Schwab Trust Bank, the Plan's Trustee, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the Trustee meets the requirements of a qualified institution defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's investments, notes receivable from participants, related income and transactions, including net appreciation (depreciation) in fair value of investments, were certified as complete and accurate by Charles Schwab Trust Bank as of and for the years ended December 31, 2024 and 2023.

5. **Related Party and Party-in-Interest Transactions**

Certain plan investments are managed by Charles Schwab, an affiliate of Charles Schwab Trust Bank, the Trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. There were no direct fees paid by the Plan to Charles Schwab in 2024 or 2023. The Plan also incurred and paid fees for recordkeeping, auditing and investment advisory services to service providers that also qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company non-safe harbor contributions and discretionary profit-sharing contributions.

7. Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020, which stated that the form of the Plan as then designed is in accordance with applicable sections of the IRC. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan Administrator and Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.
