To the Participants and Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ohio Valley Physicians, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

The following description of the Ohio Valley Physicians, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a qualified, defined contribution employer plan that provides participant-directed investment programs to all eligible employees of Ohio Valley Physicians, Inc. (the “Company”) who have completed one year of service and have attained the age of 21. Employees may enroll in the Plan on the first day of January or July coinciding with or next following the date on which an employee meets the eligibility requirements.

During 2021, the Plan was amended to allow eligible employees of Lineage Health Solutions, LLC and OVP Health Care, Inc. to participate in the Plan.

The Plan is a volume submitter plan sponsored by CCH Incorporated. Broker’s commissions associated with investment transactions and investment management fees are paid by the Plan. The Plan is regularly updated to comply with tax legislation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Each year, participants are able to contribute a percentage of their pay to the Plan, up to the maximum allowable contribution, as defined in Federal legislation. This amount is then deposited in the participant’s account as a 401(k) contribution.

Participants may rollover amounts from other eligible retirement plans to the Plan. The amounts transferred shall be allocated to the participant’s rollover contribution account. Such amounts and any earnings or losses shall be fully vested at all times.

Employer Contribution

Each plan year, the Company may elect to make a safe harbor nonelective contribution to the participant’s account equal to 3% of the participant’s compensation for the plan year. Eligibility to receive safe harbor nonelective contributions begins on the same date as eligibility for participant contributions. Any compensation participants earned during the plan year, but prior to the date on which they became eligible to receive safe harbor nonelective contributions, will be excluded when determining their safe harbor nonelective contribution. The Company will provide notice each year of its obligation to make safe harbor nonelective contributions to the participant’s account and of the other benefits provided under the Plan.

Additional profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. No discretionary contributions were made by the Company during the Plan year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with (a) the participant’s contribution, (b) the Company’s contribution and (c) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the safe harbor contribution plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate between 5.50% to 10.50%, which was 2.00% above the prime rate at the time the loans were made. Principal and interest is paid ratably through monthly payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options available to the Plan. Participants may change their allocation percentages at any time.

Payment of Benefits

Employees are eligible for retirement benefits upon reaching age 65 and are also eligible for benefits due to death or disability. Participants or their beneficiaries may elect a single lump sum payment of their entire vested account balance, or a portion of their vested account balance. Withdrawals after the attainment of age 59 ½ can be made without penalty.

If a participant terminates employment for any reason and at any age (including retirement), and the value of the participant's vested benefit does not exceed \$1,000, including any rollover contributions, then a distribution will automatically be paid to the participant. Any distribution under this provision will be paid in a lump-sum distribution within a year after the participant terminates employment.

Forfeited Accounts

Nonvested accounts of terminated employees are used to offset plan expenses or reduce the employer's contributions. Forfeited nonvested accounts totaled \$3,083 at December 31, 2024 and \$6 at December 31, 2023. During 2024, forfeitures of \$2,749 were utilized to offset plan expenses and \$3,083 to reduce the employer's contribution receivable.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles and the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they

were to initiate permitted transactions under the terms of the Plan. At December 31, 2024 and 2023, the Plan held no contracts that are considered fully benefit-responsive.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Reclassifications

Certain reclassifications have been made to the December 31, 2023 information to conform to the 2024 presentation.

Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

(3) INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

American Trust Company held the Plan's investment assets as of December 31, 2023 and executed investment transactions through July 2024. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023, and net appreciation (depreciation)

in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's Custodian.

Principal Trust Company held the Plan's investment assets as of December 31, 2024 and executed investment transactions during the year ended December 31, 2024 starting in July. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's Custodian.

(4) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) quoted prices for similar assets or liabilities in active markets, b) quoted prices for identical or similar assets or liabilities in inactive markets, c) inputs other than quoted prices that are observable for the asset or liability, d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts - Collective investment trusts (CIT) invest in a collective trust fund as well as a variety of separate accounts and mutual funds. The assets of the CITs consist of exchange traded securities whose net asset value ("NAV") values are aggregated and combined with stated fees through these procedures to arrive at the Fair Market Value. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments in Collective Investment Trusts are maintained by entities who files a Form 5500 as a direct filing entity. As a result, the Plan has not disclosed the significant investment strategies.

(5) RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsors provide to the Plan certain accounting and administrative services for which no fees are charged. Additionally, the sponsors paid certain consulting and advisory fees on-behalf of the Plan.

As of December 31, 2023 and during the year ended December 31, 2024, American Trust Company was the custodian. Therefore, transactions with American Trust Company qualify as party-in-interest transactions. These expenses are recorded as administrative expenses on the statement of changes in net assets available for benefits.

As of December 31, 2024 and during the year then ended, Principal Trust Company is the custodian and M2B Retirement Consulting, LLC is the third-party administrator. Therefore, transactions with them qualify as party-in-interest transactions. These expenses are recorded as administrative expenses on the statement of changes in net assets available for benefits.

(6) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) TAX STATUS

The Plan is a volume submitter plan offered by CCH Incorporated. CCH Incorporated obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(8) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
