For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Mallard Creek Polymers, LLC Employees Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code covering substantially all employees of Mallard Creek Polymers, LLC ("the Company"), who have completed 1 consecutive month of service, except for employees covered by a collective bargaining agreement, leased employees, consultants, and interns. In order for participants to receive any discretionary profit-sharing contribution, employees must also be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100% of compensation, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. The Plan includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled at a 3% deferral rate, unless they affirmatively elect not to participate in the Plan. The Plan also includes an auto-increase provision whereby deferral percentages increase by 1% on the first day of each plan year to a maximum of 6% for those employees automatically enrolled. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company provides matching contributions of 60% of an employee's deferral up to 6% of eligible compensation. The Company also provides a safe harbor non-elective contribution of 3% of eligible compensation to all eligible employees. The Company may also make discretionary profit-sharing contributions. No profit-sharing contributions were made for 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their contributions into selected mutual funds and collective investment trust funds as investment options as made available and determined by the Retirement Plan Committee.

Vesting

Participants are vested immediately in their elective deferral contribution, employer matching contribution, and safe harbor non-elective contribution portions of their account plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution are based on years of continuous service. A participant is 20 percent vested after two years of service and vests an additional 20 percent per year thereafter until they are 100 percent vested after six years.

Notes Receivable from Participants

Participants may borrow from their pre-tax deferral accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Participants may have 1 outstanding loan, which is secured by the balance in the participant's account and bears interest at the prime rate plus 2 percent. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or early retirement at age 55 with 10 years of vesting service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum or installment payments. In service withdrawals are allowed at age 59 ½. Hardship distributions from a participant's elective contribution accounts are permitted if certain criteria are met. Participant may also request a distribution from their rollover contribution account at any time. Involuntary distributions are made to terminated participants with balances of \$5,000 or less.

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Any forfeiture account balances may be used to reduce future Company contributions or to pay for Plan expenses. No forfeitures were utilized during 2024.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Loans amounting to \$8,012 were deemed to be in default during the year ended December 31, 2024.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Fees were offset by \$3,510 in the Administrative Fee Credit Account. In addition, certain investment-related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

3. Unaudited Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, Ascensus, LLC as agent of Ascensus Trust Company, has certified that the following data included in the accompanying financial statements is complete and accurate.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Fund: The Morley Stable Value Fund is composed primarily of a diversified portfolio of stable value investment contracts issued by life insurance companies, banks, and other financial institutions that is valued at the net asset value (NAV) of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Collective Investment Trust Funds: The remainder of the collective investment trust funds are valued at the net asset value (NAV) of units of the bank collective trusts. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in any un-vested employer contributions.

7. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Plan document sponsor by a letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the IRC. The Plan provisions are amended from time to time; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and therefore, the Plan and related trust continue to be tax-exempt.

8. Risks and Uncertainties

The Plan invests in various mutual funds and collective investment trust funds. These funds are exposed to various risks such as interest rate, market and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Related Party and Party-in-Interest Transactions
