### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Southwest Human Development, Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

**Description of the Plan**

The following description of the Southwest Human Development, Inc. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective January 1, 1999. The Plan has been amended and restated throughout the years to comply with tax legislation and most recently restated effective January 1, 2023. The Plan excludes leased employees, independent contractors, individuals employed as consultants, and reclassified employees. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for the oversight of the Plan. The Finance Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

**Eligibility**

Employees of Southwest Human Development, Inc. (the Company) are immediately eligible to participate in elective deferrals. Employees become eligible for an employer profit sharing contribution upon reaching 21 years of age, have been employed for one full calendar year, have completed at least 1,000 hours of service, and are employed on the last day of the calendar year.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Contributions are subject to certain Internal Revenue Service (IRS) limitations. Each year, participants may contribute up to 100% of pretax compensation, as defined in the Plan, not to exceed \$23,000 and \$22,500 annually in 2024 and 2023, respectively. Employees age 50 or older can contribute up to \$30,500 and \$30,000 during 2024 and 2023, respectively. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective January 1, 2021, automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant.

Effective January 1, 2023, the Plan transitioned from an Automatic Contribution Arrangement (ACA) to a Qualified Automatic Contribution Arrangement (QACA) or Safe Harbor Plan. Eligible participants were automatically enrolled with a deferral rate of 3% of eligible compensation. Beginning on September 1 of each year, the deferral rate will increase by 1% annually until the participant's deferral rate reaches 6%.

Prior to January 1, 2023, the company made contributions to the Plan at its sole discretion. These contributions were either qualified nonelective contributions or profit sharing contributions. Individuals employed on the last day of the Plan year and having worked 1,000 hours during the Plan year were eligible for company contributions.

**Contributions (Continued)**

Effective January 1, 2023, the Company's safe harbor matching contribution is 100% of the first 3% of the eligible compensation contributed to the Plan.

Profit sharing contributions, when applicable, are determined and allocated to participants solely at the discretion of the Company. For these purposes, all participants are divided into two groups: Head Start participants and non-Head Start participants.

Only participants whose compensation is paid entirely with federal Head Start funding will be considered Head Start participants, all others will be considered non-Head Start participants. Profit sharing contributions for the year ended December 31, 2024 was 1.1% for both Head Start employees and non-Head Start employees. Profit sharing contributions for the year ended December 31, 2023 was 1.5% for both Head Start employees and non-Head Start employees.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's discretionary contribution and an allocation of the Plan's earnings (losses) and administrative expenses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, or participant transactions, as defined by the Plan. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their pretax contributions including actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The participant's vesting in the Company's contribution is as follows: 0% for the first year of service, 20% for each year of service thereafter, and 100% vested after five years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Effective January 1, 2023, the participant's vesting in the Company's contributions will vest upon reaching a two-year cliff.

**Participant Loans**

The Plan does not permit participants to obtain loans from the Plan.

**Payment of Benefits**

A participant may receive the vested portion of the participant's account balance either in a lump-sum distribution or in equal installments upon termination, attainment of retirement age, death, or disability as defined by the Plan. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Amounts**

Forfeited balances of terminated participants' accounts may be used to pay plan expenses, offset Company contributions, or reallocate to participant's accounts.

There were \$-0- and \$1,157 of forfeited nonvested amounts in the Plan at December 31, 2024 and 2023, respectively. Forfeitures totaling \$26,406 and \$14,009 were used to reduce administrative expenses for the years ended December 31, 2024 and 2023, respectively. There were \$193,587 and \$110,902 of forfeitures used to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurement.

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Deferred Contributions**

Contributions received by the Plan for the subsequent Plan year.

**Administrative Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expense. In addition, certain Investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Delaware Charter Guarantee Trust Company dba Principal Trust Company, the custodian of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Funds* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 6 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the Plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letters. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the custodian as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.
