1. Plan Description

The following description of the NPR of America, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General: The Plan is a defined-contribution plan covering all eligible employees of NPR of America, Inc. (the "Company") The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective Date: January 1, 2009

Restatement Date: January 1, 2022

Anniversary Date: December 31

Valuation Date: Annually

Eligibility: All new employees, excluding union employees, non-resident aliens, and residents of Puerto Rico, become eligible to participate in the salary deferral benefit under the Plan, including discretionary employer matching contributions, when they have attained age 18 or older and completed three months of service.

Compensation: Compensation is defined as salary or wages, including any overtime, commissions, bonuses, or tips, but excluding compensation paid during the "determination period" while not a participant in the component of the Plan for which the definition applies, contributions by the employer to the Plan, post-severance compensation, leave cash outs, and payments from non-qualified unfunded deferred compensation plans.

Normal Retirement Date: The Plan defines the normal retirement date as the anniversary date coinciding with or next following the date of the participant's 65th birthday.

Early Retirement Date: The Plan defines the early retirement date as the anniversary date coinciding with or next following the date of the participant's 55th birthday

Disability Retirement Date: Disability retirement shall be upon total and permanent disability under the federal Social Security Act.

Retirement Benefits: At the applicable retirement date, each participant shall be entitled to receive the vested interest in their trust account.

Death Benefits: If a participant dies before their normal retirement date, their designated beneficiary vests 100% in the participant's account.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description - Continued

Notes Receivable from Participants: Participant loans are not permitted from the Plan.

Participant Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, not to exceed contribution limits established by the Internal Revenue Service ("IRS"). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1% of eligible compensation. Contributions are automatically invested in a designated balance fund until changed by the participant. Participants who are auto-enrolled will have an annual increase in their deferral rate of 1% up to a maximum of 6% of eligible compensation. A participant may make catch-up contributions of up to \$7,500 if the participant has attained age 50 by the end of the calendar year. The Plan currently offers various mutual funds as investment options for participants. Participants may modify salary deferral elections at any time, to be effective as of the first day of the following payroll period. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions: The Company may elect to make discretionary matching contributions to the Plan. For the year ended December 31, 2024, the employer matched 50% of deferrals up to 6% of compensation, totaling \$197,933.

Vesting: Participants are immediately 100% vested in all elective deferrals made to the Plan, and any investment earnings from these deferrals. Employer discretionary matching contributions shall vest on a graded schedule: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years.

Forfeitures: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$72,960 and \$52,498, respectively. Forfeitures will be used to reduce future employer contributions.

Investment Options: Upon enrollment in the Plan, a participant may direct up to 100% of employee contributions in any of the available investment funds offered. Participants may change their investment options at any time.

Guaranteed Interest Accounts: Investments in these funds are through a group annuity contract with participant principal and interest fully guaranteed by the entire general account assets of Standard Insurance Company. Daily interest is credited to the account. The credited interest rate may change based on the investment portfolio of the account.

Hardship Distributions: Hardship distributions are permitted from participants' pre-tax elective deferrals, Roth elective deferrals, and Employer non-elective contributions. In order to qualify for a hardship withdrawal, the participant must satisfy the legal requirements of a financial hardship as defined by Internal Revenue Code ("IRC") regulations.

Payment of Benefits: Upon retirement, termination of service, disability, or attainment of age 65, a participant or their beneficiaries may elect to receive a lump-sum amount or annuity payments equal to the value of the participant's vested interest in their account. For vested balances of \$5,000 or less, participant consent is not required for the distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan have been prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value as determined by The Standard Insurance Company, except for the fully benefit-responsive investment contract, which is reported at contract value. The fair values of the mutual fund investment accounts are reported using a unit value giving consideration to the income, cost, and sales comparison approaches of estimating property value. Purchases and sales of units are recorded on valuation dates, as are the earnings on mutual funds. Interest income is recorded on an accrual basis and is shown as an addition in the statement of changes in net assets available for benefits. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company, as provided by the Plan document. The expenses paid using the Plan's assets will generally be allocated among the accounts of participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balance or as an equal dollar amount based on the number of participants in the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Evaluation of Subsequent Events: The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

4. Fair Value Measurements (Unaudited)

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820-10, “*Fair Value Measurements and Disclosures*,” establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or 2 inputs are not available.

Level 1 Inputs - The values of mutual fund investment accounts are reported using a unit value based on quoted market prices in active markets for identical assets that the Plan has the ability to access at year-end.

No Level 2 or 3 inputs were available to the Plan at December 31, 2024 or 2023.

5. Investment Contract Fund (Unaudited)

As described in Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 962-325-50-3, “*Reporting on Fully Benefit-Responsive Investment Contracts*”, investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As required by FASB ASC 962-325-50-3, the statements of net assets available for benefits present the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value.

Standard Stable Asset A is a fully benefit-responsive investment contract with Standard Insurance Company. Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract is included in the financial statements at contract value, as reported to the Plan by the Standard Insurance Company. Contract value represents contributions made under the contract, plus interest and earnings on underlying investments, less participant withdrawals and administrative expenses. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

There are no reserves against contract value for credit risk of the contract issue or otherwise. The value of the investment contract and interest rate at December 31, 2024 and 2023, was \$74,964 at 3.04% and \$56,088 at 2.78%, respectively.

Certain events may limit the ability of the Plan to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Neither Standard Insurance nor the Plan may terminate the contract without 30 days advance written notice to the other party.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

7. Tax Status - Continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Parties-in-Interest

MMA Securities, LLC is an investment advisor to the Plan. MMA Securities, LLC is a service provider of the Plan; therefore, transactions with MMA Securities, LLC are party-in-interest transactions. Fees paid to MMA Securities, LLC by the Plan totaled \$16,467 for the year ended December 31, 2024.

StanCorp Financial Group is an administrator for the Plan. StanCorp Financial Group is a service provider of the Plan; therefore, transactions with StanCorp Financial Group are party-in-interest transactions. Fees paid to StanCorp Financial Group by the Plan totaled \$39,361 for the year ended December 31, 2024.

WellsColeman performed the audit for the year ended December 31, 2024. WellsColeman is a service provider of the Plan; therefore, transactions are party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


