## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Participants  
Metro 401(K) Plan

### **SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We have performed an audit of the financial statements of Metro 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Metro 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

### **OPINION**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Metro 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**1. Description of plan**

The following description of Metro 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution retirement plan covering all employees of WFM LLC, Franklin Country Day LTD, Metro Montessori LLC, BBCH LLC, Apple Montessori School, Inc., Franklin Montessori LTD, GOH LLC, Zava Zone LLC, Zava Zone Sterling LLC, Leadership Services Inc., and LOJJ Montessori School LLC (the “Company” or “Plan Sponsor”) who elect to participate after completing one month of service and are at least 21 years of age. Plan entry occurs on the first day of each calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated, effective January 1, 2022, to formally adopt the provisions of the CARES Act and SECURE Act. The Plan was restated again, effective January 1, 2023, to permit Roth elective deferrals.

Contributions - Each year, participants may contribute to the Plan up to 90% of pretax annual compensation, as defined, up to the maximum amount permitted under the Internal Revenue Code (\$23,000 for 2024). In addition, participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers fifty mutual funds as investment options for participants. The Plan permits the plan sponsor to make discretionary matching contributions if it chooses to do so. To be eligible for the discretionary matching contribution, participants must be employed with the Company on the last day of the plan year. The employer made no discretionary matching contribution for the year ended December 31, 2024.

Participant accounts - Each participant’s account is credited with (a) contributions and (b) Plan earnings, and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants vest immediately in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching contributions, if any, plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

Forfeited accounts - Forfeitures, arising from excess discretionary matching contributions, can be applied to offset administrative expenses of the Plan, which may otherwise be paid by the Company, or used to reduce the Company’s future discretionary matching contributions. During 2024, forfeitures totaled \$217 (\$314 for 2023). Investment earnings on forfeited funds during 2024 aggregated \$10 (none for 2023). The balance in the non-vested forfeited account at December 31, 2024 was \$541 (\$314 at December 31, 2023).

**1. Description of plan (continued)**

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of: (a) \$50,000 or (b) 50% of their vested account balance. Only one loan may be outstanding at a time and participants must demonstrate a hardship event. The loans are to be repaid over a period not to exceed five years and will incur interest at the prime rate plus 2%. Interest rates on participant notes were 10.5% at December 31, 2024 (no loans were outstanding at December 31, 2023). Principal and interest are to be paid ratably through bi-weekly or monthly payroll deductions. The notes are secured by the balance in the participant's account.

Payment of benefits - Participants are entitled to 100% of their vested account balance at age 59½, or earlier in the event of death or disability. Benefit payments are generally made in a single lump-sum payment. A participant may request to receive their benefits in the form of systematic installment payments to the extent necessary to satisfy required minimum distribution rules or a rollover to another qualified retirement plan or individual retirement account (IRA). Participants must also be 100% vested in the source from which the withdrawal is taken. Hardship distributions are also permitted under specific circumstances, as outlined in the Plan document, and may only be taken from employee deferral contributions.

Termination - Generally a participant may receive his or her vested account balance in a single lump sum at any time such participant ceases to be an employee.

**2. Accounting policies**

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities (including realized gains or losses) are recorded on the trade-date. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recognized when paid.

Administrative expenses - Certain expenses incurred in connection with the general administration of the Plan are paid by the Company. (See Note 5).

**2. Accounting Policies (continued)**

Secure Act 2.0 - In December 2022, Congress passed the Consolidated Appropriations Act of 2023 which contains over 90 new retirement provisions with varying effective dates through 2027. Since the Secure Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan documents accordingly. Certain provisions became effective in 2024 and additional provisions will become effective thereafter. There is no material impact to the Plan's 2024 financial statements.

Subsequent events - The Plan has evaluated subsequent events through October 9, 2025, the date these financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024 have been incorporated into these statements.

**3. Investments (unaudited)**

At December 31, 2024 and 2023, the Plan's investments were held by the custodians. The Plan's investments consist substantially of mutual funds at December 31, 2024 and 2023. Management has obtained certifications from Reliance Trust Company as of December 31, 2024 and 2023 stating that the certified investment information, as described in this note and Note 4 to the financial statements, is complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$75,303 during the year ended December 31, 2024 and were certified by the custodians. The Plan has a minor investment in a stable value fund which is a low risk, capital preserving investment valued daily using NAV, which mirrors the FMV.

**4. Fair value measurements (unaudited)**

Authoritative accounting guidance sets forth a framework for measuring fair value. That framework provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan measures fair value using Level 1 inputs whenever possible because they generally provide the most reliable evidence of fair value. When Level 1 inputs are unavailable the Plan uses Level 2 inputs, and Level 3 inputs are only used when Level 1 or Level 2 inputs are unavailable.

Following is a description of the valuation methodologies used by the Plan to measure fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 fair value measurements* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 fair value measurements* - Inputs other than the quoted prices in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates, and similar data. Level 2 fair value measurements were not used by the Plan in 2024 or 2023.

*Level 3 fair value measurements* - The fair value is based on at least one significant unobservable input for the asset. Level 3 fair value measurements were not used by the Plan in 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. *Related party transactions***

The Company pays for a portion of the Plan's administrative expenses. The Company absorbed \$21,963 of administrative fees on behalf of the Plan in 2024.

The Plan's investments substantially consist of mutual funds offered by Reliance Trust Company, the Plan's Custodian. Under ERISA, such transactions qualify as party-in-interest transactions.

**6. *Risks and uncertainties***

The Plan provides for various pooled separate account investment options. Such investments are exposed to interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks will occur in the near term and could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist of investments in mutual funds. The Plan has offered Plan participants investment options in various investment vehicles as a means of reducing the effects of such risks.

**7. *Plan terminations***

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**8. *Tax status***

The Plan is operating under an adoption agreement of a non-standardized prototype plan structured by its third-party administrator. The Internal Revenue Service has reviewed the terms of the prototype plan and has indicated by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to its terms and conditions; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**8. *Tax status (continued)***

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021, generally three years after the tax returns have been filed.
