## Independent Auditor's Report

### **Opinion**

We have audited the financial statements of McLean Contracting Company Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023 and the changes in net assets available for benefits for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter**

As explained in Note 4, the financial statements include investments valued at approximately \$35,942,000 (91 percent of net assets) at December 31, 2024 and \$26,082,000 (91 percent of net assets) at December 31, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by valuation reports prepared by independent appraisals, management's projections, and guideline market data. Our opinion is not modified with respect to this matter.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

### Note 1 - Plan Description

The following description of McLean Contracting Company Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

McLean Contracting Company (the "Employer") established the Plan effective July 18, 1973. As of January 1, 2011, the Plan was amended and operates, in relevant part, as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan has an ESOP committee composed of three or more individuals appointed by the Employer's board of directors. The ESOP committee members serve as the Plan's administrators and make investing decisions for the Plan.

#### **Administration**

The Plan's assets, which consist primarily of McLean Contracting Company stock, are held by the trustee of the Plan.

The ESOP committee utilizes a third-party administrator that processes and maintains the records of participant accounts and is responsible for the day-to-day operations and oversight of the Plan.

Certain administrative expenses of the Plan were paid by the Employer during the year ended December 31, 2024. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan in exchange for these services.

#### **Eligibility**

Employees are eligible to participate in the Plan on the day following their hire date. Participants who do not have at least 1,000 hours of service during the plan year or are not employed on the last working day of a plan year generally are not eligible for an allocation of the employer contributions for that year. Participants who do not meet these criteria due to retirement, disability, or death are still eligible to receive contributions for such year.

#### **Contributions**

The Employer makes contributions to the accounts of non-highly compensated participants whose employment is subject to the Davis-Bacon Act. The Davis-Bacon contribution is allocated in an amount necessary to satisfy the requirement of the Davis-Bacon Act or any similar wage law. Additionally, the Employer may make annual discretionary contributions to the Plan, as approved by the Employer's board of directors. Contributions are allocated to eligible participants' accounts based upon the participants' eligible compensation as a percentage of total compensation, not to exceed Internal Revenue Service (IRS) limitations.

The Employer provides a safe harbor matching contribution that will be remitted to McLean Contracting Company Employee Stock Ownership Plan for all eligible participants. The contribution will be based on the participants' elective deferral contributions to McLean Contracting Company 401(k) Retirement Plan (the "401(k) Plan") and will be a 100 percent match of deferrals, not exceeding 3 percent of total compensation, and 50 percent on deferrals that exceed 3 percent of total compensation but do not exceed 5 percent in total compensation.

All contributions and investments for the Plan are non-participant directed. The employer contributions that are remitted to the Plan subsequent to the plan year end are included as contributions receivable in the accompanying statement of net assets available for benefits.

#### *Vesting*

Vesting in the Employer's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Employer at 20 percent after two years of service and another 20 percent per year thereafter until they become fully vested after six years of service.

Participants are immediately 100 percent vested in all safe harbor matching contributions remitted to the Plan, and participants are 100 percent vested in contributions made to Davis-Bacon accounts.

#### *Forfeitures*

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total compensation for all eligible participants. There were no unallocated forfeitures as of December 31, 2024 and 2023.

#### *Voting Rights*

Each participant is entitled to exercise voting rights attributable to the employer shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The only matters that require pass-through of voting rights are matters with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sales of substantially all assets of a trade or business, or such similar transaction as the secretary of the Treasury may prescribe in regulations. The ESOP committee will direct the trustee to vote the shares of company stock with respect to company stock where no instructions were received from the participant.

#### *Put Option*

Under federal income tax regulations, the company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Employer buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Employer can pay for the purchase with interest in a single lump sum or through installments.

#### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with allocations of the Employer's contributions, forfeitures of terminated participants' nonvested accounts, and plan earnings and charged with an allocation of administrative expenses. Except for the allocation of terminated recycled shares to active participants, which is allocated based on the total cash balance of a participant's account, allocations are based on a participant's eligible compensation relative to total eligible compensation. As mentioned above, the safe harbor match is allocated based on a percentage of total compensation.

#### *Diversification*

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investments in the Employer's common stock into investments that are more diversified. Participants who are at least age 55 with 10 years of participation in the Plan may elect to diversify a portion of their accounts. Inactive participants who elect to diversify can receive a cash distribution or elect to roll over their accounts into another qualified plan, while active participants who elect to diversify must transfer a portion of their accounts to McLean Contracting Company 401(k) Retirement Plan. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the 6th year, the participant may elect to take a distribution of a cumulative amount up to 50 percent of his or her remaining company stock account.

#### ***Benefit Payments***

Benefit payments are available to participants upon retirement age (age 65), termination of employment, death, attainment of early retirement (age 55 with 10 years of service), or disability. Participants are entitled to a benefit equal to the vested portion of their accounts, which will be distributed in the form of a lump-sum payment of up to \$25,000. If the participant's vested balance exceeds \$25,000, it will be paid in five annual installments, which will be extended by 1 year for each \$195,000 (or fraction thereof) the account balance exceeds \$985,000, not to exceed 5 additional years. There was approximately \$2,396,000 allocated to participants who had elected to withdraw from the Plan but had not yet been paid as of plan year ended December 31, 2024.

#### ***Plan Termination***

The Employer reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to the participant or his or her beneficiary at the time prescribed by the plan terms and the Internal Revenue Code. Upon termination of the Plan, the trustee shall pay all liabilities and expenses of the trust fund.

Upon termination of the Plan, participants become 100 percent vested in their account balances.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Wilmington Trust Company (formerly known as Manufacturers & Traders Trust Company). Wilmington Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Additionally, certain plan assets are in investments in the Employer's stock. The Employer is the Plan's sponsor; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, including the valuation of employer common stock. Application of these assumptions requires the exercise of judgment as to future uncertainties, and, as a result, actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. The investment in employer common stock is also exposed to various risks. Due to the level of risk associated with the investment in investment securities and employer common stock, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### *Mutual Funds*

Mutual funds are valued at quoted prices reported in active markets.

#### Company Stock

The Plan measures company stock at fair value on a recurring basis. The fair value of company stock is based primarily on Level 3 inputs. Fair value is determined by annual independent appraisals. The appraisal was based upon a combined income and market approach, including the discounted cash flow method and guideline public company method. The unobservable inputs for the discounted cash flow method are earnings, capital growth, and the discount for lack of marketability. The unobservable input for the guideline public company method was earnings growth.

#### Money Market Funds

The money market funds are valued at quoted prices reported in active markets.
