Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified

investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan description:

General

The DePasquale & Affiliates 401(k) Plan (the "Plan") is a defined contribution plan covering all full-time employees of DePasquale Salon Systems, Inc. and its affiliates, Artistic Academy, Inc., Ecrú, Inc., DePasquale Colour & Design, Inc., and Lakme, Inc. (collectively referred to as the "Company") who have completed one year of service (minimum 1,000 hours) and are age 21 or older. The Plan is subject to the provisions of ERISA. The Plan Administrator is responsible for the oversight of the Plan, determines the appropriateness of investment offerings and monitors investment performance. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participant contributions cannot exceed the maximum amount allowable by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Company contributes 100% of the first 3% of eligible compensation and 50% of remaining participant contributions that do not exceed 5% of eligible compensation. Under the terms of the Plan, the Company may contribute a discretionary amount of its annual net earnings as determined by its Board of Directors. In 2024, there were no discretionary profit-sharing contributions.

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Each participant's interest in the Company matching contributions and the allocated portion of Company discretionary profit sharing contributions vests 20% after one year of service with the Company and 20% for each full year of service thereafter until a participant is fully vested after five full years of service. Thereafter, a participant's portion of such amounts is immediately 100% vested.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear interest at the prime rate as printed in the Wall Street Journal at the inception of the loan and provide for periodic repayment over a period of 1 to 5 years, based on

the type of loan. Principal and interest is paid ratably through monthly payroll deductions. The entire unpaid principal balance of the loan is due upon the participant's termination of employment with the Company. The interest rate on loans outstanding at December 31, 2024 ranged from 3.25% to 8.50%.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to 100% of the value in his or her account, or partial withdrawals. For termination of service for other reasons, a participant would receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,628 and \$3,278, respectively. These amounts are available to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan.

2. Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or to transfer a liability in an orderly transaction between market participants at the measurement date. The investments in registered investment companies relate to shares in mutual funds. The share price is based on the market value of the mutual funds' investments at the end of each day divided by the number of outstanding shares. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment valuation and income recognition (continued)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses are paid by the Company. These expenses have been excluded from these financial statements. Administrative fees include investment related expenses, third party administration fees and loan administration fees.

Subsequent events

The Plan's management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

3. Fair value measurements:

Accounting Standards Codification 820 – *Fair Value Measurement* (“ASC 820”) defines fair value and establishes a framework for measuring fair value under generally accepted accounting principles. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Unaudited information certified by the plan trustee

The information certified includes total investments and notes receivable of \$23,183,627 and \$19,483,913 at December 31, 2024 and 2023, respectively, and the related net investment gain of

5. Group Annuity Contract with The Lincoln National Life Insurance Company:

The Plan is invested in a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company ("Lincoln") totaling \$2,159,709 and \$1,229,370 at December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a 1% minimum annual guaranteed interest rate. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) charges billed to the Plan not being paid within 30 days, (2) an uncured violation of the Plan's investment guidelines, (3) at any time following the end of the third Contract Year, the Contract Owner Account is less than \$15,000, (4) any time following the end of the third Contract Year, there is no deposit activity for a 24 consecutive month period and the Contract Owner Account is less than \$50,000, (5) the Plan fails to furnish requested information or other documentation, (6) a material misrepresentation, (7) if the Contract is discontinued from being offered to the public, or (8) if the plan sponsor terminates the recordkeeping agreement with Lincoln or one of its affiliates.

6. Party-in-interest transactions:

Included in notes receivable - participants are loans to the relatives of the Company's principal stockholder aggregating \$47,135 and \$48,760 at December 31, 2024 and 2023. This individual is an employee of the Company and this is a loan from his respective Plan balance.

7. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Income tax status:

The Internal Revenue Service has determined and informed the Company by letter dated May 14, 1997, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and uncertainties:

The plan invests in various mutual funds which are exposed to various risks such as stock market fluctuations, interest rates, economic conditions and world affairs. Due to the level of risk associated with certain investment securities, it is reasonable that changes in the values of investment securities will occur in the near term.

Significant market disruptions, such as those caused by pandemics, natural disasters or environmental disasters, war, instability in the banking and financial services sectors, including bank failures, or other events, can adversely affect local and global markets and normal market operations. Any such disruptions could have an adverse impact on both the Plan's investments and the Plan's sponsor.
