Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Wang Globalnet 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Wang Globalnet 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Description of the Plan

The following description of the Wang Globalnet 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – Wang Globalnet (the “Company” or “Plan Sponsor”) established the Plan effective September 1, 2009. The Plan is a defined contribution plan covering all employees of the Company and its subsidiaries who are age 21 or older. The Board of Directors of the Company is responsible for administration and management of the Plan. All investments of the Plan are participant-directed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute up to 100% of participant’s annual compensation, as defined by the Plan not to exceed certain statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Plan participants direct the investment of their contributions and the employer matching contribution into the various investment options offered by the Plan. The Company makes a matching contribution equal to 100% of salary deferrals up to 3% of compensation.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. 1,000 hours of service is required to constitute a vesting service year. Any employer contributions are subject to the following graded vesting schedule:

Notes Receivable from Participants – Participants may borrow from their accounts up to a maximum that is equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. Participants must fully repay through payroll deductions within 5 years unless the loan is used for the purchase of a principal residence. If the loan is used for the purchase of a principal residence, the Administrator may permit a longer repayment term. The loans are secured by the balance in the participant’s account and bear a reasonable interest. For the plan year 2024, the interest was charged ranging 3.50% to 5.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

As of December 31, 2024 and 2023, outstanding participant loans were \$119,136 and \$101,394, respectively.

Distribution of Benefits - On termination of service due to death or disability, all amounts credited to participant's account become fully vested and lump sum distribution will be made to the beneficiary. Hardship and in-service distributions are also permitted provided certain eligibility requirements are met. The Plan allows for a mandatory cash-out of terminated participant balances of \$1,000 or less.

Forfeited Accounts - Forfeitures will be used first to pay any administrative expenses. Any remaining forfeitures will be used to reduce any employer contribution. During 2024, no amount was used to reduce employer matching contributions.

Note 2 – Summary of Significant Accounting Policies

The accounting and reporting policies of the Plan conform to accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting - The financial statements of the plan are prepared on the accrual basis of accounting.

Investment Valuation - Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. Quoted market prices are used to value investments and shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Investment Valuation and Income Recognition (Continued) - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Guaranteed Interest Accounts - The Plan participates in a contract with American United Life Insurance Company ("AUL") whereby the assets of the Plan are part of the general assets of the AUL. This contract is identified and accounted for as a guaranteed interest account. The guaranteed accounts guarantee the return of capital, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guaranteed period.

Payment of Benefits - The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan, but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Plan Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Termination of the Plan - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Recently Issued Accounting Standard - In August 2018, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2018-13, Fair Value Measurement (Topic 820) Disclosure Framework Changes to the Disclosure Requirements for Fair Value Measurement. ASU 2018-13 improved and simplifies the disclosure requirements for fair value measurements. Plan management adopted ASU 2018-13 effective January 1, 2020; its adoption did not have a material impact on the Plan's financial statements.

Note 3 – Unaudited Information - Certified Investments and Notes Receivable from Participants

Substantially all information pertaining to the Plan's investments included in the financial statements, including the associated investment income (loss) were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by American United Life Insurance Company. These information have not been audited by the independent accountants.

Note 4 – Investments

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information certified by the custodian of the Plan regarding the current value of assets held at December 31, 2024 and 2023 and transactions entered into during the respective years were used in the preparation of the accompanying financial statements.

During 2024, the Plan's investment in fixed option, separate pooled, and general accounts (including gains and losses on investment bought, sold, and held at year end) appreciated in value by \$462,935.

Note 5 – Fair Value Measurements

ASC 820-10 establishes a framework for measuring fair value as it related to financial assets and liabilities and to nonfinancial assets and liabilities measured at fair value on a recurring basis. Such framework provides fair value three-level valuation hierarchy based on upon observable and unobservable inputs with preference given to observable inputs.

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets.

Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices in markets that are not active, quoted prices for similar assets, or other inputs that are observable, either directly or indirectly, for substantially the full term of the asset.

Level 3 – Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following description of the valuation method and assumption used by the Plan to estimate the fair values of investments applies to investments held directly by the Plan.

Mutual funds - This category consists of publicly traded funds of registered investment companies. The net asset value of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

Pooled separate accounts - The fair values of participation units held in the pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices (Level 2 inputs). It seeks to maintain a return similar to a short term bond fund with a risk profile similar to a money market fund and is designed for use as a constant value investment option.

Stable value accounts - The contract values of participation units held in the stable value accounts are based on the principal invested plus interest earned. It is in the trustee's opinion that the contract value consists entirely of Level 2 inputs and is an appropriate determination of fair value of the stable value accounts.

Investments at contract value - The Plan has entered into benefit-responsive guaranteed investment contract with the custodian. The custodian maintain the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the custodian. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reset on an annual basis. The Plan administrator does not believe there are any events or circumstances under which the custodian would terminate its guarantee to this contract nor are there any events which would limit the ability to transact at contract value with participants.

Investment options are selected by the Plan Sponsor and are participant-directed. The participants have several investments they can choose from. See the attached Schedule of Assets (Held at End of Year) for a detailed listing of investments.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in fair value of the investments.

Note 6 – Income Tax Status

The Plan document is a volume submitter that the Company adopted with specific provisions customized to meet the needs of the sponsor and the participants. The volume submitter has received a favorable determination letter from the Internal Revenue Service that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Party-In-Interest Transactions

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain Plan investments in fixed option accounts are managed by American United Life Insurance Company, the custodian of the Plan.

Note 8 – Party-In-Interest Transactions (Continued)

Purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants held by the Plan are considered party-in-interest transactions.

Note 9 – Subsequent Events

Plan management has evaluated subsequent events for recognition and disclosure through October 5, 2025, which is the date the financial statements were available to be issued.
