### Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis of Matter – Investment Valuation**

As discussed in Note 4 to the financial statements, the financial statements include United Vending & Food Service common stock valued at \$1,400,400 and \$583,200 (100% of assets), at December 31, 2024 and 2023, respectively, whose fair value has been estimated using an independent appraisal, and in the absence of readily determinable fair values, with the assistance of management. Because of the inherent uncertainty of the valuation, the estimated values may differ significantly from the values that would have been used had a market value for the investments existed, and the differences could be material. Our opinion is not modified with respect to this matter.

### **Supplementary Information Required by ERISA**

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplementary information as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying information is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

---

The following brief description of the United Vending & Food Service Employee Stock Ownership Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan was established effective January 1, 2022, to enable eligible employees to benefit from common stock ownership interest in Heroes Inc. d/b/a United Vending & Food Service (the Company). The Plan commenced operations in 2023 and had no activity in 2022. The Plan is intended to be an employee stock ownership plan (ESOP) within the meaning of Section 4975(e)(7) of the Internal Revenue Code of 1986, as amended, and is intended to invest in “qualifying employer securities,” as defined in Code Section 409(1), in accordance with Treasury Regulation Sections 54.4975-11(a)(2) and (11)(b). The Plan was established to provide retirement benefits for the employees of the Company.

In April 2023, the Plan acquired 100% of the Company’s common stock using proceeds of a loan issued by the Company. The Plan holds the stock in a trust established under the Plan (see Note 6).

#### ***Eligibility***

Employees of the Company are eligible to participate in the Plan after attaining age 18 and completing 1,000 hours of service. Eligible employees participating in the Plan on the later of January 1 or the date of hire of the Plan year which requirements are met. Participants who do not have at least 1,000 hours of service during the Plan year and those who are not employed on the last day of the Plan year are not eligible for an allocation of the Company common stock for such year. Participants who are not employed on the last day of the Plan year due to retirement, death or disability are still eligible for an allocation of Company stock for such year.

#### ***Payment of Benefits***

Distributions from the Plan will be made when a participant retires, dies, becomes disabled, or otherwise terminates employment with the Company, as defined by the Plan. Distributions are in lump sums or installments made in cash. Distributions under \$1,000 will be paid out to the participant in a lump sum cash payment. Distributions between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024), are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Benefits are recorded when paid.

### ***Voting Rights***

Generally, the ESOP Committee (body appointed by the Company to manage operations of and administration of the Plan) will direct the First International Bank & Trust (Trustee) how to vote the Plan's shares of the Company's common stock. For certain extraordinary matters, participants will be able to direct the Trustee how to vote their allocated Company common stock. These matters include corporate mergers, consolidations, re-capitalization, re-classification, liquidation or dissolution.

### ***Participant Accounts and Forfeitures***

Each participant's account is credited with a) an allocation of cash or shares of the Company's common stock released by the Trustee from the unallocated account, b) forfeiture of terminated participants' non-vested accounts and c) Plan earnings or losses. Only those participants who are eligible employees of the Company as of the last day of the Plan year and have at least 1,000 hours of service during the Plan year will receive an allocation of cash or shares of the Company's common stock released or forfeited. Allocations of the Company's common stock and forfeitures are based on a participant's eligible compensation, relative to total eligible compensation. The Plan re-allocated 18.7863 shares in the amount of \$766 to participants during the year ended December 31, 2024. No forfeitures were re-allocated to participants during the year ended December 31, 2023. Plan earnings or losses on investments are allocated on the basis of actual results of the Company stock and other Plan investments. Investments are maintained in individual member accounts managed by Principal Trust Company (Principal).

### ***Vesting***

A participant's interest in allocated Company common stock is vested based on years of completed service. A participant is 20% vested after one year of credited service and vesting increases 20% per year until a participant is 100% vested after 5 years of credited service.

### ***Put Option***

Under Federal income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradeable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the estimated fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash for their Company common stock.

The Plan allows for the re-shuffling of accounts of participants actively employed by the Company and the accounts of participants who have terminated employment, died, become disabled, or received an account pursuant to the approval of a qualified domestic relations order. Reshuffling instructs the Trustee to purchase all or a portion of the shares of employer stock held by non-employed participants using liquid assets held in the accounts of employed participants.

### ***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversified accounts held by participants are transferred to the Company's 401(k) Plan then the participant can direct how those amounts are invested under the Company's 401(k) Plan. There were no amounts diversified out of the Plan during the years ended December 31, 2024 and 2023.

## **2. Summary of Significant Accounting Policies**

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments, with the exception of the Company's common stock, are reported at fair value. The Company's common stock is valued at estimated fair value based on an independent valuation. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 11, 2025. See Note 8 for a description of a subsequent event.

## 3. Administration of Plan Assets

---

The Plan's assets, which consist primarily of the Company's common stock, are held by the Trustee of the Plan.

Company contributions are held and managed by the ESOP Committee and the Trustee, which invests cash received, interest and dividend income and makes distributions to participants. The ESOP Committee and the Trustee also administer the payment of interest and principal on loans, which is reimbursed to the Trustee through contributions and dividends on the Company's common stock as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expense for the ESOP Committee and the Trustee fees are paid by the Company.

### 5. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures* provide a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quotes prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*United Vending & Food Service Common Stock:* Valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. The appraiser considered historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Note Payable

Note payable consists of an installment note payable to the Company, due in equal annual installments (adjustment for any pre-payments made) of \$316,561, including interest at 4.02%, through December 2057. This note is collateralized by certain unallocated shares of the Company common stock held by the Plan. There was \$5,728,084 and \$5,810,426, outstanding against this note payable as of December 31, 2024 and 2023, respectively.

### 7. Employer Contributions

---

The Company is obligated to make contributions in cash to the Plan, which when aggregated with the Plan's earnings, equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. The Company made a contribution of \$316,561 related to the scheduled payment of principal and interest for the years ended December 31, 2024 and 2023 (see Note 6). Additionally, the Company made discretionary cash contributions to the Plan of \$6,344 and \$500,000, for the years ended December 31, 2024 and 2023, respectively.

The Company may also make contributions to the Plan through distributions of earnings. The Company did not make contributions to the Plan in the form of distributions of earnings for the years ended December 31, 2024 and 2023.

### 8. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from Federal income taxations under Section 501(a) of the Internal Revenue Code. The Plan's determination letter is dated May 27, 2025.

The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. No prior period income tax exemptions exist.

### 9. Plan Termination

---

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the Plan will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code. Upon termination of the Plan, the ESOP Committee shall direct the Trustee to pay all liabilities and expense of the trust fund and sell shares of the Company's common stock held in the loan suspense accounts to the extent it determines such sale is necessary in order to repay the loan.

### 10. Related Party Transactions

---

Certain Plan investments are the Company's common stock held under the ESOP fund which is managed by the United Vending & Food Service ESOP Trust. These transactions with the Company qualify as party-in-interest.
