**NOTE 1 - PLAN DESCRIPTION AND BASIS OF PRESENTATION**

*General*

The following description of the Mobridge Regional Hospital's Safe-Harbor 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan initially adopted October 1, 1980, which includes employees of Mobridge Regional Hospital. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, (ERISA).

The Plan is intended to be a qualified defined contribution plan which satisfies the requirements of Section 401(k) of the Code. Under the Code, participants are not liable for federal income taxes on employee contributions, company contributions, or plan earnings until such time as they are partially or completely withdrawn from the Plan.

*Eligibility and Entry Date*

Employees are eligible to receive employer matching contributions in the Plan if they have completed one year of service and have attained the age of 18. A year of service is defined as a 12 consecutive month period during which the employee completes at least 1,000 hours of service.

Eligible employees may enter the Plan immediately for employee deferrals upon hire.

*Contributions*

Participants may contribute up one hundred percent (100%) of their eligible compensation, up to applicable 401(k) limitations, for the Plan year. The Company contributes three percent (3%) of employee's eligible compensation if no deferral is made or matches up to four percent (4%) of the employee's eligible compensation if a four percent (4%) deferral is made. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Contributions are subject to certain IRS limitations.

Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Vesting*

Participants are immediately one hundred percent (100%) vested in all contributions plus actual earnings thereon.

*Amounts allocated to persons who have withdrawn but have not been paid*

Amounts allocated to accounts of persons who, at financial statement date, have elected to withdraw from the Plan but have not been paid was \$0 and \$0 on December 31, 2024 and 2023, respectively.

*Benefits*

Upon termination of employment or service due to death, disability, or retirement, the participant will receive a lump sum amount equal to the value of the participant's account balance. The distribution is made in the form of a cash distribution.

Employees who terminate employment prior to the date they are eligible to retire, die, or become disabled, have the option of requesting early payment of their vested account balance.

*Amendment and Termination*

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Plan may determine.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and the matching contribution of the Moberidge Regional Hospital and an allocation of the Plan earnings, and charged with applicable administrative expenses. Plan earnings are allocated based on participant account balances.

*Investments*

Upon enrollment in the Plan, participants direct the investments of their contributions and Company contributions into various investment options offered by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the financial statement and accompanying notes. Actual results may differ from those estimates.

*Investment valuation and income recognition*

Investments are reported at fair value, except for the investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

*Contributions*

Contributions from employees are recorded as they are withheld from the participant's wages.

*Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

*Subsequent events*

The Plan has evaluated subsequent events as of the date of the report.

**NOTE 3 - FEDERAL INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - ADMINISTRATION OF PLAN ASSETS**

Participants must direct their contributions in a variety of investment choices as more fully described in the Plan's literature.

Certain administrative functions are performed by officers or employees of the Hospital. No such officer or employee receives compensation from the Plan. Participants may be charged additional fees for certain services requested, such as, mailing of paper statements.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2007, the plan entered into an investment contract with Mutual of America Life Insurance Company (Mutual of America). Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

The concept of benefit responsive does not apply to Mutual of America's General Account. This concept generally applies to guaranteed investment contracts (GIC) whereby the employer enters into the contract with a set amount of money and the interest rate is guaranteed for a set period of time. The employer agrees to not withdraw the funds early; however, if funds are needed to pay retirement claims, they can be withdrawn from the GIC without penalty (benefit responsive).

In the case of defined contribution plans, because the funds are allocated to the individual plan participants, the funds are always available to pay benefits, depending on the particular vesting schedule applicable to the plan. As such, the employer does not control those assets and the need for the plan to be "benefit responsive" is not relevant.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$1,791,719 and \$1,738,143, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974, as amended. The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

**NOTE 8 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

For the years ended December 31, 2024 and 2023 plan participants paid fees to Mutual of America Life Insurance Company in the amount of \$3,210 and \$2,431, respectively. Mutual of America Life Insurance Company is the trustee of the Plan. These transactions are covered by a permanent exemption under Section 408 of the Employee Retirement Income Security Act of 1974, and therefore, are not a violation of the prohibited transactions regulations promulgated by Act Section 406.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 - ERISA BOND REQUIREMENT**

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets, and is required to be at least equal to the lesser of ten percent (10%) of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained bond coverage in the amount of \$500,000 and \$500,000, respectively.

**NOTE 11 - SUMMARY OF SIGNIFICANT PLAN AMENDMENTS**

As of September 16, 2004, the Plan was amended to include maximum contribution limits, new catch up contributions for participants over 50, higher compensation limits and discretionary sponsor matching contributions. The Plan was amended March 16, 2005 to direct payment of mandatory distributions greater than \$1,000 that have not been specified by the participant to a direct rollover to an individual retirement plan designated by the Administrator. The Plan was amended effective January 1, 2007 to include employee contributions and change the Plan to a Safe-Harbor 401(k) Plan. The Plan was amended January 1, 2018 to allow for Roth deferrals and automatic enrollments. There was no impact on assets available for plan benefits resulting from these amendments.

**NOTE 13 - NONEXEMPT PROHIBITED TRANSACTIONS**

As reported on Form 5500, Schedule H, Line 4d - Schedule of Nonexempt Prohibited Transactions, employer matching contributions were made calculated using earnings in excess of what is allowed by the IRS, thus constituting nonexempt prohibited transactions between the Plan and the Company during the 2023 and 2024 Plan year. Inappropriate employer contributions amounted to \$8,174.93 for the 2023 and \$5,674.16 for the 2024 Plan years.

As reported on Form 5500, Schedule H, Line 4d - Schedule of Nonexempt Prohibited Transactions, employer matching contributions were missed for one employee during 2023, thus constituting nonexempt prohibited transactions between the Plan and the Company during the 2023 Plan year. Late remitted employer contributions amounted to \$538.07 for the 2023 Plan year.
