NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following description of the Manatt, Phelps & Phillips, LLP Employee Savings Plan (the “Plan”) provides only general information. Participants and other interested parties should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - Manatt, Phelps & Phillips, LLP (the “Firm”, the “Employer”, and the “Plan Sponsor”) established the Plan to provide deferred compensation benefits for its eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Participation - As defined by the Plan, all staff employees, part-time employees, W-2 attorneys, and non-W-2 attorneys shall be eligible to participate in the employee deferral portion of the Plan after one hour of service and attaining age 21. Temporary employees shall be eligible to participate in the employee deferral portion of the Plan after either completing one year of eligibility service or completing at least 500 hours of service each year for three consecutive years and attaining age 21. Staff employees and Manatt Health non-attorney professionals shall become eligible to participate in the discretionary Employer matching contribution portion of the Plan after completing one year of service with at least 1,000 hours of service within that year and must be employed on the last day of the Plan year. No attorneys and no income partners are eligible for the discretionary Employer matching contribution. Staff employees and non-W-2 attorneys shall become eligible to participate in the discretionary Employer profit sharing contribution portion of the Plan after completing one year of service with at least 1,000 hours of service within that year and must be employed on the last day of the Plan year. Income partners and managing directors are eligible to participate in the discretionary Employer profit sharing contribution equal to 10 percent of their eligible compensation, not to exceed \$200,000, as defined by the Plan.

Contributions - Participants may make tax deferred and Roth contributions to the Plan of up to 100 percent of their eligible compensation, subject to the maximum permitted under the Plan and the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also includes an automatic enrollment provision and all newly eligible participants are enrolled at a pretax deferral rate of three percent of eligible compensation, unless they elect otherwise. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Firm makes discretionary matching contributions equal to 50 percent of the first three percent of eligible compensation contributed. Manatt Health non-attorney professionals are eligible to receive the Firm’s discretionary matching contribution equal to 100 percent of the first four percent of eligible compensation contributed. For the year ended December 31, 2024, the Firm contributed \$1,211,956 in discretionary matching contributions. The Plan also provides for discretionary Employer profit sharing contributions. For the year ended December 31, 2024, the Firm contributed \$6,564,656 in discretionary profit sharing contributions.

DECEMBER 31, 2024

Participant Accounts - Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's profit sharing contribution and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - All contributions and related earnings credited to the participants' accounts are fully vested and non-forfeitable. Employer contributions and related earnings become 100 percent vested immediately upon entering the Plan.

Payment of Benefits - For termination of service due to death, disability, retirement, or for other reasons, a participant or their beneficiaries, as applicable, whose account balance is greater than \$7,000 may elect to receive a lump-sum distribution or receive substantially equal installments not to exceed five years for the value of the vested interest in their account. Effective January 1, 2024, if the participant's or their beneficiaries', as applicable, vested interest is less than \$7,000, the participant or their beneficiary will receive a lump-sum distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Contributions - Contributions from Plan participants and the matching contributions from the Firm are recorded in the year in which the participant contributions are withheld from compensation.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are valued daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

DECEMBER 31, 2024

Administrative Expenses - Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Firm. Administrative expenses paid by the Firm are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net appreciation of investments is reflected net of these fees.

Benefits Payable to Participants - Benefits are recorded when paid.

Subsequent Events - The Firm has evaluated subsequent events through October 10, 2025, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements, except as disclosed below.

Effective January 1, 2025, the Plan was amended whereby temporary employees shall be eligible to participate in the employee deferral portion of the Plan after either completing one year of service or completing at least 500 hours of service each year for two consecutive years and attaining age 21.

3. FAIR VALUE

The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are the following:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 – Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – This category consists of publicly traded funds of registered investment companies. The net asset value ("NAV") of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

Self-directed brokerage accounts – The Vanguard Self-Directed Brokerage Fund allows a participant to buy or sell investments such as mutual funds and common stocks. The fair value of this account is the aggregation of the fair value of the underlying assets, all of which are actively traded, and are therefore classified as Level 1 within the valuation hierarchy.

Vanguard Retirement Savings Trust III – The Vanguard Retirement Savings Trust III, held in a collective trust (“CT”), is valued at the NAV of units of a bank collective trust. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The CT does not have any unfunded commitments relating to its investments, or any significant restrictions on redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

5. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their account balance. Loans are generally issued with a maturity of up to five years. The term of any loan for the purpose of purchasing a primary residence shall not exceed 10 years. The loan interest rate is set at a reasonable interest rate as determined by the plan administrator, as defined in the Plan. Principal and interest are paid ratably through payroll deductions.

6. TAX STATUS

The Firm received a determination letter dated October 3, 2017, in which the IRS stated that the Plan as designed was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter and the Firm believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Firm has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PLAN TERMINATION

The Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in investments managed by an affiliate of the Trustee. Transactions in such investments qualify as party in interest transactions for which exemptions exist. During 2024, the Trustee and its affiliate received direct compensation of \$203,120, all of which was paid by the participants through the Plan and received indirect compensation based on formula from investments. In addition, the Plan's independent public accountants received direct compensation of \$19,500.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS

One 2024 Roth contribution was not remitted timely to the Trustee as required by the Department of Labor's regulations. This late remittance is detailed in the attached Schedule H, Line 4a - Schedule of Delinquent Participant Contributions.
