As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 9 to the financial statements, is complete and accurate.

**Opinion**

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Executive Auto Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Executive Auto Group, Inc. and related participating employers (collectively, the Company) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Board of Trustees and management determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions - Each year, participants may contribute up to 100% of pretax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. At its discretion, the Company may match a percentage of participant pre-tax contributions to the Plan. In 2024, the Company contributed 25% of the first 4% of base compensation that a participant contributed to the Plan. Company matching contributions are invested as directed by the participants. Additional profit sharing amounts may be contributed at the option of the Plan sponsor and are invested as directed by the participants. The Company made no profit sharing contributions during the year ended December 31, 2024. Participants must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year in order to receive an allocation of employer matching or profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Company matching and profit sharing contributions is based on years of continuous service. Vesting occurs at a rate of 20% per year until the participant is 100% vested after five years of credited service.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Each loan bears interest at 2% above the prime rate, as defined, and is secured by the balance in the participant's account. Principal and interest is paid ratably through weekly or semi-monthly payroll deductions.

1. DESCRIPTION OF PLAN, CONTINUED

Payment of benefits - On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or partial withdrawals of at least \$1,000. Participants may elect to defer payment of their benefits until a later date, as defined (if the value of the vested benefit is greater than \$5,000). In 2024, the threshold was increased to \$7,000.

In certain hardship situations, participants may withdraw part of their account balance while actively employed, but such withdrawals are limited to the amount dictated by the hardship. The Plan also permits in-service distributions upon attaining age 59 1/2.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,439 and \$21, respectively. These accounts can be used to reduce Plan expenses or future employer contributions. Plan expenses were reduced by \$21 in 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Benefit payments - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Uncertain tax positions - U.S. GAAP prescribes a comprehensive model for how management should measure, recognize, present, and disclose in its financial statements uncertain tax positions management has taken or expects to take on a tax return. The Plan recognizes the tax benefits from uncertain tax positions if it is more likely than not that the tax position will be sustained on examination by the taxing authorities, based on the technical merits of the position.

Subsequent events - The Plan has evaluated events, if any, that have occurred subsequent to December 31, 2024, through October 9, 2025, the date the financial statements were available to be issued, and included information in the notes to the financial statements related to any identifiable events, if necessary.

3. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Units in the pooled separate accounts are valued using the net asset value (NAV) as a practical expedient to measure fair value as determined by Nationwide Trust Company, FSB. The value of a pooled separate account is its market value less operating expenses accrued but not deducted, if any. The value of a pooled separate account is based on the value of the assets allocated to the separate account, which can include, but is not limited to, stocks, bonds, mortgages, real estate, mutual funds, other separate accounts, and cash or cash equivalents.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan participates in an index fixed contract, which by definition is considered to be a guaranteed investment contract (GIC). The contract is an insurance company issued general account backed group annuity contract. There are no specific securities in the general account that back the investments in this account. All transactions are at contract value, including discontinuance of the contract. In certain instances when total distributions or transfers in the GIC within a calendar year exceed pre-determined thresholds, transactions in the GIC may face certain restrictions, in accordance with the contract terms. This could potentially result in the GIC not being fully benefit-responsive in certain instances. Management does not believe any such conditions that would limit participants' ability to transact at contract value have occurred.

Because the GIC is considered to be fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. Contract value as reported to the Plan by Nationwide Trust Company, FSB and Nationwide Life Insurance Company (collectively, Nationwide), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balances at contract value.

The GIC is a group annuity insurance product issued by Nationwide Life Insurance Company and is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of Nationwide Life Insurance Company and not on the value of the securities within the insurer's general account. Deposits made to the GIC are deposited in Nationwide Life Insurance Company's general account. Payment obligations under the GIC represent an insurance claim supported by all general account assets. The GIC does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Expenses related to the GIC are calculated by Nationwide Life Insurance Company and incorporated in the GIC crediting rate. Past interest rates are not indicative of future interest rates.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS, CONTINUED

Interest is credited on contract balances using a single “portfolio rate” approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting.

When establishing interest crediting rates for this product, Nationwide considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer’s general account. These rates are established using the five year treasury note yield adjusted for constant maturity as reported by the Federal Reserve Board in the *Federal Reserve Bulletin*. The minimum credit rate under the contract is 0.00%.

Key factors that could influence future average interest crediting rate include, but are not limited to: participant-directed cash flows; changes in interest rates; total return performance of the underlying contract; or default or credit failure of any of the investment contracts, or other investments held in the Plan.

5. RELATED-PARTY TRANSACTIONS

Certain Plan investments are units of pooled separate accounts managed by, and a guaranteed investment contract with, Nationwide. Nationwide is also the custodian and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. In addition, loans to participants qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed an intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

7. INCOME TAX STATUS

The Plan utilizes a non-standardized pre-approved defined contribution plan provided by Northwestern Wisconsin Associates, for which the IRS issued an opinion letter dated June 30, 2020, stating the form of the Plan was acceptable under the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Nationwide.
