## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator,  
Safe-Harbor 403(b) Thrift Plan for Employees of  
Bay Area Legal Services, Inc.:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Safe-Harbor 403(b) Thrift Plan for Employees of Bay Area Legal Services, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

(1) **Description of Plan:**

The following description of Safe-Harbor 403(b) Thrift Plan for Employees of Bay Area Legal Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(a) **General**—The Plan is a defined contribution 403(b) plan covering all eligible employees of Bay Area Legal Services, Inc. (the Organization). All eligible employees may begin to participate in the Plan at date of hire. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Each year, participants may contribute up to 100% of eligible pre-tax annual compensation, as defined by the Plan, up to IRS limits. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have an initial deferral rate set at 2% of eligible compensation, increasing 1% annually up to a maximum of 5%.

The Organization makes a safe harbor matching contribution at a rate of 100% for the first 3% of employee compensation deferred plus 50% of the next 2% of employee compensation deferred per eligible participant. The Organization may also make a discretionary non-safe harbor pro-rata contribution. No discretionary contributions were made for the year ended December 31, 2024. Participants direct the investments of the Organization's contribution into various investment options offered by the Plan. Contributions are subject to certain limitations.

(c) **Participant accounts**—Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The Plan currently offers 1 general account and 45 pooled separate accounts. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) **Notes receivable from participants**—Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance whichever is less. The loans are secured by the balance in the participant's account and bear interest at a variable rate. The variable interest rate is equal to the rate credited to amounts held in the interest accumulation account plus 3%, currently 5.85% for the year ending December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

(e) **Vesting**—Participants are immediately vested in their contributions and all Organization contributions plus actual earnings thereon.

(1) **Description of Plan:** (Continued)

(f) **Payment of benefits**—Upon termination of service due to retirement, disability, or death, participants or beneficiaries will receive a distribution equal to their vested account balance in accordance with plan provisions. Distributions may be paid in the form of a lump-sum payment or annual installments. The participant may take an in-service withdrawal from all accounts at age 59 1/2 or later. Absent the participant's election to roll distributions into another qualified plan or receive a lump sum payment, vested balances that are \$5,000 or less for terminated participants will be distributed to the participant in a lump sum payment. The Plan allows for certain hardship distributions from participant accounts.

(g) **Forfeited accounts**—The Plan is a safe harbor plan, with 100% of contributions vesting immediately. As a result, no forfeitures will occur under the Plan.

(h) **Plan expenses**—The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Certain administrative expenses of the Plan are paid directly by the Organization.

(i) **Cash and cash equivalents**—The insurance General Account is valued at contract value which is equal to fair value and is considered to be a cash equivalent. Contract value represents contributions made under the contract, plus interest at the credited rate, less funds used to purchase annuities and pay administrative expenses charged.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of accounting**—The financial statements of the Plan are prepared under the accrual method of accounting.

(b) **Investment valuation and income recognition**—The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for details regarding fair value measurements. Interest income and dividends are recognized when paid. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) **Payment of benefits**—Benefits are recorded when paid.

(d) **Notes receivable from participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

(e) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(f) **Subsequent events**—The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued. In December 2024 the Organization's Board passed a resolution to change service providers from Mutual of America to Empower. The conversion was completed in August 2025. No other subsequent events requiring recognition or disclosure have been identified.

(3) **Information Certified by the Trustees:**

All investment information disclosed in the accompanying financial statements and ERISA-required schedules, including investments held and participant loans at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America.

(4) **Investments and Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) **Investments and Fair Value Measurements:** (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value used at December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* – Valued at fair value of units held by the plan at the year end. Fair value is determined by the issuer and is valued daily using publicly available quoted market prices which match the current underlying investment holdings of the account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) **Plan Termination:**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the Plan and participants will become 100% vested in all amounts credited to their accounts.

(6) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(7) **Income Tax Status:**

The Plan adopted a pre-approved non-standardized plan that obtained a favorable determination letter from the Internal Revenue Service dated March 2, 2020. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdiction for the most recent three years; however, there are currently no audits for any tax periods in progress.

(8) **Parties-in-Interest:**

Mutual of America manages Plan investments and provides administrative services to the Plan and therefore, qualifies as a party-in-interest to the Plan. Fees paid to Mutual of America are included in administrative expenses.
