Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Western Heavy Haul, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Western Heavy Haul, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Western Heavy Haul, Inc. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. 1. Plan Description

The following description of Western Heavy Haul, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering all eligible employees of Western Heavy Haul, Inc. (the Employer). The Plan was established January 1, 1997. The Plan's most recent restatement was effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees oversee the governance of the Plan.

Contributions

Participants may elect to contribute, on a pre-tax basis, up to 100 percent of their annual compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Participants may also contribute rollover amounts, representing distributions from other qualifying plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Employer makes a required non-discretionary Safe Harbor match contribution equal to 100 percent of elective deferrals up to 4 percent of participant eligible compensation. Participants are eligible for Safe Harbor matching beginning on the first day of the month after attaining age 18 and completing two months of service. In addition, the Employer may make discretionary contributions allocated on an employee-by-employee basis in amounts determined by the Employer. Participants are eligible for discretionary Employer contributions after one year and 1,000 hours of service and be employed on the last day of the year. The Plan did not make a discretionary contribution for the years ended December 31, 2024 and 2023. All contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, in accordance with the Plan's provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their accounts into various investment options offered through Empower Trust Company, LLC. All accounts are fully participant directed.

Vesting

Participants are vested immediately in their contributions and Employer Safe Harbor matching contributions, plus actual earnings thereon. Vesting in discretionary Employer matching and profit-sharing contributions are based on years of service, defined as one calendar year in which the participant has at least 1,000 hours of service, according to the following schedule:

Payment of Benefits

Upon retirement, death, disability, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts in a lump sum, in accordance with the appropriate provisions of the Internal Revenue Code (IRC) and applicable state laws. Also, hardship withdrawals are allowed under certain circumstances, as described in the Plan document. In addition, participants may elect to receive withdrawals, at any time, of part or all of the interest in their accounts related to prior rollover contributions. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested.

Forfeited Accounts

Forfeitures of terminated participants' non-vested portions of Employer contributions may be used to pay Plan expenses and reduce future Employer contributions. During the Plan years, there were no forfeitures. At December 31, 2024 and 2023, there were no forfeitures available to offset future contributions or pay administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The Plan allows up to three outstanding loans for each participant at any one time. The loans are secured by the balance in the participant's account and bears an interest rate set at 1 percent above the prime rate, as defined. Loan terms range up to five years, unless the loan is used to purchase a principal residence, in which case the loan term may go up to 15 years. Principal and interest on participant loans is paid ratably through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net asset during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements.

Investment Valuation and Income Recognition, continued

The Plan's insurance contract is carried at contract value, which is fully benefit-responsive as described in Note 4, and represents deposits, plus earnings, less expenses and withdrawals.

Interest and dividend income are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant and employer contributions are recorded in the year in which participant contributions are withheld and underlying compensation paid.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses and Fees

Certain costs of administering the Plan are absorbed by the Employer and are therefore excluded from these financial statements. Certain other administrative and participant transaction fees are paid from participant accounts. Investment related expenses are included as part of investment income.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited a fixed quarterly rate which is used to pay investment advisory expenses. For the years ended December 31, 2024 and 2023, \$16,747, and \$13,392, respectively, was credited to the account and used to pay investment advisory expenses.

Recent Accounting Standard Adopted

On January 1, 2024, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, acting as the custodians for the Plan, have certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

4. Investment Contracts

The Plan's fixed account investment option is provided through a Group Annuity Contract with Empower classified as a general insurance contract. Under the terms of the contract, a crediting rate is established for amounts invested in the fixed account. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. The fixed account investment option is considered fully benefit-responsive notwithstanding the liquidation value events under the contract that limit the ability of the Plan to transact at contract value. The declared interest rate as of December 31, 2024 and 2023 was 2.80 percent and 1.35 percent, respectively.

5. Plan Termination

Although the Employer has not expressed any intent to discontinue its contributions and terminate the Plan Agreement, it may do so at any time subject to the provisions set forth in ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.

6. Tax Status

The Plan has adopted a Volume Submitter Profit Sharing Plan with CODA (the Volume Submitter Plan) sponsored by Pension Plan Specialists, P.C. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, which stated that the Volume Submitter Plan qualifies under Section 401(a) of the IRC and therefore the Plan is not subject to tax under present income tax law. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

Certain Plan investment options are funds managed by Empower Annuity Ins. Co. of America for the years ended December 31, 2024 and 2023. These transactions qualify as exempt party-in-interest transactions. Administrative fees paid directly by the Plan to custodians were \$3,039 and \$3,015 for 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate account as part of a group annuity contract, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets in the fair value hierarchy for the years ended December 31, 2024 and 2023.

9. Non-Exempt Transactions

During the year ended December 31, 2024, there were no late participant contribution payments. During the year ended December 31, 2023, there were late participant contribution payments totaling \$970 that were not remitted to the Plan within the appropriate time period by the Employer. In conjunction with the year ending December 31, 2022, late participant contributions of \$2,579 are reported as late transmittals. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest and has further implemented a procedure to ensure that all future remittances are made within the prescribed time period. There was a total of \$3,549 of non-exempt transactions from the years ended December 31, 2022 and 2023, which was corrected in 2024.

10. Reclassification

Certain prior year amounts have been reclassified to conform to current year presentation. Such reclassification had no effect on the previously stated changes in net assets available for benefits.

11. Subsequent Events

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
