### ***Opinion***

We have audited the financial statements of Food Authority Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **Note 1. Plan Description and Basis of Presentation**

The following brief description of the Food Authority Employee Stock Ownership Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

***General***

Air Stream Corp. (Air Stream) was formed and began operations in January 15, 1979. Air Stream has two wholly owned subsidiaries, Food Authority, Inc. and Food Authority South, LLC (South). Food Authority Holdings, Inc. (Holdings or the Company) was formed on August 3, 2017. On September 2, 2021, Holdings purchased 100% of the capital stock of Air Stream.

South established the Food Authority South LLC Profit-Sharing Plan (the Profit Sharing Plan) on January 1, 2016 (Effective Date). The Profit Sharing Plan allowed for discretionary profit-sharing contributions to be made by South. On December 21, 2016, the Profit Sharing Plan was amended to include all employees of Food Authority Massachusetts LLC with an effective date of January 1, 2016. On September 3, 2021, the Company amended and restated the Profit Sharing Plan to become the Plan that operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan is administered by an Employee Benefits Administration Committee appointed by the Company's board of directors. The trust department of an independent third-party bank is the Plan's trustee.

On September 9, 2021, the Plan purchased 1,000,000 shares of Holdings' voting common stock (the common stock) at a purchase price of \$49,000,000, which represents 100% of the Holdings' outstanding shares of common stock (the ESOP Transaction). The common stock, which is held in a trust established under the Plan, was purchased with cash from the Plan totaling approximately \$1,927,000 and the remaining portion was financed by issuing promissory notes in the aggregate amount of \$47,073,000. The cash payment of \$1,927,000 resulted in 26,228 shares being released and allocated. The ESOP Transaction was subject to a working capital and outstanding debt adjustment resulting in an increase to both the purchase price and the promissory notes by \$11,942,546. The final purchase price of the 1,000,000 share of the Company's voting common stock was \$60,942,546 (\$60.94 per share).

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Holdings. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- The accounts of employees with rights in allocated common stock (allocated), and
- Common stock not yet allocated to employees (unallocated)

***Eligibility***

Employees of the Company and its participating subsidiaries have reached the age of 21 are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during such Plan year and have attained the age of twenty-one years. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

***Contributions***

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted.

***Payment of Benefits***

Distributions on account of death, disability, or retirement are made in a lump sum or substantially equal annual installments over a period not to exceed five years following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made in five annual installments after the debt has been paid off. The amount to be distributed is based upon the immediately preceding valuation date.

Distributions are made in cash equal to the value of the shares allocated to the participants account. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

***Administrative Expenses***

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

***Voting Rights***

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's preferred stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants with less than three years of service are vested 0% and are 100% vested upon three years of service.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company preferred stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. However, if the fair market value of qualifying employer securities allocated to a participant's ESOP account is \$500 or less on the valuation date

immediately preceding the first day on which a participant is eligible to make the foregoing election, then that participant will not be eligible to make such an election.

***Forfeitures***

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. There were 2,047 forfeiture shares with a value of \$35,947 allocated to participants during the year ended December 31, 2024.

These forfeitures were allocated to the existing participants at year end, on a pro-rata basis and there were no unallocated forfeitures for the years ended December 31, 2024 and 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Allocations***

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated), and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

***Investment Valuation and Income Recognition***

The shares of Company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income, if any, is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions, if any, are reported on the average cost method. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Benefit Payments***

Benefits are recorded when paid. There were no benefits paid for the year ended December 31, 2024.

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Money market fund: Valued at cost plus accrued interest, which approximates fair value.
- The fair value of the Company's common stock held by the Plan is valued at fair value based upon independent appraisal. This appraisal was based upon a combination of the market and income valuation approaches consistent with the industry. The appraiser considered historical and projected cash flow and

net income, return on assets, return on equity, market comparable, and fair value of Company’s assets and liabilities.

- The valuation process involves the selection of an appraiser under contract on a year to year basis with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Loans Payable**

In September 2021, the Plan entered into promissory notes in an original aggregate amount of \$47,073,000 with the seller of the Company, which were then assumed by the Company. The proceeds of the loans were used to purchase the Company’s common stock. The original purchase price of the ESOP was subject to a working capital and outstanding debt adjustment. The outstanding debt adjustment increased the promissory notes by \$11,942,546 increasing the total loan balance to \$59,015,212. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is determined by the Company and trustees on a year by year basis. Principal and interest payments resulted in 40,000 shares being released and allocated for the Plan year ended December 31, 2024.

The loan is payable in 25 equal annual principal installments, plus accrued interest at 1.73% per annum. If not paid sooner, the principal and interest shall be paid by December 31, 2045. The balance of the loan as of December 31, 2024 and 2023, was \$49,056,646 and \$51,086,660, respectively. Interest expense on the loan amounted to \$868,926 for the year ended December 31, 2024.

**Note 6. Related-Party and Party-in-Interest Transactions**

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related-party and party-in-interest transactions. As described in Note 1, the Company pays all plan expenses. The Plan has a number of service providers for services such as record keeping, plan administration, and appraisals. Such providers are parties in interest under ERISA.

**Note 7. Risks and Uncertainties**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets (deficit) available for benefits.

**Note 8. Administration of Plan Assets**

The Plan's investment in Company common stock is held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received and makes distributions to participants. The trustee also administers the payment of interest and principal on the loan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Company.

**Note 9. Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed preferred stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code (IRC).

**Note 10. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated September 14, 2023, stating that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
