Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Tampa Bay Downs 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Tampa Bay Downs 401(k) Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 - DESCRIPTION OF PLAN

The following description of the Tampa Bay Downs 401(k) Savings Plan (the Plan) provides general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-seasonal employees of Tampa Bay Downs, Inc. (the Company) who have completed one hour of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 30 percent of pretax annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan has been amended to adopt the Safe Harbor Employer Matching Contributions provisions under Internal Revenue Code Section 401(k)(12). This amendment is effective as of June 1, 2010. Therefore, the employer matching contribution is 100% up to the first 3 percent of Compensation and 50 percent for the next 2 percent, up to 5 percent of Compensation for December 31, 2024 and 2023.

All employer contributions are invested in the same proportion as the employee contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the (a) employee's contribution, (b) an allocation of the Companies' additional contribution, and (c) Plan earnings. The Company's contributions are allocated pro rata using the same base that was used to determine the amount of the employees' contributions. Plan earnings are allocated based on the return of the specific investments held in the individual's account. Forfeitures shall be used to reduce the Companies' matching contributions to the Plan or pay administrative expenses of the plan. At December 31, 2024 and 2023, the Plan had approximately \$285 and \$144, respectively, of forfeiture available to reduce the Company's expenses or future contributions.

Vesting

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are always 100 percent vested in their deferred salary plus actual earnings thereon. In addition, the participants become vested in the Companies' contribution plus actual earnings thereon, based on years of continuous service. Safe Harbor Employer Matching contributions are fully vested when made. Non-Safe Harbor Employer matching contributions are 100 percent vested after four years of service.

The following is a schedule of the vesting percentages for Non-Safe Harbor employer contributions and matching:

All participants are 100 percent vested at the age of 65, regardless of their term of service.

Payment of Benefits

Participants are entitled to receive 100 percent of their vested balance in the Plan upon (a) normal retirement at age 65, (b) disability, (c) death, or (d) other termination of employment.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. The Plan currently offers twenty-nine mutual fund accounts and a guaranteed account backed by the general account of Empower. Participants may change their investment options daily.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Registered investment accounts held by trust companies are listed at estimated fair values as determined by the trust company.

Accounts are valued daily. Purchases and sales of securities are recorded on a trade-date plus one day basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investments

Investments are carried at current market value based upon quoted market prices. Purchases and sales of securities are recorded on the trade dates. Gains or losses on sales of securities are based on specific identification of those securities. Dividend income is recorded on the ex-dividend date. Income from investments is recorded as earned.

Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the amounts reported in these financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest as participant loan receivables. The participant loan receivable balances as of December 31, 2024 and 2023 were \$193,118 and \$135,595, respectively.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

FASB Codification 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value, Level 2 inputs other than quoted prices that are observable and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, mutual funds, cash and cash equivalents are based on quoted market prices.

NOTE 4 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PLAN ADMINISTRATION

The Company paid for certain audit and ERISA Surety Bond expenses. Certain administrative functions are performed by employees of the Company. None of the employees receive any compensation from the Plan.

NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower/ Talbott Life & Annuity Insurance Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and the interest bearing cash account reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
