### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Northwest Medical Homes, LLC Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Northwest Medical Homes, LLC Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## 1. Plan Description

This description of the Northwest Medical Homes, LLC Employee Savings Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan's trustees oversee the governance of the Plan.

### General

The Plan was established on January 1, 1998 for employees of Northwest Medical Homes, LLC (the Employer). The Plan is a defined-contribution plan covering substantially all employees of the Employer, except for most union employees, leased employees, and independent contractors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective January 1, 2022.

### Eligibility

Employees are eligible to participate in the Plan at age 21 and upon attainment of one year of service with at least 1,000 hours. Employees enter the Plan on the first of the month after meeting the eligibility requirements.

### Contributions

Eligible participants may elect to contribute pre-tax or Roth after-tax deferrals of compensation up to the limits provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may make additional pre-tax "catch-up" contributions. The Plan also allows for participants to make rollover contributions from existing qualified plans.

The Employer makes a Safe Harbor matching contribution of 100 percent of the first 3 percent of the participant's compensation contributed as deferrals and 50 percent of the next 2 percent of the participant's compensation contributed as deferrals each pay period, with a maximum match of 4 percent of eligible compensation. For the plan year ended December 31, 2024 and 2023, Safe Harbor contributions totaled \$242,432 and \$220,493, respectively.

The Employer may also make additional discretionary profit sharing contributions. To be eligible for such contributions, an employee must meet the eligibility requirements noted above and be employed on the last day of the Plan year with 1,000 hours of service during the year. For the plan year ended December 31, 2024 and 2023, discretionary profit sharing contributions totaled \$478,073 and \$490,217, respectively.

The Employer may also make additional discretionary matching contributions. To be eligible for such contributions, an employee must meet the eligibility requirements noted above. No such contributions were made in 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's and Employer's contributions and allocations of investment earnings or losses, based on the specific investments held in the participant's account. Each participant's account is also charged with an allocation of administrative expenses, when applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their accounts into various mutual fund investments offered by Voya Financial.

**Participant Loans**

Beginning May 1, 2024, participants may borrow a minimum of \$1,000 from their accounts or up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and will bear interest at a rate of 2 percentage points above the prime rate. Principal and interest will be repaid no less frequently than quarterly payments over a reasonable period of time not to exceed five years, unless for the purchase of a primary residence which can be repaid over a period not to exceed 15 years.

**Payment of Benefits**

In the event of death, disability, retirement, or termination of employment, the participant's account balance is payable as soon as administratively feasible after the date of the event. Once a participant reaches the age of 59½, the participant has an option to make an in-service withdrawal from their account, limited to one in-service distribution per year. Benefit payments are to be made in the form of an annuity unless the participant waives this option and elects a lump-sum distribution instead. The Plan does not allow for hardship withdrawals.

**Vesting**

Participants are immediately vested in their deferrals, Company Safe Harbor contributions and actual earnings thereon. Participants shall become 100 percent vested upon attainment of retirement age or in instances of death or permanent disablement. Participants are vested in the Company's discretionary matching and profit sharing contributions based on years of continuous service. A participant earns a year of service during any Plan year in which the participant is credited with 1,000 hours of service.

**Forfeitures**

Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan must be used before the end of the Plan year following the Plan year during which the termination occurred, and will be used to restore forfeitures, pay the Plan's administrative expenses or to reduce future Company contributions. During the year ended December 31, 2024 and 2023, amounts forfeited from participant accounts were \$5,056 and \$35,727, respectively. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,362 and \$20,377, respectively. In 2024 and 2023, \$20,375 and \$21,477 of forfeitures were used to reduce Employer contributions, respectively.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Accordingly, actual results may differ from those estimates.

**Contributions**

Participant and employer contributions are recorded in the year in which the participant contributions are withheld or the underlying compensation is paid.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses and Fees**

Expenses of maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements. Some costs of administration, including annual individual account fees, may be paid from participant accounts at the Employer's election. Loan fees may also be charged against participants who have been granted a loan. Investment related expenses are included in net change in fair value of investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. Participant loans were not permitted as of and for the year ended December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant deferral contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Information Certified by the Plan's Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

**4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become 100 percent vested in their accounts.

**5. Tax Status**

The Plan adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by Hershner Hunter LLP that received a favorable opinion letter from the Internal Revenue Service on November 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**7. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under professional standards are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Cash equivalent funds held by the Plan are valued at the contract value of the cash instrument. Because these inputs are not observable, these assets are considered to be valued at Level 2 in the hierarchy.

*Registered investment companies:* The Plan's investments are units of mutual funds held within a group annuity contract. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

*Insurance company general account:* Contracts held by the Plan are not considered fully benefit-responsive at the Plan level and are stated at fair value, which materially approximates contract value. Contract value is increased by contributions and earnings on the contracts, and reduced by participant withdrawals and administrative expenses. Fair value is assessed based on analysis of interest rates, maturities, discounted cash flows, and other observable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**8. Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by one of the investment providers of the Plan or a fixed or variable annuity contract with one of the providers. These transactions qualify as party-in-interest transactions as defined by ERISA.

**9. Non-Exempt Transactions**

For the year ended December 31, 2024 and 2023, participant contributions totaling \$106,994 and \$35,601, respectively, were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest and will further implement a procedure to ensure that all future remittances are made within the prescribed time period. Delinquent contributions from 2023 were corrected in 2024. Delinquent contributions from 2024 will be corrected in 2025.

**10. Subsequent Events**

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
