NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of plan

The following description of Federal Protection, Inc., (“Company”) 401(k) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all employees of Federal Protection, Inc., Federal Construction, Inc. Federal Response Center, Inc., Federal Protection Montana, LLC, and Federal Document Control, LLC. Employees are eligible to make elective deferrals after 3 months of service and after 21 years of age, and are eligible for Company discretionary contributions if employed on the last day of the year and worked at least 1,000 hours during the plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, subject to contribution limits set forth by the Internal Revenue Service. The Company is required to make a safe harbor match in the amount equal to 100% of the first 3% of participants’ contributions plus 50% of participants’ contributions that exceed 3% but do not exceed 5% of participants’ compensation.

Participants may also contribute to a ROTH account on an after-tax basis, but the sum of these contributions and pre-tax contributions above may not exceed the annual contribution limits set forth by the Internal Revenue Service.

The Company may also make a profit sharing contribution at the discretion of the Company’s Board of Directors.

c. Participants’ accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of plan (continued)

d. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

e. Payment of benefits

The Plan provides that a participant will receive a lump-sum amount equal to the value of his or her account as soon as administratively practical in the plan year beginning after termination.

f. In-service withdrawals

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals.

g. Participant investment rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

h. Forfeitures

Forfeitures of unvested Company matching contributions from terminated participant accounts can be used to offset Company matching contributions or to pay Plan administrative expenses, as determined by the Plan Administrator. At December 31, 2024, there were forfeited unvested accounts of \$1,008.

2. Summary of significant accounting policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment valuation

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of significant accounting policies (continued)

Payment of benefits

Benefits are recorded when paid.

3. Information prepared and certified by Qualified Institution

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part from information certified by the Trustee in accordance with 29 CRF 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments in mutual funds of and \$26,581,654 and \$22,951,859 at December 31, 2024 and 2023, respectfully, and related gain of \$3,466,454 for the year ended December 31, 2024.

4. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Transactions with parties-in-interest

Fidelity Management Trust Company is the trustee/custodian of the Plan investments. Fidelity Workplace Services, LLC is the Plan record keeper and responsible for the annual discrimination testing, annual 5500, and distribution processing. Fidelity Technology Group, LLC manages the Data Center Operations and Related Infrastructure Systems for Fidelity Workplace Services, LLC. Federal Protection, Inc. is the administrator for the Plan and responsible for providing all required plan documents. Fidelity Investments is the investment advisor for the Plan. RMMC is the Plan auditor. Each of these entities are classified as parties-in-interest with respect to the Plan.

Investment advisor fees, custodial fees, recordkeeping fees, and fees associated with distributions are paid for with Plan assets. All of the other administrative costs, including the salary of the Plan administrator and professional fees (accounting, legal, etc.) associated with the Plan are paid by the Plan sponsor.

6. Administrative costs

During the year ended December 31, 2024, administrative expenses of \$112,221, were paid by the Plan. All other administrative costs were paid by the Plan sponsor.

7. Tax status

The Prototype Plan, under which the Plan operates, obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue

7. Tax status (continued)

Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Fair value measurements

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.
- Level 2        Inputs to the valuation methodology include
- quoted prices for similar assets in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.
- Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

8. Fair value measurements (continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

*Registered investment companies (Mutual funds):* Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Separated participants

At December 31, 2024, \$487,951 of the net assets available for benefits are for those participants who have separated from active service with the Plan sponsor.

12. Subsequent event

The Plan has evaluated subsequent events through October 3, 2025, the date which the financial statements were available to be issued. There were no significant events noted that did not exist at the date of the balance sheet but arose subsequent to that date.
