**1. *Description of Plan***

The following description of the Employee Benefit Plan of Victory Human Services, Inc. (the Plan) provides only general information. Participants should refer to the summary plan description or the plan agreement for more complete information of the Plan's provisions.

*General*

The Plan is a 401(k) defined contribution plan covering all full-time employees of Victory Human Services, Inc. (the Company). There is no minimum age requirement to enroll into the Plan. Eligible employees have the option to enroll in the Plan on their date of hire for elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors oversee governance of the Plan. The Company's Board of Directors and management determine the appropriateness of the Plan's investment offerings and monitor investment performance.

*Employer Contributions*

Each year, the Company can contribute a discretionary non-elective contribution to all eligible participants of the Plan, who are actively employed during the Plan year. The Company contribution is based on the sole discretion of the Company's Board of Directors. During 2024 and 2023, the Company did not make any contributions into the Plan.

*Participant Contributions*

Participants may contribute the lesser of a percentage of their compensation, as defined in the Plan documents, for the calendar year or the maximum allowed under section 402(g)(1)(B) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, the Plan allows participants to make Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and an allocation of (a) Company contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. *Description of Plan - continued***

*Forfeited Accounts*

Forfeitures of terminated participant non-vested accounts shall be applied to reduce future Company contributions and non-elective contributions to the Plan, or used to pay Plan expenses.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is upon the completion of three years of vesting service.

*Notes Receivable from Participants*

Participants may borrow from their respective accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loan proceeds are obtained by liquidation of investment company shares attributable to the participant's account. Loan terms will not be greater than five years or up to thirty years for the purchase of a primary residence.

Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined at the time of the loan by the Plan administrator. Interest rates on outstanding loans as of December 31, 2024 and 2023, range from 4.25% to 9.50%. Principal and interest payments are made ratably through payroll deductions.

*Payments of Benefits*

On termination of service due to death, disability or retirement, a participant (or the beneficiary upon the participant's death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of one to fifteen years. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may make either hardship or discretionary withdrawals from certain funds within the Plan while still employed. Both types of withdrawals have specific limitations and conditions. Withdrawal elections may be made at any time, and a minimum withdrawal of \$1,000 is required. There is no limit on the number of hardship or discretionary withdrawals a participant may make during employment with the Company.

**2. *Significant Accounting Policies***

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Administrative Expenses*

The Company pays substantially all administrative expenses of the Plan. Administrative expenses, which relate to the servicing of participant loans and certain investment fees, are paid via a reduction of participant account balances.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

**3. Information Prepared and Certified by the Trustee (Unaudited)**

Certain information in the accompanying financial statements and ERISA-required supplemental schedules related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

**4. Income Tax Status**

The Plan, has adopted the Mutual of America Life Insurance Company Prototype Non-standardized Profit Sharing Plan which has received a determination letter from the Internal Revenue Services (IRS) dated March 31, 2014, that the prototype plan satisfies the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, plan management believes that the Plan is currently designed and being operating in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

**5. Party-in-Interest Transactions**

Plan investments consist of certain funds managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services totaled \$1,311 and \$736, for the years ended December 31, 2024 and 2023, respectively.

**6. Fair Value Measurements**

*FASB ASC 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value:

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**7. The General Account**

The Plan invests in the General Account (the Fund), a traditional fully benefit-responsive guaranteed investment, managed exclusively for the Plan by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Fund's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Fund meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. The Fund is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported by Mutual of America Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**7. *The General Account - continued***

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Fund at December 31, 2024 and 2023, was \$222,868 and \$209,802, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

There are certain events that limit the ability of the Plan to transact at contract value with the issuer immediately. Such events include termination of the contract, layoffs, termination of the plan, plant closings, bankruptcy, mergers or early retirement incentives. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The investment contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

**8. *Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan Agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**9. *Risks and Uncertainties***

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risk such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net asset available for benefits.

**10. *Delinquent Participant Contributions***

During 2021, 2020 and 2019, participant contributions and participant loan payments were made through payroll withholdings according to the biweekly payroll schedule of the Company. Remittances of these amounts were made each pay period to the Plan. For the years ended December 31, 2021, 2020 and 2019, two, five and fourteen pay periods, respectively, resulted in delinquent contributions totaling \$1,450, \$21,939 and \$38,942, respectively. During 2021, plan management corrected \$44,830 of the total delinquent contributions. Management anticipates on calculating the lost earnings for the remaining delinquent participant contributions and correcting the errors during 2025, outside of the Voluntary Fiduciary Correction Program following the Department of Labor's guidelines and calculator.

**11. *Subsequent Events***

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in these financial statements.
