- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Inserra Supermarkets, Inc. Profit Sharing 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Inserra Supermarkets, Inc. Profit Sharing 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Inserra Supermarkets, Inc. Profit Sharing 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Inserra Supermarkets, Inc. Profit Sharing 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### 1. DESCRIPTION OF THE PLAN

The following brief description of the Inserra Supermarkets, Inc. Profit Sharing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company (“Fidelity” or “Trustee”) is the trustee of the Plan’s assets. Fidelity Workplace Service LLC is the Plan’s recordkeeper.

**Eligibility** – Employees become eligible to participate in the Plan on January 1st or July 1st upon attainment of age 21 and upon completion of one year of service with Inserra Supermarkets, Inc. (the “Company”) or the following participating employers: LML Supermarkets, Inc., Shoprite of Garnerville, Inc., Terzo of Garfield, LLC, Shoprite Liquors of Hillsdale, Inc., Tonnelle Liquors, Inc., KD Liquors LLC, Lin-Lar, Inc., Lady Bella Liquors, LLC, Honoris Causa, LLC, or 22 SP Wine & Liquors, LLC.

**Contributions** – Each year, participants may contribute up to the maximum percentage of eligible compensation allowable under the Internal Revenue Code (“IRC”). Participants in the Plan may elect to make contributions, through payroll deductions, up to 60% of their compensation. In accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible employees may make additional employee contributions known as a “catch-up” contributions in accordance with the Economic Growth and Tax Reconciliation Relief Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024.

The Plan Sponsor matches 50% of the participant's pre-tax contributions, up to 4% of compensation calculated and remitted on an annual basis. An additional profit-sharing contribution may be made at the discretion of the Plan Sponsor. For the years ended December 31, 2024 and 2023, the Company made a discretionary profit-sharing contribution.

Participants direct the investment of participant and employer contributions. This investment election can be changed at the participant's discretion. The Plan currently offers a variety of different mutual funds as investment options for participants.

Participants may change their contribution percentage elections, with the option to discontinue their contribution in the Plan, at the beginning of each payroll period.

**Rollovers** – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

**Participant Accounts** – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution, any Company contributions, an allocation of Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Allocations of expenses are based upon account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. DESCRIPTION OF THE PLAN (continued)

**Vesting** – Plan participants are 100% fully vested in their rollover contribution, salary deferral contributions, and any earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is as follows:

**Notes Receivable from Participants** – Participants may borrow from their individual account balances in accordance with the Plan's provisions. The maximum amount is the lesser of (a) \$50,000 or (b) one-half a participant's vested account, but not less than \$1,000. Loans are collateralized by the participant's vested account. All loans bear an interest rate at prime plus 1% and must be repaid in five years, unless used for the purchase of the participant's principal residence, which may be paid over a period up to ten years. The interest rates of loans range from 4.25% to 9.50%, maturing through December 2029. Interest and principal are paid ratably through payroll deductions. Upon termination of employment, the participant may either repay any outstanding balance in full or incur a tax liability on the unpaid balance.

**Distributions** – Benefits will normally be distributed to a participant or his or her beneficiary upon death, disability, retirement, termination of employment or minimum required distribution. Benefits are distributed, under one or both of the following methods: (i) a single lump-sum payment (ii) installments over a period of time as determined by the participant and the Plan. Employees may defer distribution only if the account balance is greater than \$7,000. Prior to age 65, in-service withdrawals from the Plan are allowed for unusual hardship and upon attaining the age of 59.5.

Upon termination of employment prior to eligibility for retirement, participants are eligible to receive the vested balance in their account.

**Forfeited Accounts** – Forfeited balances of participants' non-vested accounts are used in future periods to reduce employer contributions or pay Plan expenses. At December 31, 2024 and 2023, the unallocated forfeitures totaled \$28,748 and \$20,250, respectively. For the year ended December 31, 2024, \$889 of forfeitures were utilized to reduce employer contributions.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates** – The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of asset and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Valuation of Investments and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for description of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expense and charged directly to the participant's account.

**Payment of Benefits** – Benefit payments to participants are recorded when paid.

**Excess Contributions** - Benefit paid to participants during the year ended December 31, 2024 include payments of \$55,379 made to certain active participants to return to them excess deferral contributions as required to satisfy the relevant non-discrimination provisions of the Plan.

### 3. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan management has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, except for comparing such information certified by the trustee with information included in the Plan's financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i-Schedule of Assets (Held at End of Year).

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual and Money Market Funds:*** Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. FEDERAL INCOME TAX STATUS

The Plan has adopted a Volume Submitter Profit Sharing Plan with CODA sponsored by Fidelity Management & Research Company. On June 30, 2020, the IRS stated in an advisory letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

The Plan is currently undergoing an audit by the Department of the Treasury Internal Revenue Service Tax Exempt and Government Entities. The audit is in progress for the tax year ended December 31, 2021, and the outcome is yet to be determined. While the Company believes that the Plan has complied with all applicable tax laws, the financial results of the audit may result in adjustments to the Plan's tax positions, which could affect its financial statements.

### 6. RISK AND UNCERTAINTIES

The Plan invests in various securities including mutual and money market funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks that may be impacted by external financial, business and other factors including economic downturns, natural disasters, geopolitical conflicts or pandemic illness. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Additionally, the investments the Plan invests in may change their distribution or dividend policies, which could have an effect on the value of the investment securities.

The Plan's exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed fund elections including active and passively managed funds covering multiple asset classes. Additionally, the investments with each participant-directed fund election are further diversified into varied financial instruments. The Plan's investment in Fidelity Government Money Market Fund totaling \$6,572,575 as of December 31, 2023 represented a concentration equal to or greater than 10% of the Plan's net assets available for benefits. The Plan's investment in Fidelity Contrafund K6 totaling \$22,199,025 and \$17,770,925 as of December 31, 2024 and 2023, respectively, represents a concentration equal to or greater than 10% of the Plan's net assets available for benefits.

### 7. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the right to; modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

### 8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional. Fidelity Workplace Services provides recordkeeping services for the Plan. Fidelity Investments Institutional, Fidelity Workplace Services and Fidelity Management Trust Company are companies under Fidelity Investments. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, transactions with Fidelity Investments Institutional qualify as party-in-interest transactions. In addition, participants are charged administrative expenses for distributions and loan withdrawals as well as investment advisory fees as applicable by Fidelity Workplace Services, and these transactions qualify as party-in-interest transactions. Net fees paid by the Plan were approximately \$124,000 for the year ended December 31, 2024.

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

### 9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required.
