Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ideal Clamp Products 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). 1. Plan Description

The following description of the Ideal Clamp Products 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was established May 1, 1979 and was most recently amended and restated effective January 1, 2024. The Plan is a defined contribution plan available for qualifying employees of Ideal Clamp Products, Inc. and participating employers (collectively the Company or Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The trustee of the Plan is Charles Schwab Trust Bank (Trustee). The recordkeeper of the Plan is TRI-AD Actuaries, Inc. (Recordkeeper). The administrator of the Plan is the Company. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company, as defined, are eligible to participate in the Plan after completing 30 consecutive days of employment. Prior to January 1, 2024, temporary employees of the Company, as defined, were eligible to participate in the Plan after completing 12 consecutive months of service with at least 1,000 hours.

Union employees whose employment is governed by a collective bargaining agreement, leased employees, and non-resident aliens are not eligible to participate in the Plan.

Contributions

Participants may contribute on a pre-tax or after-tax Roth basis up to 100% of their eligible compensation, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained or will attain the age of 50 by the last day of the plan year may elect to make catch-up contributions, as defined by the Plan, subject to IRC limitations. Participants may increase or decrease their deferral percentages throughout the year.

The Plan includes an automatic-enrollment provision whereby eligible employees will be automatically enrolled in the Plan at a 3% pre-tax contribution rate. Participants may waive the automatic enrollment.

For the year ended December 31, 2024, the Company made a safe harbor basic matching contribution equal to 100% of the first 3% of participant contributions, plus 50% of the next 2% of participant contributions. Catch-up contributions are matched.

The Company may also make an annual discretionary profit-sharing contribution. Participants are eligible to receive a discretionary profit-sharing contribution if they have completed a year of service (12 months of service with at least 1,000 hours) and are employed by the Company on the

last day of the plan year. These discretionary contributions will be allocated in the ratio that a participant's annual total compensation bears to the compensation paid to all eligible participants for the plan year. The Company did not elect to make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Rollover contributions transferred from other qualified retirement plans or Individual Retirement Accounts (IRA) are accepted as permitted by the Plan Document.

Participants Accounts and Investment Options

Each participant's account is credited with (1) the participant's pre-tax, after-tax Roth, catch-up, and rollover contributions; (2) the Company's safe harbor basic matching contribution and discretionary profit-sharing contribution; and (3) an allocation of plan earnings or losses thereon. Each participant's account is charged with withdrawals and expenses. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option.

Participants may direct the investment of their account balances into various investment options offered by the Plan and may change their investment elections at any time. The Plan offers various registered investment companies (mutual funds) and a collective investment trust as investment options for participants. If a participant does not affirmatively elect an investment allocation, a Target Date Fund appropriate for the participant's age will be selected for them. Participants may make investment election changes at any time. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting and Forfeitures

Participants are immediately 100% vested in their pre-tax, after-tax Roth, catch-up, rollover and employer safe harbor basic matching contributions. Participants are 100% vested in the discretionary profit-sharing contribution upon completion of three years of service. A participant's vesting percentage in discretionary contributions shall be 100% if the participant dies while employed, becomes disabled, or reaches normal retirement age (age 65).

In the event the Plan has forfeited balances, forfeitures may be applied to reduce future employer contributions or pay plan administrative expenses. As of December 31, 2024 and 2023, the forfeitures account had a balance of \$0.

Payment of Benefits

A participant's vested interest in the Plan is payable upon termination of employment for any reason or upon death. Upon termination of service, the participant may (1) elect to receive the distribution in a lump sum, (2) roll over their account balance to another qualified plan or IRA, or (3) leave the account in the Plan up to age 72, at which time one of the above distribution options must be selected if the participant is no longer employed.

If a participant dies before benefits have begun, the vested portion of the account is paid to the beneficiary in a lump sum.

Terminated participants whose account balance is less than \$1,000 will receive a lump-sum cash distribution if the participant does not elect another form of distribution. If the participants balance

is over \$1,000 but no more than \$7,000 it will be rolled into an IRA in the name of the participant. Terminated participants may elect to withdraw any portion of their accounts at any time after they terminate, provided the minimum amount requested is at least \$1,000.

Actively employed participants can begin withdrawing their employer safe harbor basic matching contribution account along with their pre-tax, after-tax Roth and rollover balances without penalty at age 59½. In-service hardship distributions are allowed if certain criteria are met. A beneficiary may elect to rollover any portion of a distribution that would constitute an eligible rollover distribution, if it were made by a participant, surviving spouse or alternate payee.

Notes Receivable from Participants

A participant may borrow a minimum of \$1,000 up to 50% of his or her non-forfeitable balance not to exceed \$50,000. Notes are secured by the balance in the participant's account and bear an interest rate based on the rates available for similar borrowings from commercial institutions; the rate is fixed for the term of the note. Interest rates on outstanding notes at December 31, 2024 range from 3.25% to 10.50%. Notes are repaid ratably through payroll deductions over a period of five years or less, (unless the note is used for the purchase of a primary residence which may be a longer duration). Only one note may be outstanding at a time, and a participant may not originate more than one new note in a 12-month period.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Document to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. To the extent not already vested, participants would be fully vested upon termination of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchase and sales are recorded on the trade-date basis. Interest and dividend income include interest on the collective investment trust fund and dividends on holdings in registered investment companies. The net appreciation in the fair value of investments represents the realized and unrealized gains and losses on the investments and capital gains reinvested.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest was de minimus. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant contributions and the related safe harbor basic matching contributions are recorded in the Plan year during which the Company makes payroll deductions from the participant's compensation.

Payment of Benefits

Benefits paid to participants are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid as of December 31, 2024 or 2023.

Administrative Expenses

The Plan may pay for eligible Plan expenses as provided by the Plan Document. Fees, primarily loan origination, distribution fees, and asset-based fees, are charged directly to the participant's account and are included in administrative expenses. Administrative expenses of \$122,712 were paid by the Plan for the year ended December 31, 2024. Certain investment expenses charged within the registered investment companies are presented net of the net income or loss of each investment option in net appreciation in fair value of investments. All other expenses of the Plan incurred during 2024 were paid by the Company and are excluded from these financial statements.

3. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified that the following data included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest and dividend income, net appreciation in the fair value of investments, and interest earned on participant notes receivable as shown on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

- Investment balances and information included in the notes to financial statements.
- All investment information included in the supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) 820, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement of an asset or liability.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered Investment Companies (Mutual Funds) - The shares of mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish

their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund Collective Investment Group Trust - The Wilmington Trust Collective Investment Trust III for MetLife Group Annuity Contract No. 25554 (the Fund) was formed as a collective investment group trust. The Fund is comprised of a group annuity contract which primarily consists of fully benefit responsive investment contracts. The Fund is valued daily at the NAV of the units of the collective investment trust. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily. If the Plan initiates a full redemption of the Fund, the issuer reserves the right to require 12 months' notification in order to ensure that security liquidations will be carried out in an orderly manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing plan document sponsored by FIS Business Systems LLC. The Internal Revenue Service (IRS) has determined and informed FIS Business Systems LLC, by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing plan document qualifies under Code Section 401. The Plan Administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date, and no provision for income taxes have been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.

6. Exempt Party-in-Interest Transactions

The Plan has a service agreement with the Recordkeeper which shall continue indefinitely, unless cancelled by either party with prior written notice. Payments to the Recordkeeper by the Plan consisted of administrative fees totaling \$122,712 for the plan year ended December 31, 2024. Also, the Trustee receives indirect fees charged within the investment accounts. In addition, participants could borrow from their accounts (notes receivable from participants). The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. Risks and Uncertainties

The Plan provides for various investments in registered investment companies and a collective investment group investment trust. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity and related income of the investments are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investments and the level of uncertainty related to the changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued. Management determined there were no material subsequent events that required recognition or additional disclosure in these financial statements.
