Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of TOBA, Inc. Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of TOBA, Inc. Profit Sharing Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TOBA, Inc. Profit Sharing Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TOBA, Inc. Profit Sharing Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A – DESCRIPTION OF PLAN

The following description of TOBA, Inc. Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all employees of TOBA, Inc. (the Company), except collective bargaining employees and leased employees, who have completed 60 days of service and are age 19 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally established as of January 1, 1996, and has been subsequently amended and restated effective February 18, 2022. The Plan's trustees are responsible for oversight of the Plan. They determine the appropriateness of the Plan's investment offerings and monitor investment performance.

2. Contributions

Each year, participants may contribute a percentage of pre-tax or after-tax (Roth) annual compensation, as defined in the Plan up to IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Newly eligible employees are automatically enrolled in the Plan to make pre-tax contributions at a rate of three percent of eligible compensation. Employees may elect to opt out of automatic enrollment or change their contribution percentage at any time.

The Company may make discretionary matching or profit sharing contributions as determined by the Company's Board of Directors. For the year ended December 31, 2024, the Company elected to make profit sharing contributions of \$515,095, against which management applied \$15,000 of the balance of forfeitures. This was allocated to employees based on eligible compensation for those who were still employed on the last day of the year, worked at least 1,000 hours during the Plan year, and completed 12 months of service. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

3. Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, account earnings, and may be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participant accounts are participant-directed, including any Company contributions.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after six years of service.

5. Payment of Benefits

Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59.5. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the Internal Revenue Code (IRC). Payments are made in the form of a lump-sum distribution or a non-periodic distribution. In-service and hardship distributions are allowed if certain criteria are met.

6. Forfeited Accounts

Accounts forfeited by participants who terminate service prior to becoming fully vested may be used to pay Plan expenses or reduce the Company's matching contribution. For the year ended December 31, 2024, participants forfeited \$74,665. The Company utilized \$62,531 and \$41,893 in forfeitures to reduce the Company's contribution and to pay Plan expenses, respectively, during 2024. Unallocated forfeited accounts totaled \$36,691 and \$62,114 at December 31, 2024 and 2023, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The financial statements of the Plan are prepared using the accrual method of accounting and in conformity with accounting principles generally accepted in the United States of America.

2. Administrative Expenses

Certain operating expenses of the Plan are deducted from participant accounts. The remaining expenses are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of those investments.

3. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Principal Life Insurance Company, which received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan adopted by the Plan, as then designed, satisfied the applicable provisions of the Internal Revenue Code.

3. Income Tax Status – Continued

Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

4. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

5. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

6. Payments of Benefits

Benefits are recorded when paid.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statement of Net Assets Available for Benefits.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. In the event of termination or partial termination of the Plan, all amounts credited to a participant's account, including Company contributions, become fully vested. Their accounts shall be distributed to participants in accordance with the provisions of the Plan.

NOTE D – FINANCIAL INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Principal Trust Company (Trustee) that all information relating to the Plan's investments and related investment income is complete and accurate. Information as to the value of the investments in the trust fund managed by the Trustee, investment income, and all information in the supplemental schedule is presented in reliance solely upon those certifications.

NOTE E – FAIR VALUE MEASUREMENTS

The investments of the Plan are reported at fair value, except for the Plan's Fixed Income Guaranteed Option investment, as required by GAAP. The Plan categorizes its fair value measurements within the fair value hierarchy established by ASC 820, which gives the highest priority to quoted prices in active markets for identical assets (Level 1), and the lowest to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1: Valuations based on quoted prices in active markets for identical assets or liabilities accessible by the Plan as of the measurement date.
- Level 2: Valuations based on inputs—other than quoted prices included in Level 1—that are observable for the asset, either directly or indirectly.
- Level 3: Valuations based on unobservable inputs for the asset, reflecting the Plan's own

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset values and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: are valued at net asset value as reported by the investment manager of the fund.

Common Collective Trust: is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The Common/Collective Trust, which is measured at fair value using the net asset value per share (or its equivalent) as a practical expedient, has not been categorized in the fair value hierarchy. There were no unfunded commitments or liquidity or redemption restrictions related to the Common/Collective Trust.

NOTE F – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains a contract (fixed interest account) with Principal. Principal maintains the contributions in a general account. The average yield for the years ended December 31, 2024 and 2023 as 1.55% and 1.65%, respectively. Principal is contractually obligated to repay the principal and the specified guaranteed interest rate to the Plan. Contract value represents contributions made under the contract, plus earnings less participant withdrawals. The contract value in the amount of \$14,321 and \$14,102, is presented on the face of the statement of net assets available for benefits as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on Principal's ability to meet its financial obligations. Principal's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Principal. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE G – PARTIES IN INTEREST

Certain Plan investments are shares of mutual funds and common collective trust funds managed by Principal Trust Company. The Plan receives custodial and recordkeeper services from Principal Trust Company (the trustee) and therefore, these transactions qualify as party-in-interest transactions.

Also, several employees of the Company serve on the Administrative Committee and provide various services to the Plan (at no cost to the Plan) as follows:

1. A portion of the administrative functions of the Plan
2. Plan operations
3. Investment review

NOTE H – SUBSEQUENT EVENTS

In preparing these financial statements, the Plan management has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued. No events or transactions were noted to that date which require further disclosure.
