- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of matter – Basis of accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - PLAN DESCRIPTION

The Robert R. McCormick Foundations (the “Foundations”) are the sponsors for the Robert R. McCormick Foundations 403(b) Plan (the “Plan”). The Foundations include the Robert R. McCormick Foundation and the Cantigny Foundation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. Effective January 1, 2023 the Company amended its plan document to add the safe harbor design, funding a safe harbor employer match, which funds the Plan on a pay period basis rather than quarterly. Effective June 30, 2023, the Company amended the plan document to add a true-up option to the safe harbor match, allowing the employer to make true-up matching contributions if the period used to determine matching contributions is a period that is not the plan year.

General

The Plan is a defined contribution plan, which covers all employees of the Foundations who voluntarily elect to defer income through regular elective deferral contributions. Prior to 2023, employee participants who completed at least 1,000 hours of service during their first 12 months of employment or any Plan year thereafter were eligible to receive employer matching contributions as described below. Effective January 1, 2023, employees are immediately eligible for the employer match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration

Ongoing administration of the Plan is performed by the Retirement Plan Committee (the “Committee”), which is appointed by the Foundations. The Committee is responsible for the management and control of the Plan’s assets and has certain discretionary authority and control over such assets.

Contributions

The Plan consists of two types of contributions: employee elective deferral contributions and employer matching contributions. Employee elective deferral contributions are initiated by the employee and are limited to the elective deferral and the age 50 catch-up deferral limits under Section 403(b) of the Internal Revenue Code (IRC). Participants may elect to designate all or any portion of his future elective deferral contributions as Roth elective deferral contributions; and the Plan provides for an automatic election to have elective deferral contributions made. The automatic elective deferral contribution shall be pre-tax elective deferral contributions and shall be 3% of compensation. The employee may affirmatively elect a different percentage or elect not to make elective deferral contributions, and may elect to designate all or any portion of his elective deferral contributions as Roth elective deferral contributions. The automatic elective deferral contribution also applies to all active participants who have not elected to make elective deferral contributions of at least 3%.

Effective January 1, 2023, employer contributions are matched at 100% of elective deferral contributions that are not over 6% of the participating employee’s compensation.

Participants can direct their contributions into their choice of various Principal Trust Company (Principal) investment options.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (i) the employer’s contribution and (ii) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable From Participants

Participants can borrow from their fund accounts a minimum of \$1,000 or a maximum equal to the lesser of \$50,000 (reduced by any other outstanding loan balances) or 50% of the value of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates at the inception of the loan. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence. Only two loans may be outstanding to a borrower at any time.

Vesting

Participants are fully vested in the entire amount of their contributions, together with actual earnings associated with their contributions. Participants are vested immediately in employer contributions.

Forfeitures

During the year ended December 31, 2024, \$42,735 was used from the forfeited nonvested account to reduce employer contributions and \$7 was used to pay administrative expenses. Nonvested forfeited benefits are maintained by the custodian and are used to reduce future employer contributions or pay administrative expenses. The forfeited nonvested account balance as of December 31, 2024 and 2023, was \$0.

Withdrawals Prior to Termination

Participants may elect to withdraw up to 100% of their employee elective deferral contributions upon written notice of financial hardship to the Plan Administrator. Employer matching contribution account balances are not eligible for withdrawal prior to termination.

Retirement Benefits

Benefits are paid as elected at any time after the participant has attained age 59½. Mandatory benefit payments will be made to retired participants who have attained age 73 and have previously elected not to receive benefits upon reaching normal retirement age. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The payment of vested benefits due to retirement, disability, death or termination of employment will be made at the election of the participant, or in case of death, at the election of his or her designated beneficiary. Per the Plan, if a terminated participant's vested benefit is not greater than \$7,000, the participant is paid a lump-sum distribution as soon as administratively practicable after the participant's separation from employment. The Foundations have elected to allow the participant to elect a rollover distribution of vested benefit amounts.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Foundations.

Plan Termination

The Foundations retain the right to terminate the Plan at any time. In the event of dissolution, merger, consolidation or reorganization of the Foundations, the Plan shall terminate. The liquidation of Plan assets at the time of its termination shall be directed by the Committee and shall include the payment of benefits to applicable participants in accordance with ERISA.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the modified cash basis of accounting. Accordingly, the Plan's transactions are reported on the basis of cash receipts and cash disbursements, except for accrued income and the fair value reporting of investments held by the custodian. Had the financial statements been prepared using the accrual basis of accounting, employer contributions receivable to the Plan would have been approximately \$44,000 and \$12,000 at December 31, 2024 and 2023, respectively.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments

The Plan's investments in mutual funds are stated at fair value based on quoted market prices as reported to the Plan by the trustee, Principal. The Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

The Plan's investment in the Principal Guaranteed Option, which is a fully benefit responsive investment contract, is reported at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the custodian, is the aggregation of contributions, plus interest, less withdrawals, if any.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on the trade date.

Net Appreciation in Fair Value of Investments

Net realized and unrealized appreciation is reported in the accompanying financial statements as net appreciation in fair value of mutual funds.

Distributions

Distributions are recorded when paid.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at contract and fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

Plan investments are valued using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY

Plan assets include a fully benefit responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. Due to the nature of these contracts, they do not have specific underlying assets assigned. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - INCOME TAX STATUS

The Plan is a Volume Submitter 403(b) Plan sponsored by Principal Life Insurance Company and adopted by the Foundations. The Volume Submitter Plan obtained its latest opinion letter March 31, 2017, in which the Internal Revenue Service (IRS) stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state and local taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Principal, the Plan's trustee. Therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan has loans to participants that also qualify as party-in-interest transactions.
