## INDEPENDENT AUDITORS' REPORT

To the Trustees  
Sellars Absorbent Materials 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Sellars Absorbent Materials 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The Sellars Absorbent Materials 401(k) Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 1, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Sellars Absorbent Materials, Inc. is the plan sponsor, employer and the plan administrator. Standard Retirement Services, Inc. (a subsidiary of StanCorp Financial Group, Inc.) is the third party administrator that maintains plan and participant records and tax counsel that performs various compliance tests. Charles Schwab Trust Bank ("Charles Schwab") is the investment agent and custodian of plan assets. Retirement Plan Solutions is the plan's investment advisor. Three officers of the plan sponsor are the plan trustees.

**Investments** - An investment committee at the plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**Mutual Funds** - Valued at the published quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

**Investment at contract value** - The plan has a fully benefit-responsive stable value fund through an annuity contract issued by Standard Insurance Group ("Standard"; a subsidiary of StanCorp Financial Group, Inc.). Standard maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The interest crediting rate is reset quarterly and has a floor of 1.00%. The average yield earned by the fund was 3.07% in 2024 and 2.78% in 2023.

This contract is fully benefit-responsive and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time. Amounts may be transferred from the participant's account balance in the fund at any time.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution with a market value adjustment or an installment payout, at contract value, over a period of years. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan sponsor was not aware of any events that are probable of occurring that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

## 2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

**General** - The plan was established on January 1, 1993 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees that have reached 18 years of age are eligible to make elective deferral contributions and receive employer matching contributions immediately following their date of hire. For purposes of qualified nonelective contributions, an employee must be employed on the last day of the year to which the contribution relates. This requirement is waived upon death, disability or attainment of the normal retirement age during the year to which the contribution relates.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Upon meeting eligibility requirements, new employees are automatically enrolled in the plan and have 6% of their compensation withheld as elective deferral contributions. Participant deferral percentages automatically increase 1% each year until they reach a maximum of 15%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer Qualified Automatic Contribution Arrangement ("QACA") safe harbor matching contributions are made equal to 100% on the first 4% contributed by the employee and 50% on the next 2% contributed by the employee. Contributions are funded coinciding with each payroll with an annual true up contribution.
- d. Employer discretionary matching contributions may be made at the employer's discretion. No such contributions were made in 2024 or 2023.
- e. Employer nonelective contributions may be made at the employer's discretion. No such contributions were made in 2024 or 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of the employer's contributions. Participants are allowed to transfer funds between the various investment options on a daily basis and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants become fully vested in the employer QACA safe harbor matching contributions and related earnings after two years of service. Participants begin vesting in non-safe harbor employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Participants generally receive their distribution in the form of a single lump sum, partial withdrawals or installment payments. In-service withdrawals can commence upon attaining the age of 59½. Hardship withdrawals are permitted under the plan in certain circumstances.

**Forfeitures** - Forfeited nonvested accounts are used to pay certain administrative fees or to reduce the amount of the employer contributions. Forfeitures used to reduce employer QACA safe harbor matching contributions were \$58,000 in 2024 and \$44,000 in 2023. Unapplied forfeitures were \$3,000 and \$5,000 as of December 31, 2024 and 2023.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

**Notes receivable from participants** - Participants may obtain a loan from their account with approval of the plan administrator. Each participant may generally only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the total outstanding loan cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term generally cannot exceed five years unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through December 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### 3. PARTY-IN-INTEREST TRANSACTIONS

StanCorp Financial Group, Inc. and subsidiaries perform third party administration services and certain asset custodial services for the plan, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the plan for StanCorp Financial Group, Inc. services recorded as a component of administrative expenses in the accompanying statements of changes in net assets available for benefits were \$61,000 in 2024 and \$55,000 in 2023.

Charles Schwab provides certain administrative services to the plan pursuant to a services agreement between the plan sponsor and Charles Schwab. Charles Schwab receives revenue from mutual fund service providers for services Charles Schwab provides to the funds. The revenue is used to offset certain amounts that would otherwise be owed to Charles Schwab for its administrative services to the plan.

Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

### 5. INCOME TAX STATUS

The plan adopted a Standard Retirement Services, Inc. non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
