Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oak View Farms, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Oak View Farms, LLC (Company) 401(k) Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions. The plan became effective on September 1, 2016.

a. General

The plan is a defined contribution plan with 401(k) plan provisions covering all employees of Oak View Farms, LLC, Northeast Iowa Artificial Insemination, Inc., and Whole Oceans, LLC, except collective bargaining employees and non-resident aliens, who have attained age eighteen and have completed one thousand hours of service during a twelve-month period. An employee may become a participant in the plan on the first day of January or July following the date on which the employee meets the eligibility requirements. The plan is subject to the provisions of the Employee Retirement Income Security Tax Act of 1974 (ERISA).

In December of 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect.

b. Contributions

The Company matches 100% of the first 3% that employees contribute to the plan. Participants may elect to contribute any amount of their annual wages, except bonuses, as pre-tax or Roth deferrals as defined in the plan subject to the following limitations. The maximum amount an individual can contribute to the plan in any calendar year is limited to the applicable limit under the Internal Revenue Code Section 402(g). The maximum amount under the Internal Revenue Code Section 402(g) is \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The maximum catch-up contribution is \$7,500 for each of the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants can change their elective deferral contribution withholding rates each payroll period. Participants direct the investment of their contributions into various investment options offered by the plan.

c. Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's match, and an allocation of plan earnings. Forfeitures of terminated participants' non-vested accounts are used to reduce the Company's match and plan expenses. In addition, contract fee expenses are deducted from each participant's account. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

d. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 20% vested after one year of service, with an additional 20% vesting in each of the following years, becoming 100% vested after five years of credited service. Additionally, a participant shall be fully (100%) vested upon the earlier of their attainment of age sixty-five, death or disability while still employed.

e. Retirement, Disability and Death Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account balance or receive payment in a series of substantially equal periodic installments not to exceed the participant's life expectancy. If a participant dies prior to retirement or termination of employment, the amount due him/her will be paid to the participant's beneficiary in a lump sum amount or a series of substantially equal periodic installments as the beneficiary elects. The plan also provides for certain in-service withdrawals of vested account balances as defined in the plan.

2. Summary of Accounting Policies

a. Basis of Accounting

The financial statements of the plan are prepared under the accrual method of accounting.

b. Investment Valuation and Income Recognition

The plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments purchased and sold as well as held during the year.

c. Payments of Benefits

Benefits are recorded when paid.

d. Management Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

e. Administrative Expenses

Certain expenses of maintaining the plan are paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements. Fees related to processing benefit payments are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

f. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

g. Date of Management's Review

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

4. Fair Value Measurements

The fair value measure accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs include quoted prices for similar assets and liabilities in active markets, and level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when level 1 or level 2 inputs were not available. The plan had no level 2 or level 3 measurements for the periods presented and there were no changes in the methods used to measure fair value as of December 31, 2024 and 2023.

Accounting guidance on fair value measurements are classified and disclosed in the following category:

Level 1 Fair Value Measurements:

The fair value of mutual funds is based on quoted net asset values on the shares as reported by the fund. The mutual funds held by the plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the plan are considered to be actively traded.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

5. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. **Income Tax Status**

The non-standardized pre-approved plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the underlying non-standardized, pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the plan administrator and the plan's tax counsel believe that the plan is currently being designed and operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified, and the related trust is tax exempt.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,229 and \$6,139, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses.

8. **Related Party Transactions**

Certain plan investments are shares of mutual funds managed by American Funds. Capital Bank and Trust Company is the custodian of plan assets and Capital Research and Management Company is the record-keeper. The TPA Experts is the third-party plan administrator. Therefore, these transactions qualify as party-in-interest. Fees paid by the plan for administrative expenses, services and processing benefit payments amounted to \$7,795 and \$19,676 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the plan's operation.

Certain employees and officers of Oak View Farms, LLC 401(k) Plan, who may also be participating in the plan, perform administrative services to the plan. Oak View Farms, LLC 401(k) Plan does not charge fees for these administrative services to the plan.

9. **Risks and Uncertainties**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect each participant's account balances and the amounts reported in the statements of net assets available for benefits.
