INDEPENDENT AUDITORS' REPORT

To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Main Street Hospitality Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Main Street Hospitality Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Main Street Hospitality Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule of Assets (Held at Year End) as of December 31, 2024 and Delinquent Participant Contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN:

The following description of the Main Street Hospitality Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Lion House, LLC, Mohawk Hospitality, LLC, Main Street Hospitality, LLC, MSH Hammetts, LLC, MSH Providence, LLC, MSH Hampton Bays, LLC, Marshall & Main, LLC, and Lucky Sevens Hospitality, LLC (the "Companies") who have elected to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was restated effective January 1, 2022 with several amendments, the most significant being the change to a safe harbor plan with an employer safe harbor matching contribution equal to 100% of the first 3% and 50% of the next 2% for a maximum of 4%.

The Plan was amended effective July 1, 2022 to change the initial eligibility service requirement to one month, change the entry date to monthly, added a participating employer, Marshall & Main, LLC and ceased participating employers, Believers, LLC and Doers, LLC.

Administration of the Plan

Fitzpatrick Retail and Realty Company, Inc. (the "Company") is the plan sponsor and is responsible for the monitoring and administration of the Plan. Standard Retirement Services, Inc. ("Standard Retirement"), the Plan's third-party administrator, is responsible for the general administration of the Plan. Reliance Trust Company ("Reliance") and Standard Insurance Company ("Standard Insurance") serve as the asset custodians for the Plan.

Eligibility provisions

Eligible employees become participants in the Plan following attainment of age 18 and a total of three consecutive calendar months of service (one month of service effective July 1, 2022). Part time, temporary or seasonal employees are excluded unless one year of service (1,000 hours) is completed in any year of employment. The Plan's entry dates are the first of the Plan quarter (first day of the month effective July 1, 2022) coinciding with or next following the date in which the employee meets eligibility requirements.

Participants' accounts

Each participant's account is credited with the participant's voluntary contributions, the Company's contribution, Plan earnings (losses) and are charged with an allocation of administrative expenses. Allocations are based on participant account balances, participant earnings, compensation or transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN: (CONTINUED)

Notes receivable from participants

The provisions of the Plan allow participants to borrow a portion of their vested account balances. Borrowings may not exceed the lesser of \$50,000 or 50% of the vested account balance with a minimum loan of \$1,000. Loans shall bear a reasonable rate of interest commensurate with local prevailing rates, must be repaid ratably within 5 years, or a longer reasonable period of time if used to acquire a principal residence. Loans are secured by the balance in the participants' accounts and bear interest at 3.25% and 8.5%. Principal and interest is paid ratably through payroll deductions.

Contributions

The Plan provides for eligible employees to contribute up to the maximum limit allowable under the Internal Revenue Code. Pre-tax contributions are limited to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. The Plan allows for catch-up contributions (limited to \$7,500 for the years ended December 31, 2024 and 2023) for participants over age 50. Participants also have the option of making after tax Roth contributions to the Plan. Participants direct their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

The Plan allows employer safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% for a maximum of 4%. The Plan also provides for a discretionary profit-sharing contribution as determined by the Companies on an annual basis equal to a uniform percentage of a participant's salary deferrals. No discretionary profit sharing contributions were made for the years ended December 31, 2024 and 2023.

Vesting

Participants are immediately vested in their voluntary contributions and the employer safe harbor matching contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant must work 1,000 hours during each Plan year to earn a year of vesting service. A participant becomes 100% vested upon attainment of normal retirement age of 65, upon disability, death or after five years of credited service in the following increments:

Forfeited accounts

If a participant terminates employment at a time when the participant is less than 100% vested, the non-vested portion of employer contributions is forfeited. Forfeitures of terminated participants' nonvested accounts may be used to reduce administrative expenses or to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts were \$16,615 and \$13,673 respectively. For the years ended December 31, 2024 and 2023, no forfeitures were used to reduce employer contributions.

Payment of benefits

On termination of service, attainment of normal retirement age, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the participant's account or substantially equal installment payments. Additionally, upon termination of employment, participants may also receive installment payments for minimum required distributions. Distributions are subject to the applicable provisions of the Plan document. Hardship distributions are allowed if the participant satisfies certain conditions.

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (the "Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not to be made until the end of the first plan year beginning on or after January 1, 2026, however, plans must operate in accordance with effective date of each new provision.

Major provisions of this Act that may effect the Plan include:

- Effective January 1, 2024, the limit for mandatory cash outs was raised from \$5,000 to \$7,000.
- Effective January 1, 2025, further expansion of eligibility to long-term part-time workers, which will allow participation after two consecutive years of 500 or more hours.
- Effective January 1, 2026, catch up contributions for any participants over age 50 who earn over \$145,000 are now required to be made on a Roth basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Plan termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

Investment valuation and income recognition

Plan investments are stated at fair value with the exception of the fully-benefit responsive investment contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to fully-benefit responsive investment contracts. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and the insurance company. See Note 4 for further discussion of fair value measurements. All investments are participant directed.

In accordance with the policy of stating investments at fair value, the statements of changes in net assets available for benefits includes the net appreciation in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation on those investments.

Purchases and sales of securities are reflected on the trade date and gains and losses are determined on the basis of identified cost. Interest income is recorded as earned on the accrual basis and dividends are recorded on the ex-dividend date.

Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account.

Benefit payments

Benefit payments to participants are recorded when paid.

Plan expenses

Certain plan expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants or their beneficiaries are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes receivable from participants

Notes receivable from participants are recorded at their unpaid balance plus any accrued but unpaid interest. Since the participant's remaining vested investment balance is sufficient to cover the outstanding loan amount, there is no allowance for doubtful accounts at December 31, 2024 and 2023. Interest is calculated and included in the repayment terms of the loan when the loan is initiated and is recognized with the amortization of the loan as each payment is remitted. Loans are monitored for repayment under the original loan terms and defaulted when active participants cease payments past the allowed grace period. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. For terminated participants, once a distribution is requested, the outstanding loan balance will be netted against the remaining vested investment balance.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America and the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. INFORMATION CERTIFIED BY THE CUSTODIANS:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974. Accordingly, Reliance Trust Company and the Standard Insurance Company (the Standard), the custodians of the Plan, certified to the Plan administrator the fair value and physical custody of investments, participant loans and investment transactions to be complete and accurate as of December 31, 2024 and 2023, which are included in the Statements of Net Assets Available for Benefits, as well as dividend and interest income, net appreciation in the fair value of investments included in the Statements of Changes in Net Assets Available for Benefits for the years then ended and the information contained in Notes 4 and 5 concerning investments, and the information included in the Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS:

The Plan follows established guidelines for a fair value hierarchy that prioritizes the inputs used to measure fair value. An asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The hierarchy prioritizes the inputs into three broad levels as follows:

- Level 1 Quoted prices (unadjusted) in active markets for identical assets or liabilities. Market price is generally obtained from exchange or dealer markets.
- Level 2 Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Inputs are obtained from various sources including market participants, dealers and brokers.
- Level 3 Unobservable inputs that are supported by little or no market activity as they trade infrequently or not at all and that are significant to the fair value of the assets or liabilities.

4. FAIR VALUE MEASUREMENTS: (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued daily based upon the quoted market prices of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INVESTMENT CONTRACT:

Certain funds are invested in an insurance company general contract account, the Standard Stable Asset A Fund (a fully benefit-responsive contract), administered by The Standard. The funds are fully and unconditionally guaranteed by The Standard. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate was 3.04% and 2.78% for 2024 and 2023, respectively. Such interest rate is reviewed on a quarterly basis for resetting.

5. INVESTMENT CONTRACT: (CONTINUED)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are likely to not occur.

6. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS:

Standard Retirement is the third-party administrator of the Plan, therefore, fees paid by the Plan to Standard Retirement qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan to Standard Retirement for recordkeeping/administration, distribution and loan services amounted to \$15,713 and \$15,254, respectively. Investment management fees paid to the Standard and Reliance Trust are included in net appreciation in fair value of investments in the statements of changes in net assets.

Certain employees and officers of the Companies, who may also be participants in the Plan perform administrative services at no cost to the Plan.

7. TAX STATUS:

The Plan received an updated determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving this opinion letter. However, the Plan administrator and Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

During the year ended December 31, 2023, Plan management discovered an operational failure whereby three active employees were improperly forced out of the Plan. Plan management corrected this error and contributed the lost earnings during the year ended December 31, 2024. Plan management believes the final outcome of the correction process will not have a material impact on the Plan's financial statements or the Plan's qualified tax status.

7. TAX STATUS: (CONTINUED)

During the year ended December 31, 2023, Plan management discovered an operational failure whereby the Plan did not remit payroll contributions from one employee into the Plan for one payroll period, though it was withheld from the employee's paycheck. The corrective contribution of \$244, including lost earnings, was deposited to the Plan in September 2024. Plan management believes the final outcome of the correction process will not have a material impact on the Plan's financial statements or the Plan's qualified tax status.

During the year ended December 31, 2022, Plan management discovered an operational failure whereby the Plan did not update their employer matching contribution formula in accordance with the Plan amendment effective January 1, 2022. Through September 30, 2022, participants received the previous discretionary match of 50% of the first 4%, instead of the new employer safe harbor matching contribution equal to 100% of the first 3% and 50% of the next 2%, for a maximum of 4%. The corrective contribution of \$29,032, including lost earnings, was remitted to the Plan on December 23, 2022. Plan management also discovered that for one pay period in October 2022, three employees received the old discretionary match. Plan management corrected this error during the year ended December 31, 2023. Plan management believes the final outcome of the correction process will not have a material impact on the Plan's financial statements or the Plan's qualified tax status.

During the year ended December 31, 2022, Plan management discovered an operational failure whereby the Plan did not remit payroll contributions from one Company into the Plan, though it was withheld from the employee's paycheck. The error impacted only one employee and the missed contribution amount of \$274, including lost earnings, was remitted to the Plan in October 2023. Plan management believes the final outcome of the correction process will not have a material impact on the Plan's financial statements or the Plan's qualified tax status.

For the pay period January 7, 2022, Plan management discovered a systematic error whereby the Plan incorrectly did not withhold participant contributions and employer safe harbor matching contributions for all participants included in the January 7, 2022 pay period which is not in compliance with the Plan document. The corrective contribution of \$3,592, including lost earnings, was paid to the Plan on November 10, 2023. Plan management believes the final outcome of the correction process will not have a material impact on the Plan's financial statements or the Plan's qualified tax status.

During the year ended December 31, 2024, management discovered an operational failure whereby the Plan incorrectly calculated forfeitures for certain participants' non-vested account balances upon the distribution of the participants' balances. The incorrect 2024 forfeiture calculations amounted to \$1,032 and the Plan is in the process of correcting them. Plan management believes the final outcome of the correction process will not have a material impact on the Plan's financial statements or the Plan's qualified tax status.

8. RISKS AND UNCERTAINTIES:

The Plan provides for various investment fund options in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PROHIBITED TRANSACTIONS:

During the years ended December 31, 2023, the Company failed to remit certain participant contributions to the Plan totaling \$173,480 respectively, within the time period prescribed by the Department of Labor Regulations. Delays in remitting contributions to the Plan were due to procedural errors.

Lost earnings for the \$284,517 of contributions corrected during the 2020, 2021, 2022, and 2023 Plan years totaled approximately \$4,800 and were contributed to the Plan in the fourth quarter of 2023. Lost earnings for the \$63,841 of contributions were immaterial and were contributed to the Plan as of December 31, 2024.

10. SUBSEQUENT EVENTS:

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.
