Notes to Financial Statements

Note 1. Plan Description

The following description of F. Schumacher & Co. 401(k) Plan for Salaried Employees (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering all salaried employees (except union member employees and leased employees) of F. Schumacher & Co. (the Company, Employer or Plan Administrator) who have completed one hour of service. The Plan is administered by the Executive Retirement Committee of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute pretax annual compensation, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant's maximum annual pretax contribution in 2024 was limited to the Internal Revenue Service (IRS) cap of \$23,000 for participants under the age of 50 and \$30,500 for participants aged 50 and over. Participants may also contribute amounts representing rollovers from other qualified benefit plans. The employer may make discretionary matching contributions however, no employer matching contributions were made in 2024 or 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts and a collective trust fund as investment options for participants.

Participant accounts: Each participant's account is credited with the participant's contribution, Plan earnings, and certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their own contributions plus actual earnings thereon.

Notes receivable from participants: Participants may borrow from their participant account up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only two outstanding loans at a time. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.50% to 8.50%. Principal and interest are paid through monthly payroll deductions. Loans must be repaid within five years, unless the loan is taken for the purchase of a primary residence.

Payment of benefits: On termination of service due to death, disability or retirement, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants continuing employment subsequent to attaining the age of 73 (72 if they attained age 72 between January 1, 2020 and December 31, 2022; 70½ if they attained age 70½ before January 1, 2020) may elect to receive installment payments over their remaining life expectancy.

Note 2. Summary of Significant Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of accounting: The financial statements of the Plan are prepared using the accrual basis of accounting.

Contributions: Contributions from Plan participants are recorded in the year in which participant compensation is earned.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation in the fair value of investments are recognized in the financial statements in the periods in which such changes occur and includes gains and losses on investments bought and sold during the year, as well as held during the year.

Investments, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with these investments, it is reasonable that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable, if any, are recorded as a distribution based upon the terms of the Plan agreement.

Other income: The Trustee may receive revenue sharing payments from the mutual funds in which the Plan's assets are invested. The administrative services agreement between the Plan and the Trustee provides that to the extent that revenues sharing payments received by the Trustee exceeded administrative fees charged to the Plan by the Trustee, the excess will be credited to the Plan's forfeiture account and included in other income in the statement of changes in net assets available for benefits.

Benefit payments: Benefits are recorded when paid.

Administrative costs: Administrative costs of the Plan are paid by the Plan or the Company.

Subsequent events: The Plan evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 10, 2025, for these financial statements.

Note 3. Investment Information Certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the information provided to the Plan Administrator by the Trustee is complete and accurate.

Note 4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4. Fair Value Measurements (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Mutual funds are valued at the net asset value (NAV) of shares held by the Plan based upon unadjusted quoted market prices.

Collective trust fund: The collective trust fund is valued at NAV based upon units held by the Plan. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

Pooled separate accounts: Pooled separate accounts are valued at the NAV of shares held by the Plan at year-end, as provided by the Trustee. The NAV is not a publicly-quoted price in an active market. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Such Plan Sponsor-directed actions include, but are not limited to: (i) trustee or Plan Sponsor-directed reallocation of investments; (ii) Company-sponsored layoffs/termination of groups of employees; (iii) disposing of or selling a component of the business which involves the transfer or termination of employees; (iv) terminating the fund as an investment option of the Plan; and (v) terminating the Plan or participating trust.

Note 5. Exempt Party-in-Interest Transactions

Certain Plan investments in pooled separate accounts and collective trust funds are managed by an affiliate of the Plan's Trustee. If applicable, transactions related to these investments qualify as exempt party-in-interest transactions. Fees paid by the Plan for recordkeeping services, audit and consulting services amounted to approximately \$63,000 for the year ended December 31, 2024.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7. Tax Status

The Plan Sponsor has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of those investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
