In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of North Country Family Health Center 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to eligible employees of North Country Family Health Center, Inc. (the Center) who meet certain eligibility requirements. The Plan is administered by the Retirement Committee. Invesco Trust Company (Invesco) and Matrix Trust Company (Matrix) are the recordkeepers and custodians of the Plan's assets. CMFG Life Insurance Company (CMFG) is the insurance company and issuer of the stable value fund. CUNA Mutual Retirement Solutions (CUNA) is the Plan's advisor and third-party administrator. OneDigital Investment Advisors (OneDigital) is the consultant for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees of the Center are eligible to immediately begin salary deferrals pursuant to a properly completed and valid salary reduction agreement. Employees are eligible for the Center's contribution upon completing one year of service.

Contributions

Active participants may make voluntary contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (the Code) under Section 403(b). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Code. The Plan has auto-enrollment at 1% for new non-participating employees of the Center. In addition, there is an auto-increase of 1% for each year thereafter with a maximum of 8%.

The Center may make matching discretionary contributions to the Plan on behalf of eligible participants. The Center matched 100% of the voluntary contributions up to 3% of eligible participant compensation in 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Center's contributions and Plan earnings/losses on all contributions. Allocations of earnings/losses and administrative expenses are based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance.

Funding Vehicles

Plan contributions are invested in one or more of the funding vehicles offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants employed prior to October 31, 2016 are immediately vested in their account balance, which includes voluntary contributions, the Center's contributions, and actual earnings/losses thereon. Starting November 1, 2016, new participants are immediately vested in voluntary contributions and actual earnings/losses thereon. Employer contributions and actual earnings/losses thereon are subject to a five-year graded vesting schedule.

Notes Receivable from Participants

Participants are eligible for a loan with a minimum of \$1,000 and a maximum equal to the lesser of a) \$50,000 or b) one-half of the participant's vested account. The loan amount cannot exceed the maximum amount imposed by the Code. Loans are required to be repaid in a period not to exceed 5 years, unless used to purchase a primary residence, in which case repayment may be made over a reasonable period of time that may exceed 5 years. Total notes receivable from participants outstanding at December 31, 2024 and 2023 were \$31,322 and \$21,790, respectively.

Payment of Benefits

Vested funds are paid to participants when they retire, incur a long-term disability, or terminate employment with the Center. Benefits are paid out in a single lump sum or annuity contracts at the option of the participant.

Participants with account balances under \$7,000 have a mandatory distribution upon severance from employment.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined in the Plan, represents a forfeiture. Forfeitures are utilized to reduce the Center's matching contribution or to pay administrative expenses. There were no forfeited non-vested accounts at December 31, 2024 and 2023. Forfeited amounts were used to reduce the Center's matching contribution in 2024 and 2023.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investments

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Registered investment companies: Valued at the net asset value of shares held at year end based on quoted prices in active markets.

There were no changes in the valuation methodologies used during 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amount reported in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Allowance for Credit Losses

The Plan records a receivable for the employee and employer contributions that are remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant improvements or deteriorations are expected in the future economic conditions, therefore management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 or 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Notes receivable from participants are secured by their account balances and bear interest at rates ranging from 7.50% to 10.50%.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by participants. Management fees and operating expenses charged to the Plan for investments are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

4. STABLE VALUE FUND

The Plan is invested in a fully benefit-responsive investment contract with CMFG. CMFG maintains the contributions in a general account. The account is credited with earnings on the credited interest rate and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract guarantees an interest rate of 1%.

As described in Note 2, because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Although plan participants generally may withdraw assets from the stable value fund without restrictions, CMFG may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

5. FAIR VALUE MEASUREMENTS

6. TAX STATUS

The Plan is exempt from federal and state income tax under Section 403(b) of the Code. The Plan is required to operate in conformity with the Code to maintain its tax-exempt status for Plan participants. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

Transactions between Invesco, Matrix, CMFG, CUNA, OneDigital and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, participants are 100% vested in their accounts. All distributions would be made in accordance with any applicable requirements of ERISA and the Code.

9. RECONCILIATION TO FORM 5500

The classification of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 differs between these financial statements and Form 5500. However, the total change in net assets available for benefits for the years then ended agrees between these financial statements and Form 5500.

10. AMENDMENTS

During 2024, the Plan was amended to include that the period of service with Lowville Medical Associates, LLP would be counted towards the eligibility period for the Plan.

11. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
