### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the MedAmerica Health Systems Corporation 401(k) Savings and Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### Note 1 - Plan Description

The following description of the MedAmerica Health Systems Corporation 401(k) Savings and Investment Plan (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering certain employees of MedAmerica Health Systems Corporation (the Plan Sponsor) and several organizations that are affiliated with the Plan Sponsor (collectively, the Company or Employer). All employees who have attained the age of 18 are eligible to participate in the Plan, subject to certain exclusions, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Participants who have attained the age of 18 can contribute a portion of their compensation through pre-tax or Roth contributions to the Plan, up to the maximum allowed under the Plan and the Internal Revenue Code (IRC). The Plan was amended on December 11, 2023, to allow for Roth contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Participants who reach age 50 may elect to make catch-up contributions.

The Company makes matching contributions equal to 25 percent of the participant's contributions up to 6 percent of compensation deferred. Employees must attain the age of 18 and complete one year of service to be eligible for Company contributions to the Plan.

Newly eligible employees are automatically enrolled in the Plan at a deferral rate of 3 percent of compensation. Employees may opt out of the automatic enrollment at any time.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and allocations of the Company's matching contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in the participant accounts are participant directed.

**Vesting** – Participants are immediately 100 percent vested in employee salary and rollover contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants become fully vested in the Company's contributions after three years of service.

**Participant Notes Receivable** – Participants may borrow from their accounts subject to certain maximum and minimum amounts as prescribed in the Plan and in the IRC. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

**Benefit Payments** – Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Account balances less than the statutory limit are paid in a single lump sum upon termination without consent; however, participants have the option, when applicable to roll their vested account balances into a qualified account and avoid any premature distribution penalties. Participants may also make withdrawals of vested account balances prior to termination upon attainment of age 59 ½ or in the event of financial hardship, as defined by the Plan. The Plan allows for certain employees to receive their distribution as an annuity and for an in-service withdrawal option for employees who have attained age 62 and have vested money purchase plan benefits, as defined.

**Party-in-interest Transactions** – Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the qualified institution for the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines.

**Forfeitures** – If a participant is not fully vested on their termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions and pay plan administrative expenses. At December 31, 2024 and 2023, forfeited account balances totaled \$45,809 and \$69,020, respectively. During the years ended December 31, 2024 and 2023, \$38,982 and \$-0-, respectively, were used to reduce Company contributions. During the years ended December 31, 2024 and 2023, \$31,803 and \$50,691, respectively, were used to pay administrative expenses.

**Termination** – While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

**Basis of Accounting** – The accompanying financial statements are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and qualified institution.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Participant Notes Receivable** – Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

**Benefit Payments** – Benefits are recorded when paid.

**Administrative Expenses** – Certain administrative costs are paid by the Company and are excluded from these financial statements.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Risks and Uncertainties** – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events** – The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

#### Note 3 – Information Prepared and Certified by a Qualified Institution

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

#### Note 4 – Tax Status

The Plan adopted a pre-approved plan document which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### Note 5 – Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the inputs and valuation techniques used to measure fair value. Following are the three levels of the fair value hierarchy:

**Level 1** - Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2** - Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3** - Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances whereby inputs used to measure fair value fall into different levels in the above fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

**Participant directed brokerage accounts:** The accounts hold primarily cash, common stocks and mutual funds which are valued at daily closing prices and are deemed to be actively traded.

**Common collective trust funds:** The common collective trust funds are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practice expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 – Guaranteed Investment Contract**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company (Lincoln) totaling \$2,429,676 as of December 31, 2024 and \$2,996,251 as of December 31, 2023. Lincoln, the contract issuer, maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the contract issuer but may not be less than 1.7 percent. The interest rate is reviewed on a periodic basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin-offs of a subsidiary) which cause a significant withdrawal from the Plan, or (iv) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the contract issuer to modify the contract without mutual consent from the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the guaranteed investment contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.
