## 1. DESCRIPTION OF PLAN

The following description of the Lima Refining Company and Superior Refining Company LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

### A) General

The Plan is a defined contribution plan covering substantially all U.S. employees represented by a collective bargaining agreement of Lima Refining Company (“LRC”) and Superior Refining Company LLC (“SRC”), collectively the “Employer” upon completion of six months service. On February 28, 2023, with the acquisition of the remaining 50 percent interest in Ohio Refining Company LLC (“ORC”) by Husky Oil Toledo Company, all represented U.S. employees of ORC were immediately included in the Plan. The Plan excludes certain classes of employees as follows: a) non-resident aliens; b) leased employees; c) independent contractors; and d) non-union employees of LRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and became effective July 3, 2007.

The general administration of the Plan is the responsibility of the Employer (the “Plan Administrator”). Pursuant to the Plan’s trust agreement, an independent trustee maintains custody of the Plan’s assets. Vanguard Fiduciary Trust Company (“Vanguard” or the “Trustee”) serves as trustee of the Plan and Vanguard Group, Inc. serves as independent record keeper of the Plan.

The Plan offers a broad array of investment options across the risk/return, capitalization and style spectrum that allow participants to build portfolios consistent with their needs, objectives and risk profile.

### B) Contributions

Each year, participants may contribute up to 50 percent of their pre-tax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make additional contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. In 2024 and 2023, the Plan offered 23 registered investment companies and one common/collective trust fund as investment options for participants. For LRC employees, LRC makes a maximum contribution at 200 percent of the first three percent of compensation, as defined, that a participant contributes to the Plan plus 100 percent of the portion of such participant contributions that exceeds three percent but does not exceed six percent of compensation, as defined. For SRC employees, SRC makes a matching contribution at 100 percent of the first four percent of compensation, as defined, that a participant contributes to the Plan plus 50 percent of the portion of such participant contributions that equal but do not exceed six percent of compensation, as defined. For ORC employees, ORC makes a maximum contribution at 150 percent of the first four percent of compensation, as defined, that a participant contributes to the Plan plus 100 percent of the portion of such participant contributions that exceed three percent but does not exceed seven percent of compensation, as defined by the Plan document.

### C) Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Employer’s contributions and an allocation of Plan earnings. Allocations are based on participant’s earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### D) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer’s contribution portion of their accounts is based on years of continuous service, at 20 percent each year until fully vested after five years of credited service.

### E) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 reduced by their highest outstanding note balance on the date of the loan or 50 per of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at prime lending rate plus one percent. Principal and interest are paid ratably through payroll deductions each pay period. As at December 31, 2024, interest rates ranged from 4.25 percent to 9.50 percent and maturity dates ranged from January 2025 to April 2032. As at December 31, 2023, interest rates ranged from 4.25 percent to 9.50 percent and maturity dates ranged from January 2024 to April 2032. Deemed distributions from defaulted loans were \$nil in the year ended December 31, 2024 (2023 – \$12,963).

### F) Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum equal to the value of the participant's vested interest in their account or installments for a specified period not to exceed the participant's life or life expectancy (and a designated beneficiary). For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution less any applicable penalties if a certain age is not attained.

### G) Forfeited Accounts

Accounts forfeited by former unvested participants may be used to reduce future employer contributions. Recovery of forfeitures were \$13,678 in the year ended December 31, 2024 (2023 – \$41,412 of recovered forfeitures), which increased employer contributions. At December 31, 2024 the forfeiture carried forward balance was \$16,794 (December 31, 2023 – \$27,953).

### H) Asset Transfer In (Out)

From time to time, asset transfers occur between the Plan and the Company sponsored Cenovus Non-Represented 401(k) Plan due to the transfer of employees to or from represented and non-represented employment status. The transfer to the Cenovus Non-Represented 401(k) Plan was \$1,930,668 in the year ended December 31, 2024 (2023 – \$3,366,116).

### I) Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100 percent vested in their employer contributions.

## 2. SUMMARY OF ACCOUNTING POLICIES

---

The following accounting policies have been used in the preparation of the Plan's financial statements:

### A) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

### B) Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### C) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net changes in investments includes gains and losses on investments bought and sold or held during the year.

### D) Notes Receivable from Participants

Notes receivable from participants are valued at amortized cost. Amortized cost represents the unpaid principal balance plus unpaid accrued interest.

### E) Payment of Benefits

Benefits are recorded when paid.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of registered investment companies and units of the Vanguard Retirement Savings Trust III managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions. Fees of \$14,050 were paid to Vanguard by participants in the year ended December 31, 2024 (2023 – \$7,600).

### 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board, Accounting Standard Codification 820, “Fair Value Measurements and Disclosures”, establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three-level valuation hierarchy is based upon the transparency of inputs to the valuation of an asset as of the measurement date.

The three levels are defined as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology are observable for the asset (other than quoted prices included in Level 1), either directly or indirectly. Observable inputs are those that reflect the assumptions market participants would use in pricing the asset developed on market data obtained from sources independent of the Plan.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Unobservable inputs are those that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing the asset, developed based on the best information available in the circumstances.

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the Plan’s valuation methodologies for assets at fair value. Such valuation methodologies were applied to all of the assets carried at fair value.

#### **Registered Investment Companies**

Shares of registered investment companies are valued at the quoted net asset value on the measurement date. There are no restrictions on trading and the funds can be redeemed at fair market value at any time, therefore, the investments are classified within Level 1 of the valuation hierarchy.

#### **Stable Value Fund**

The stable value fund consists of Vanguard Retirement Savings Trust III Stable Value Fund which is composed primarily of non-fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The stable value fund is valued using the net asset value as a practical expedient and as such excluded from the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan’s valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

### 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Significant market disruptions, such as those caused by policies around tariffs, trade relations, global conflicts, pandemics, natural or environmental disasters, acts of terrorism, or other events, can adversely affect local and global markets and normal market operations. Any such disruptions could have an adverse impact on the value of the Plan's investments and the Plan's performance.

### 6. TAX STATUS

Management considers the Plan to be in compliance with Section 401(a) of the Internal Revenue Code of 1986, as amended (the "Code") and, accordingly, to be entitled to an exemption from federal income taxes under the provisions of Section 501(a) of the Code. An opinion letter dated March 31, 2014 has been received by Vanguard stating that the form of the prototype plan adopted by the Plan is acceptable under the Code Section 401 for use by employers for the benefit of their employees. The opinion letter, in effect, states that an employer who adopts the Plan will be considered to be qualified under the Code Section 401(a) provided all terms of the Plan are met and the Plan does not discriminate in favor of key or highly compensated employees. Therefore, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirement of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that is more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as at December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2017.

### 7. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, as trustee, has certified that all of the information provided is complete and accurate as at December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023. Information included in the accompanying financial statements and notes to financial statements as to investments, notes receivable from participants, dividend income, interest income, interest income on notes receivable from participants, net increase (decrease) in fair value of registered investment companies, investment balances disclosed in the fair value measurement table, excluding investment levels, and all information in the supplemental schedule is presented in reliance solely upon these certifications.
