Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Description of Plan

The following description of the Koos Manufacturing, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Koos Manufacturing, Inc., and AG Adriano Goldschmied, Inc., an affiliate related by common ownership (collectively the "Company" or "Plan Sponsor"), who are the age of twenty one or older and have completed twelve months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contribution - Each year participants may contribute up to the maximum amount allowed by the Plan and subject to certain limitation. However, the total contributions in any taxable year may not exceed the dollar limit of \$23,000 per taxable year 2024. Employees over the age of 50 is allowed to make additional "catch-up" contribution of \$7,500 in 2024.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Any employer contributions are subject to the following graded vesting schedule:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Years of service for vesting are counted from the inception of the plan. For vesting, the participants will be credited with a year of service for each plan year during which he or she earns credit for 1,000 hours of service. Moreover, no employer profit sharing contributions are subject to a vesting schedule.

Note 1 - Description of Plan (Continued)

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum that is equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. Participants are required to repay the loans through payroll deduction within 5 years unless the loan is used for the purchase of a principal residence. If the loan is used for the purchase of a principal residence, the Administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear a commercially reasonable rate of interest. If participants terminate employment, any remaining payments are due immediately.

As of December 31, 2024 and 2023, the outstanding participant loan balances were \$156,728 and \$141,395, respectively.

Top-Heavy Plan - When more than 60% of the plan assets are in the accounts of key employees, in any plan year, the plan is considered to be a top-heavy plan. In such case, non-key employees will be entitled to certain "top-heavy minimum benefits" and other special rules will apply. Among these top-heavy rules, the Company may be required to make contributions on behalf of the non-key employees in order to provide with at least "top-heavy minimum benefits."

Distribution of Benefits - The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of service, death, disability or retirement, a participant or beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment.

Participants may withdraw all or part of their vested account balance once they reach age 59^{1/2}. They may also withdraw any or part of their rollover contributions account in the Plan as well as any after-tax contributions held in their account in the Plan at any time and at any age.

In the event of financial hardship, participants can withdraw their own elective deferrals (excluding earnings on the elective deferrals) as well as any vested matching contributions if they satisfy certain conditions under the Plan.

Forfeited Accounts - Forfeitures will be used first to restore previously forfeited account balance of returning participants who are entitled. Remaining forfeitures will be used to reduce any employer contributions and may also be used to pay plan expenses. During 2024, \$33,935 was used to reduce the employer contributions.

Termination of the Plan - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

The accounting and reporting policies of the Plan conform to accounting principles generally accepted in the United States of America (US GAAP).

Basis of Accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Accounting Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition - All investments are carried at fair value or an approximation of fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes Plan's gain and losses on investment bought and sold as well as held at year end. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits - The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan, but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Plan Administrative Expenses - Cost of administration of the plan is generally charged to the employer and the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Recently Issued Accounting Standard - In August 2018, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2018-13, Fair Value Measurement (Topic 820) Disclosure Framework Changes to the Disclosure Requirements for Fair Value Measurement. ASU 2018-13 improved and simplifies the disclosure requirements for fair value measurements. Plan management adopted ASU 2018-13 effective January 1, 2020; its adoption did not have a material impact on the Plan's financial statements.

Note 3 - Unaudited Information - Certified Investments and Notes Receivable from Participants

The Plan's investments were held by Principal Life Insurance Company, the Plan's trustee as of and for the year ended December 31, 2024. All investments are participant-directed.

All investment information disclosed in the accompanying financial statements and supplemental schedule (Schedule H, Line 4i) including investments held at December 31, 2024, and net realized and unrealized appreciation or depreciation in fair value of investments, dividends, interest, and other income for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Plan's trustee.

These information have not been audited by the independent auditors.

Note 4 - Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value as it related to financial assets and liabilities and to nonfinancial assets and liabilities measured at fair value on a recurring basis. Such framework provides fair value three-level valuation hierarchy based on upon observable and unobservable inputs with preference given to observable inputs.

The three levels of the fair value hierarchy under ASC 820-10 are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices in markets that are not active, quoted prices for similar assets, or other inputs that are observable, either directly or indirectly, for substantially the full term of the asset.

Level 3 - Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The Plan used the following methods and assumptions in estimating the fair values disclosure for financial instruments:

Mutual funds - The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Note 5 - Income Tax Status

The Plan document is a volume submitter that the Company adopted with specific provisions customized to meet the needs of the sponsor and the participants. The volume submitter has received a favorable opinion letter from the Internal Revenue Service that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees.

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 - Party-In-Interest Transactions

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain Plan investments in registered investment companies are managed by the custodian of the Plan. Purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants held by the Plan are considered party-in-interest transactions.

Note 8 - Subsequent Events

Plan management has evaluated all subsequent events for recognition and disclosure through October 3, 2025, which is the date the financial statements were available to be issued.
