Because of the significance of the matters described in the Basis for Disclaimer of Opinion section, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

## **1. DESCRIPTION OF PLAN:**

The following description of the Saint Ursula Academy of Cincinnati, Inc. 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of Plan provisions.

### **General**

The Plan is a defined contribution plan created under Internal Revenue Code (IRC) section 403(b), covering substantially all employees of Saint Ursula Academy ("Sponsor" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Subject to certain limits, participants may contribute a portion of their compensation to the Plan upon hire. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Sponsor contributes to eligible participants who have attained age 21 and two years of service, an amount equal to 6% of eligible compensation under the Plan. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

### **Participant accounts**

Each participant's account is credited with the participant's contribution and, if eligible, an allocation of the Sponsor contribution, and an allocation of Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. A participant is 100% vested in all Sponsor contributions and earnings received thereon.

### **Plan loans**

Participants with funds held in an elective deferral account may obtain plan loans for a minimum of \$1,000 up to a maximum of \$50,000, subject to limitations based on the balance in the participant's account. Such loans are obtained directly from TIAA-CREF and are collateralized by a portion of the participant's account balance. Upon execution of the loan, 110% of the loan amount will be set aside into the TIAA Traditional Annuity as collateral on the loan. Loan payments are made directly by the participant to TIAA-CREF. Defaults are determined in accordance with the terms of the plan loan agreement. Upon default, the plan loan becomes taxable to the participant; however, the collateral remains in the participant's account until the participant reaches a distributable event such as retirement or termination. Plan loans outstanding at December 31, 2024 and 2023 were \$54,984 and \$52,174, respectively.

### **Participant loans**

The Plan also allows participants to borrow from their vested fund accounts in accordance with the participant loan provisions of the Plan. The notes receivable are secured by the balance in the participant's account. The interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

### **Payment of benefits**

Upon termination of service, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, partial payment, installment payments or annuity payments. Normal retirement age is 65 years. In the event of a participant's death, any remaining balance will be paid to designated beneficiaries.

In-service distributions are permissible from the Plan for participants that have obtained the age of 59 and 1/2. Participants electing in-service distributions may elect to receive all or a portion of their elective deferrals in a lump sum payment. Hardship withdrawals are permitted in accordance with the Plan document.

The Plan allows cash-out distribution of an individual account for a participant who incurs a severance from employment and has less than \$5,000 in his or her individual account.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

The following are the significant accounting policies of the Plan:

### **Basis of accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of estimates**

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment valuation and income recognition**

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of benefits**

Benefits are recorded when paid.

### **Administrative expenses**

The Sponsor pays most Plan administrative expenses and such expenses are excluded from these financial statements. If the Sponsor does not pay such expenses, the qualified institutions shall pay them from the Plan assets. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

### **Subsequent events**

The Plan evaluates events subsequent through October 6, 2025, the date the financial statements were available to be issued.

## **3. CERTIFIED INVESTMENT INFORMATION:**

Certain information in the accompanying financial statements and ERISA required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA-CREF), qualified institutions.

#### 4. INVESTMENTS:

The Plan has investment contracts with the TIAA-CREF through CREF Group Retirement Unit-Annuity. Contributions may be deposited into the insurance companies' general accounts under unallocated investment contracts, a pooled separate account or registered investment companies. The insurance company is contractually obligated to repay the principal and a specified interest rate for contributions deposited into their general accounts. A portion of the unallocated insurance contracts have surrender charges and other restrictions on withdrawals, and are therefore, not considered to be fully benefit-responsive. The remaining portion of the unallocated insurance contracts do not have restrictions on withdrawals and are considered fully benefit-responsive. The pooled separate account is credited with the actual earnings of the underlying investments and charged for plan withdrawals and administrative expenses.

#### 5. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2            Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Include mutual funds which have readily determinable market values and CREF variable annuity accounts, which do not have readily determinable market values. The Plan, as permitted by accounting principles generally accepted in the United States of America, has valued the CREF investments based on the net asset value reported by the investment manager as a practical expedient, which is based on the underlying securities. These securities generally consist of assets with readily determinable market values such as common stocks, corporate obligations and government securities.

*Unallocated insurance contracts:* Unallocated insurance contracts that are not considered fully benefit-responsive are valued at fair value, which equals cash contributions plus interest credited to the Plan's contracts, less any withdrawals and fees. The insurance company has represented that contract value approximates fair value due to current crediting rates being comparable to those of similar investments. Interest is credited daily at an interest rate that will not be less than the guaranteed minimum interest rate. The interest crediting rate is declared on a quarterly basis. In determining the reasonableness of the methodology, the Plan Committee evaluates a variety of factors, including a review of the existing contract, economic conditions and overall credit ratings.

*Pooled separate account:* The TIAA Real Estate Account is valued at net asset value. The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value of the TIAA Real Estate Account is determined by the investment manager using standard valuation techniques such as independent appraisals for real estate projects and discounted cash flows analysis for debt securities that consider various factors including interest rates and the credit quality of the counterparty. Transfers are limited to one per calendar quarter.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS:**

Funds invested in the TIAA Traditional Annuity under group supplemental retirement unit-annuities (GSRA) and supplemental retirement annuities (SRA) are considered fully benefit-responsive. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA-CREF is contractually obligated to repay the principal and a specified interest rate that is guaranteed under the contract.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment contracts do not permit TIAA-CREF to terminate the agreement prior to the scheduled maturity date.

Funds invested in the TIAA Traditional Annuity under group retirement annuities (GRA) are not considered to be fully benefit-responsive due to surrender charges and withdrawal restrictions. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because this investment is not fully benefit-responsive, it is reported at fair value and is included in Note 5.

**7. RELATED PARTY TRANSACTIONS:**

Certain plan investments are managed by TIAA-CREF, the qualified institutions as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan Sponsor pays directly fees related to the Plan's operations.

**8. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**9. TAX STATUS:**

The Plan Sponsor adopted a volume submitter 403(b) Plan with TIAA-CREF which received a favorable opinion letter from the Internal Revenue Service (IRS) dated August 7, 2017. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Sponsor has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**10. CONTRACTS EXCLUDED FROM INVESTMENTS:**

As permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*, the Plan has elected to omit certain contracts from the investment balance reported on the Form 5500. These contracts were created prior to January 1, 2009 and contain fully vested, participant-directed investment accounts. These accounts are owned by the individual participants for whom the accounts were initially established, and the Plan no longer has any obligation to such accounts. If the identified contracts, as reported by the qualified institutions, were included, net assets available for benefits would increase by approximately \$710,000 and \$729,000 as of December 31, 2024 and 2023, respectively. Investment income of approximately \$86,000 and distributions of approximately \$105,000 related to such accounts, as identified by the qualified institutions, have also been excluded in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**11. RISKS AND UNCERTAINTIES:**

Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
