**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Robert R. McCormick Foundations Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

**Basis for opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE 1 - PLAN DESCRIPTION**

The Robert R. McCormick Foundations (the “Foundations”) are the sponsors for the Robert R. McCormick Foundations Defined Contribution Plan (the “Plan”). The Foundations include the Robert R. McCormick Foundation and the Cantigny Foundation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan, which covers all employees of the Foundations who have completed at least 1,000 hours of service during their first 12 months of employment or any Plan year thereafter.

Employee contributions to the Plan are not permitted. Loans from the Plan are not permitted. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

***Plan Administration***

Ongoing administration of the Plan is performed by the Retirement Plan Committee (the “Committee”), which is appointed by the Foundations. The Committee is responsible for the management and control of the Plan’s assets and has certain discretionary authority and control over such assets.

***Contributions***

The Foundations’ Plan contributions are calculated and funded on an annual basis. Contributions in 2024 are equal to 8% of each participant’s annual compensation. Participants can direct their contributions into their choice of various Principal Trust Company (Principal) investment options.

***Participant Accounts***

Each participant’s account is credited with the allocations of (i) the Foundations’ contribution and (ii) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

All participants are vested in equal percentages over a three-year period.

***Forfeitures***

As of December 31, 2024 and 2023, forfeited nonvested accounts were approximately \$9,000 and \$0, respectively. Forfeitures utilized from the forfeited, nonvested accounts during the year ended December 31, 2024, were approximately \$15,000, and were used to pay administrative expenses. Nonvested forfeited benefits are maintained by the trustee and used to reduce future employer contributions or pay administrative expenses.

***Retirement Benefits***

Employee participants may elect early retirement between the ages of 55 and 65. Normal retirement is age 65. Benefits are paid as elected at any time after the retired participant has attained age 55. Mandatory benefit payments will be made to retired participants who have attained age 73 and have previously elected not to receive benefits upon reaching normal retirement age. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**December 31, 2024 and 2023**

The payment of vested benefits due to retirement, disability, death or termination of employment will be made at the election of the participant, or in case of death, at the election of his or her designated beneficiary. Per the Plan, if a terminated participant's vested benefit is not greater than \$7,000, the participant is paid a lump-sum distribution as soon as administratively feasible after the participant's separation from employment. The Foundations have elected to allow the participant to elect a rollover distribution of the vested benefit amounts.

***Administrative Expenses***

Certain expenses incurred in the administration of the Plan are paid directly by the Foundations.

***Plan Termination***

The Foundations retain the right to terminate the Plan at any time. In the event of dissolution, merger, consolidation or reorganization of the Foundations, the Plan shall terminate. The liquidation of Plan assets at the time of its termination shall be directed by the Committee and shall include the payment of benefits to applicable participants in accordance with ERISA. All participant accounts are 100% vested upon termination of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared using the modified cash basis of accounting. Accordingly, the Plan's transactions are reported on the basis of cash receipts and cash disbursements, except for accrued income and the fair value reporting of investments held by the trustee. Had the financial statements been prepared using the accrual basis of accounting, employer contributions receivable at December 31, 2024 and 2023, would be approximately \$888,000 and \$872,000, respectively.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

The Plan's investments in mutual funds are stated at fair value based on quoted market prices as reported to the Plan by the trustee, Principal. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on the trade date.

The Plan's investment in the Principal Guaranteed Option, which is a fully benefit responsive investment contract, is reported at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the custodian, is the aggregation of contributions, plus interest, less withdrawals, if any.

***Net Appreciation in Fair Value of Investments***

Net realized and unrealized appreciation is reported in the accompanying financial statements as net appreciation in fair value of mutual funds.

***Distributions***

Distributions are recorded when paid.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and at contract value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Plan investments are valued using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY**

Plan assets include a fully benefit responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. Due to the nature of these contracts, they do not have specific underlying assets assigned. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 - INCOME TAX STATUS**

The Plan is a Non-standardized Prototype Profit Sharing Plan (Prototype Plan) sponsored by Principal Life Insurance Company and adopted by the Foundations. The Prototype Plan obtained its latest opinion letter June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not requested its own determination letter from the IRS. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state and local taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by Principal, the Plan's trustee. Therefore, these transactions qualify as party-in-interest transactions.

**NOTE 9 - SUBSEQUENT EVENTS**

The Foundations evaluated the Plan's December 31, 2024, financial statements for subsequent events through October 8, 2025, the date the financial statements were available to be issued. No events require recognition or disclosure in the financial statements.
