Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Hear.com 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following description of the Hear.Com 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was established on April 1, 2021. The Plan is a defined contribution plan covering substantially all employees of Hear.com (the “Company” or the “Employer”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”) and is administered by the Company.

Eligibility

Employees of the Company are eligible to participate in the Plan immediately upon their date of employment. Employees are eligible to receive non-elective contributions as soon as they become eligible to participate in the Plan. Effective January 1, 2023, employees are eligible to receive matching contributions if they have six months of service in the Plan year. In addition, any part-time, seasonal, and temporary employees who work less than 1,000 hours of service in the Plan year, and any union, leased, Puerto Rico employees and nonresident aliens, are excluded from eligibility to the Plan.

Contributions

The Plan provides each participant with an opportunity to make elective deferrals, after-tax contributions, and Roth contributions to the Plan, subject to the limitations of the Internal Revenue Code. Employees are automatically enrolled at a 3% pre-tax deferral percentage, unless the employee elects not to participate in the Plan. Employees auto enrolled in the Plan are subject to an annual auto escalation of 1% on the first day of each plan year, unless the employee makes a contrary election. The automatic escalation cannot increase an employee’s pre-tax deferral rate higher than a maximum rate of 10%.

Effective January 1, 2023, the Company is required to make a matching contribution equal to the lesser of 50% of a participant’s contributions up to 6% of eligible compensation or \$2,000. The Company may choose to make an annual non-elective contribution to the Plan. In order to receive any non-elective contribution, a participant must be employed on the last day of the plan year and must have at least 1,000 hours of service in the plan year. The Company did not make a non-elective contribution in 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the custodians as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their own contributions and earnings thereon. For non-elective employer contributions, participants vest 40% after two years of service and an additional 20% each subsequent year until fully vested after completing five years of service. For employer matching contributions, participants vest 20% for every year of service until fully vested after completing five years of service.

Forfeitures

The portion of a participant’s balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. The Plan provides for terminated employees who resume employment within one year to have any forfeited amounts reinstated (“reinstatement period”). Forfeitures may be used to pay plan expenses,

reduce employer contributions for the plan year, or reallocate to the other participants as additional employer contributions. Any remaining amount thereafter shall be applied toward succeeding plan years until fully utilized. Forfeitures from employees for the year ended December 31, 2024 were approximately \$42,000. Forfeitures used to pay expenses in 2024 were approximately \$21,000. At December 31, 2024 and 2023, the available forfeiture balance was approximately \$43,000 and \$22,000, respectively.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance incurred during the 12-month period ending on the day before the date on which the loan was made or 50% of their vested account balance. A participant may have up to two loans outstanding at a time. Loan repayment terms are not to exceed five years or thirty years if the loan is for the purchase of a primary residence. Loans are repaid through payroll deductions and are monitored by the plan administrator. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. As of December 31, 2024, the interest rates on the outstanding loans range from 4.25% to 9.50%.

Benefits

Upon termination, death, disability, or retirement, vested plan benefits will be distributed to a participant or his/her beneficiary either in a lump-sum distribution or annuity payments. In addition, the Plan provides for participant withdrawals from their individual accounts pursuant to specific guidelines as set forth in the plan document.

Administrative Expenses

All transaction fees for loan and distribution requests are paid from participants' accounts. Substantially all other administrative expenses are paid from participants' accounts (see Note 5), otherwise they are to be paid by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at either fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. See Note 3 for discussion of contract value measurements.

The sales and purchases of investment securities, and gains and losses on the sale of investments, are recognized at the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Information Certified by the Plan Custodian

The following is a summary of the investments, notes receivable from participants, non-interest and interest bearing cash regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, in the Plan's financial statements and supplemental schedule, that was prepared or derived from information provided by the State Street Bank and Trust Company, the custodian of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that such information is complete and accurate.

Investment Contract with Insurance Company

The Plan is party to an investment contract with Prudential Retirement Insurance and Annuity Company ("Prudential") whereby allocated contributions are maintained in a Guaranteed Interest Account ("GIA"). The contract is included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses), because it is fully-benefit responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Prudential. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with

another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under the *Employee Retirement Income Security Act of 1974*. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed interest account does not permit Prudential to terminate the agreement prior to the scheduled maturity date.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies:

Mutual funds: Valued at unadjusted quoted prices in an active market at year-end.

Self-directed brokerage accounts: Self-directed brokerage accounts include mutual funds, common stock, exchange trade funds, unit investments trusts, and money market funds, which are all valued at quoted prices in an active market of the underlying investments held by the Plan at year-end.

Interest bearing cash: Book value equals fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-In-Interest Transactions

Transamerica Retirement Solutions (“Transamerica”) is the record keeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Transamerica were \$55,318 for the year ended December 31, 2024.

Transamerica and the Employer have an agreement whereby participants are charged a fee in proportion to their account balance, which is credited to the expense budget account. This amount can be used to pay for ERISA qualified plan expenses or allocated to participants at the end of the year. For the year ended December 31, 2024, \$2,253 was charged to participants. The balance available to pay future expenses was \$5,792 and \$ 3,392 as of December 31, 2024 and 2023 respectively.

Note 6. Tax Status

On June 30, 2020, the Internal Revenue Service (“IRS”) stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself, and has been amended since receiving the determination letter, however, the Plan’s management believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants’ account balances and the value of investments reported in the financial statements.

Note 8. Plan Termination

Although the Company has not expressed any intention to do so, it has the right to terminate the Plan in whole or in part at any time subject to the provisions set forth in ERISA. Upon termination, all participants become fully vested in their individual accounts.
