### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Crown Bakeries Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Basis for Opinion**

**NOTE A | DESCRIPTION OF PLAN**

The following description of Crown Bakeries Retirement Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*1. General*

The Plan, established on February 1, 2000, is a defined contribution (salary-deferral) plan for eligible employees of Crown Bakeries, LLC and its related entities. Employees become eligible upon reaching age 18 and completing two consecutive months of service. Collectively bargained employees, leased employees, nonresident aliens, and independent contractors are excluded. The Plan was formally known as the Bun Company Retirement Plan and was amended effective March 1, 2021 formally changing the name of the Plan to Crown Bakeries Retirement Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In 2022, the Plan Sponsor acquired two additional bakeries. The assets from the former plans were merged into the Plan.

*2. Contributions*

Each year, participants may contribute up to the maximum dollar amount as determined by the Federal government of pre-tax or post-tax (Roth contribution) annual compensation, as defined in the Plan document. The maximum deferral in 2024 and 2023, was \$ 23,000 and \$ 22,500, respectively, with the option of an additional catch-up deferral for those 50 years of age or over of \$ 7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company has adopted a safe harbor enhanced matching contribution provision. For eligible employees, the employer contributions are equal to the first 5% of wages deferred by the eligible employee. The employer may also elect to make discretionary qualified nonelective contributions and matching contributions. Participants are eligible for the discretionary employer contribution if they are employed on the last day of the plan year and complete at least 1,000 hours of service during that year. The last-day and hours requirements are waived for participants who terminate employment due to disability or who retire on or after normal retirement age.

**NOTE A | DESCRIPTION OF PLAN**

*3. Participant Accounts*

Each participant's account is credited with the participant's voluntary contributions and an allocation of the Company contribution(s), Plan expenses and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

*4. Notes Receivable from Participants*

Participants may borrow from their participant account a maximum amount equal to the lesser of 50% of the participants' vested account balances or \$ 50,000. Participants may only have one loan at a time, and participant notes made from the Plan generally have a term no longer than five years from the date of the loan. Participant notes are secured by the balance in the participants' accounts and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator.

*5. Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon and in the employer's safe harbor matching contribution and discretionary employer contributions and earnings thereon.

*6. Investments*

Upon enrollment in the Plan, a participant may direct contributions to selected investments as made available and determined by the Plan trustee. Participants may change their investment options at any time pursuant to procedures established in the Plan document.

*7. Payment of Benefits*

Retiring participants, participants leaving the employment of the Company due to disabling illness or injury and participants whose employment is terminated prior to retirement, or death will receive the vested balance in their individual account in a lump-sum payout, IRA rollover, or conversion to another qualified plan, or in installment distributions over a specified period not to exceed the life or life expectancy of the participant. Upon death, a participant's account is paid in a lump sum to the designated beneficiary. The Plan also allows for in-service distributions after participants have reached age 59 ½ and, under certain circumstances, participants may receive a hardship distribution.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

*1. Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*2. Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*3. Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan committee determines the valuation policies utilizing information provided by the investment advisors, custodians and trustees. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*4. Payment of Benefits*

Benefit payments are recorded when paid.

*5. Notes Receivable from Participants*

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

6. *Expenses*

Fees incurred in administering the Plan may be paid by the Plan or the Company. Fees paid by the Plan for investment management services were included as a reduction of the return earned by each fund.

7. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 9, 2025, which is the date the financial statements were available to be issued. Through October 9, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE C | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE C | FAIR VALUE MEASUREMENTS**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E | PLAN TERMINATION**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of partial or total Plan termination, participants will be entitled to the full amount in their accounts as of the date of termination.

**NOTE F | TAX STATUS**

The Plan is intended to be qualified under Section 401(a) and tax exempt under Section 501(a) of the Internal Revenue Code (IRC). The Plan is a non-standardized pre-approved profit sharing plan with CODA and obtained its last approval letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since this date, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G | RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan holds units of mutual funds issued by Vanguard. Vanguard is the Plan custodian, therefore, these transactions qualify as party-in-interest transactions.

**NOTE H | PLAN ADMINISTRATION EXPENSES**

Under the Plan document, administrative expenses related to the operation of the Plan and the investment of Plan assets may be paid either by the Company or from Plan assets. To the extent such expenses are not paid by the Company, they are charged to participant accounts either (i) pro rata based on account balances or (ii) as per-participant (flat) charges, as applicable.

**NOTE I | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
