### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brown Stove Works, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brown Stove Works, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

# Notes to Financial Statements

## NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Brown Stove Works, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution employee benefit plan covering substantially all employees of Brown Stove Works, Inc. (the Company) who have attained age 21 and completed one year of service. Employees may become participants in the Plan on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or following the date eligibility requirements are met. Each plan year begins on January 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

The Plan is a contributory plan whereby an employee who elects to participate may contribute a minimum of 1 percent up to a maximum of 20 percent of their annual compensation as defined by the Plan; however, the total deferral in any plan year may not exceed statutory limits. The Company may contribute a matching contribution equal to a discretionary percentage of the participant's salary deferrals. The matching percentage is determined by the Company each year. For 2024 and 2023, Company matching contributions were equal to 100 percent of eligible contributions made by a participant up to a maximum of 6 percent of the participant's eligible compensation.

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. The Plan adopted Accounting Standards Codification (ASC) 326, *Financial Instruments - Credit Losses*, effective January 1, 2023, using the modified retrospective method. In accordance with ASC 326, no allowance for credit losses has been recorded as of December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's contribution, if any, and an allocation of fund earnings and administrative expenses. Fund earnings and administrative expenses are allocated based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the total amount that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed. Participant loans are not permitted by the Plan.

### Vesting

Participants are immediately vested in their salary deferrals plus actual earnings thereon. Participants are fully vested in the Company's matching contribution portion of their accounts upon reaching age 62, upon death, or upon permanent disability. Otherwise, vesting in amounts attributable to the Company's matching contribution portion is determined under the following schedule and is based on years of credited service. A year of credited service is earned for each year in which at least 1,000 hours of service have been performed for the employer.

## NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

### Payment of Benefits

The Plan provides that a participant may begin receiving normal retirement benefits upon attaining age 62. If a participant's employment is terminated, the participant is entitled to receive all of his or her vested contributions and earnings thereon. The Plan also allows certain hardship distributions prior to retirement. Distributions may be made as lump-sum distributions or as equal installments.

### Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to pay administrative expenses or reduce Company contributions to the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51,145 and \$41,621, respectively. For 2024 and 2023, no forfeitures were used to pay administrative expenses or reduce Company contributions.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The policies that materially affect net assets available for benefits and changes in net assets available for benefits are summarized as follows:

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

Management performed an evaluation of subsequent events through October 2, 2025, the date these financial statements were available to be issued.

### NOTE 3. INVESTMENTS

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard Fiduciary Trust Company, the Trustee of the Plan, except for comparing such amounts to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the Trustee that the following information is complete and accurate.

### NOTE 4. TAX STATUS OF THE PLAN

The Company has adopted a Prototype Non-Standardized Safe Harbor Profit Sharing Plan with CODA document with a restatement effective date of January 1, 2021. The prototype plan sponsor has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been modified since receiving the favorable opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

### NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

All of the Plan's investments are managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than as a direct payment. The Plan also made direct payments of \$1,013 and \$1,050 in 2024 and 2023, respectively, to the third party administrator which was not covered by revenue sharing.

### NOTE 7. PLAN TERMINATION PROVISIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their account balances.

## NOTE 8. FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/collective trust fund:* A collective investment trust that is composed primarily of fully benefit-responsive investment contracts valued at the net asset value (NAV) of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan may permit shares of the trust to be exchanged on behalf of participating employees only for investments in non-competing options available under the Plan. Any such asset exchange must remain in non-competing options for a minimum of 90 days before any exchange of such assets to a competing option, as defined by the investment contract, available under the Plan is permitted. Additionally, during January of each year, the Plan shall not permit more than the greater of \$500 or 25% of the shares of the trust to be exchanged on behalf of participating employees for investment in any competing option available under the Plan. There are no other participant or Plan redemption restrictions or unfunded commitments for these investments.

*Money market fund:* Valued at the NAV of units of the money market fund. The NAV is calculated by subtracting liabilities from the value of the fund's total assets and dividing it by the number of fund shares outstanding.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brown Stove Works, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brown Stove Works, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

# Notes to Financial Statements

## NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Brown Stove Works, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution employee benefit plan covering substantially all employees of Brown Stove Works, Inc. (the Company) who have attained age 21 and completed one year of service. Employees may become participants in the Plan on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or following the date eligibility requirements are met. Each plan year begins on January 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

The Plan is a contributory plan whereby an employee who elects to participate may contribute a minimum of 1 percent up to a maximum of 20 percent of their annual compensation as defined by the Plan; however, the total deferral in any plan year may not exceed statutory limits. The Company may contribute a matching contribution equal to a discretionary percentage of the participant's salary deferrals. The matching percentage is determined by the Company each year. For 2024 and 2023, Company matching contributions were equal to 100 percent of eligible contributions made by a participant up to a maximum of 6 percent of the participant's eligible compensation.

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. The Plan adopted Accounting Standards Codification (ASC) 326, *Financial Instruments - Credit Losses*, effective January 1, 2023, using the modified retrospective method. In accordance with ASC 326, no allowance for credit losses has been recorded as of December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's contribution, if any, and an allocation of fund earnings and administrative expenses. Fund earnings and administrative expenses are allocated based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the total amount that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed. Participant loans are not permitted by the Plan.

### Vesting

Participants are immediately vested in their salary deferrals plus actual earnings thereon. Participants are fully vested in the Company's matching contribution portion of their accounts upon reaching age 62, upon death, or upon permanent disability. Otherwise, vesting in amounts attributable to the Company's matching contribution portion is determined under the following schedule and is based on years of credited service. A year of credited service is earned for each year in which at least 1,000 hours of service have been performed for the employer.

## NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

### Payment of Benefits

The Plan provides that a participant may begin receiving normal retirement benefits upon attaining age 62. If a participant's employment is terminated, the participant is entitled to receive all of his or her vested contributions and earnings thereon. The Plan also allows certain hardship distributions prior to retirement. Distributions may be made as lump-sum distributions or as equal installments.

### Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to pay administrative expenses or reduce Company contributions to the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51,145 and \$41,621, respectively. For 2024 and 2023, no forfeitures were used to pay administrative expenses or reduce Company contributions.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The policies that materially affect net assets available for benefits and changes in net assets available for benefits are summarized as follows:

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

Management performed an evaluation of subsequent events through October 2, 2025, the date these financial statements were available to be issued.

### NOTE 3. INVESTMENTS

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard Fiduciary Trust Company, the Trustee of the Plan, except for comparing such amounts to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the Trustee that the following information is complete and accurate.

### NOTE 4. TAX STATUS OF THE PLAN

The Company has adopted a Prototype Non-Standardized Safe Harbor Profit Sharing Plan with CODA document with a restatement effective date of January 1, 2021. The prototype plan sponsor has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been modified since receiving the favorable opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

### NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

All of the Plan's investments are managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than as a direct payment. The Plan also made direct payments of \$1,013 and \$1,050 in 2024 and 2023, respectively, to the third party administrator which was not covered by revenue sharing.

### NOTE 7. PLAN TERMINATION PROVISIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their account balances.

## NOTE 8. FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/collective trust fund:* A collective investment trust that is composed primarily of fully benefit-responsive investment contracts valued at the net asset value (NAV) of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan may permit shares of the trust to be exchanged on behalf of participating employees only for investments in non-competing options available under the Plan. Any such asset exchange must remain in non-competing options for a minimum of 90 days before any exchange of such assets to a competing option, as defined by the investment contract, available under the Plan is permitted. Additionally, during January of each year, the Plan shall not permit more than the greater of \$500 or 25% of the shares of the trust to be exchanged on behalf of participating employees for investment in any competing option available under the Plan. There are no other participant or Plan redemption restrictions or unfunded commitments for these investments.

*Money market fund:* Valued at the NAV of units of the money market fund. The NAV is calculated by subtracting liabilities from the value of the fund's total assets and dividing it by the number of fund shares outstanding.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Independent Auditor's Report

To the Management and Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brown Stove Works, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brown Stove Works, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion



# Notes to Financial Statements

## NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Brown Stove Works, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution employee benefit plan covering substantially all employees of Brown Stove Works, Inc. (the Company) who have attained age 21 and completed one year of service. Employees may become participants in the Plan on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or following the date eligibility requirements are met. Each plan year begins on January 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

The Plan is a contributory plan whereby an employee who elects to participate may contribute a minimum of 1 percent up to a maximum of 20 percent of their annual compensation as defined by the Plan; however, the total deferral in any plan year may not exceed statutory limits. The Company may contribute a matching contribution equal to a discretionary percentage of the participant's salary deferrals. The matching percentage is determined by the Company each year. For 2024 and 2023, Company matching contributions were equal to 100 percent of eligible contributions made by a participant up to a maximum of 6 percent of the participant's eligible compensation.

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. The Plan adopted Accounting Standards Codification (ASC) 326, *Financial Instruments - Credit Losses*, effective January 1, 2023, using the modified retrospective method. In accordance with ASC 326, no allowance for credit losses has been recorded as of December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's contribution, if any, and an allocation of fund earnings and administrative expenses. Fund earnings and administrative expenses are allocated based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the total amount that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed. Participant loans are not permitted by the Plan.

### Vesting

Participants are immediately vested in their salary deferrals plus actual earnings thereon. Participants are fully vested in the Company's matching contribution portion of their accounts upon reaching age 62, upon death, or upon permanent disability. Otherwise, vesting in amounts attributable to the Company's matching contribution portion is determined under the following schedule and is based on years of credited service. A year of credited service is earned for each year in which at least 1,000 hours of service have been performed for the employer.

## NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

### Payment of Benefits

The Plan provides that a participant may begin receiving normal retirement benefits upon attaining age 62. If a participant's employment is terminated, the participant is entitled to receive all of his or her vested contributions and earnings thereon. The Plan also allows certain hardship distributions prior to retirement. Distributions may be made as lump-sum distributions or as equal installments.

### Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to pay administrative expenses or reduce Company contributions to the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51,145 and \$41,621, respectively. For 2024 and 2023, no forfeitures were used to pay administrative expenses or reduce Company contributions.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The policies that materially affect net assets available for benefits and changes in net assets available for benefits are summarized as follows:

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

Management performed an evaluation of subsequent events through October 2, 2025, the date these financial statements were available to be issued.

### NOTE 3. INVESTMENTS

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard Fiduciary Trust Company, the Trustee of the Plan, except for comparing such amounts to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the Trustee that the following information is complete and accurate.

### NOTE 4. TAX STATUS OF THE PLAN

The Company has adopted a Prototype Non-Standardized Safe Harbor Profit Sharing Plan with CODA document with a restatement effective date of January 1, 2021. The prototype plan sponsor has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been modified since receiving the favorable opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

### NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

All of the Plan's investments are managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than as a direct payment. The Plan also made direct payments of \$1,013 and \$1,050 in 2024 and 2023, respectively, to the third party administrator which was not covered by revenue sharing.

### NOTE 7. PLAN TERMINATION PROVISIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their account balances.

## NOTE 8. FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/collective trust fund:* A collective investment trust that is composed primarily of fully benefit-responsive investment contracts valued at the net asset value (NAV) of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan may permit shares of the trust to be exchanged on behalf of participating employees only for investments in non-competing options available under the Plan. Any such asset exchange must remain in non-competing options for a minimum of 90 days before any exchange of such assets to a competing option, as defined by the investment contract, available under the Plan is permitted. Additionally, during January of each year, the Plan shall not permit more than the greater of \$500 or 25% of the shares of the trust to be exchanged on behalf of participating employees for investment in any competing option available under the Plan. There are no other participant or Plan redemption restrictions or unfunded commitments for these investments.

*Money market fund:* Valued at the NAV of units of the money market fund. The NAV is calculated by subtracting liabilities from the value of the fund's total assets and dividing it by the number of fund shares outstanding.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
