We have performed audits of the financial statements of Chemonics International, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of the Chemonics International, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Chemonics International, Inc. (Company) for the benefit of all employees who are not temporary or leased employees. Employees must work greater than six months to be eligible for Company contributions. Procurement and Logistics Technology Center (PLTC), a 100% owned subsidiary of the Company, is also a participating employer. Effective June 25, 2024, Chemonics Capital, LLC was added as a participating employer. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan trustee is Empower Trust Company, LLC (Empower), the custodian of the guaranteed interest account is Empower Annuity Insurance Company (EAIC) and the recordkeeper is Empower Retirement Services.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of 1% to 100% of eligible compensation, up to the maximum allowed by law. Employee rollover, Roth and after-tax contributions are also permitted. After-tax contributions are allowed from 2% to 15%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Employees, who are not Third Country Nationals, are automatically enrolled at 5%, unless enrollment is waived or percentage deferral is changed. There is an automatic 1% increase each year until the percentage deferral reaches 15% or the participant elects to waive the automatic increase. Third Country Nationals, those employees who are not United States citizens and working in a foreign country, are not automatically enrolled.

The Company may make discretionary matching contributions to the Plan, as well as discretionary profit-sharing contributions. Employees must complete six months of service to be eligible for Company matching contributions and have 1,000 hours to receive Company discretionary contributions. For the years ended December 31, 2024 and 2023, the Board Managers of PLTC elected to make a 4% of eligible compensation employer contribution for PLTC employees only. For the year ended December 31, 2024, the Board of Managers of Chemonics Capital elected to make an employer contribution of 100% on the first 4% of the participant's eligible compensation and 50% on the next 2% of the participant's eligible compensation for Chemonics Capital employees only. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the funds and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after four years of credited service. Participants receive 25% of vesting service on the Company contribution account after the first year of credited service and 25% for additional years after year one. The nonvested balance is forfeited upon termination of service. Forfeitures are used to pay administrative expenses, reduce Company contributions, and any remaining, reallocated amongst eligible participants.

Payment of Benefits

Benefits under the Plan are paid in cash in a lump-sum or in installment payments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may make withdrawals after reaching age 59.5 and, under certain circumstances, are allowed to make hardship withdrawals and after-tax deposit account withdrawals. A participant is eligible to receive a distribution from the Plan upon the participant's termination of service, death, disability or retirement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts and unclaimed property accounts totaled approximately \$431,000 and \$423,000, respectively. Forfeitures of \$2,327 were used to pay Plan administrative expenses for the year ended December 31, 2023. Forfeitures of \$55,708 were used during 2024 to correct prior year vesting percentage errors.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants may have two loans outstanding. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prime rate plus 1%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. As noted in the subsequent event footnote, there was a partial plan termination that occurred as of April 2025 due to the termination of greater than 20 percent of the Company's workforce.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. The Plan has a fully benefit-responsive contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The self-directed brokerage accounts consist of common stocks, money market funds and mutual funds. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

The Plan's interests in the common collective trust is valued using net asset value (NAV) as the practical expedient at year end. There are no practical redemption restrictions for these investments and the redemption notice period is daily.

The fully benefit-responsive guaranteed selected fund investment contract is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Empower Trust Company. This prototype plan document has been filed with the appropriate agency and has been amended since the favorable opinion letter has been received. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee and Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and EAIC, the trustee and custodian of the Plan, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income, interest income from notes receivable from participants and other income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets held at year end as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and self-directed brokerage accounts (common stocks, mutual funds and money market funds). If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. There are no Level 2 investments held. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 investments held by the Plan.

Note 5. Investment Contract With Insurance Company

The Plan has a fully benefit-responsive investment contract with Empower Life. Empower Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The effective annual interest rate will never be less than 0%.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustees and custodian. The Plan paid administrative, advisory and contract fees to Empower and Empower Life of \$182,900 and \$174,767 during 2024 and 2023, respectively.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

During 2025, due to the loss of the Company's main source of contract revenue from USAID, the Company terminated approximately 700 eligible employees of the Plan. This triggered a partial Plan termination which all employees impacted by this termination became 100% vested in their account balance.

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
