### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Washington University Retirement Medical Savings Account Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **1. DESCRIPTION OF THE PLAN**

The following brief description of the Washington University Retirement Medical Savings Account Plan (the “Plan”), which was established January 1, 2007, by Washington University (the “University”, the “Employer”, or the “Plan Administrator”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan enables the Employer to provide any Eligible Employee with an account that they can use to save for retiree medical expenses on a tax-favored basis (earnings grow tax-free) while employed. Eligible Employee is defined as an employee hired on or before the first day of the Plan Year and either (a) a benefits-eligible regular faculty member of the Employer with an appointment of 50% of the required full-time faculty workload or a regular semester-based teaching faculty member on the Danforth campus with a semester appointment of at least 6.5 credit hours, (b) a benefits-eligible staff member whose standard work schedule is 20 hours or more per week, or (c) a benefits-eligible staff member who regularly works 20 hours or more per week and who is a member of the International Union Operating Engineers Local No. 148.

Prior to 2014, the Employer made a contribution to the accounts of those employees who contributed a minimum annual amount or greater based on their salary. The contribution amounts by both employees and the Employer were made each pay period. Employees were immediately vested in the Employer contributions. The Employer stopped making contributions effective January 1, 2014, however, employees remain eligible to make contributions each pay period. The employee selects from several options for investment of the funds. Earnings on the amounts contributed are not subject to income tax if they are used by employees to pay for eligible medical expenses for themselves or their dependents after the employee retires. Eligible expenses include retiree health plan premiums, Medicare premiums and out-of-pocket health expenses after retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Additions and Changes to the Plan**

There were no significant amendments to the Plan during plan years 2024 and 2023.

##### **Funding**

The Employee After-Tax Contribution Trust and the University-Contribution Trust (collectively the “Trusts”), established under the Trust Agreement are funded by after-tax contributions made by the employee and by tax-free contributions that were made by the Employer, respectively. Employee contributions are withheld from the individual participants’ payroll.

Employees may invest their contribution accounts in investment options according to procedures and requirements set forth by the Plan Administrator. The participant may select and may change investment selections periodically, according to procedures and requirements set forth by the Plan Administrator.

##### **Administrative Expenses**

Administrative expenses consist primarily of trustee and claims administration fees.

The Employer pays the account administration fees for active employees and for retirees and surviving spouses, provided the employee retired in accordance with Employer policies and procedures. Those who terminate employment with the Employer will be responsible for their own account administrative fees. Investment fees are paid out of the investment earnings on the funds prior to being credited to the account.

**Forfeitures**

Forfeitures include residual balances remaining in either the employee after-tax contribution account or the University-contribution account, after (a) the participant has died, and (b) the spouse has died, or (c), if for a period of five consecutive years following termination of employment a Participant's account is inactive and the Plan Administrator is unable to locate the Participant (or confirm that the Participant is deceased), the Plan Administrator may instruct the Trustee to forfeit the balance of the Participant's accounts, subject to reinstatement (including applicable gains and losses) paid out of each Trust's forfeiture account (or by the Employer if such forfeiture accounts are insufficient) in the event that the Participant or other individual with rights to the accounts contacts the Plan Administrator. Such forfeited amounts may be used to reduce future Plan administrative costs.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investments**

Investments are held at the Trustee and Custodian, Teachers Insurance and Annuity Association of America (TIAA) as of December 31, 2024 and 2023, and are stated at fair value as determined using publicly stated quotes.

**Payments to Participants**

Payments to participants for eligible expenses are recorded upon distribution.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

The financial statements have been prepared using values and information available to the Plan as of December 31, 2024.

**3. TAX STATUS**

The Trusts received exemption letters dated September 27, 2007 from the Internal Revenue Service (IRS), in which the IRS determined that the Trusts of the Plan are exempt from federal income taxes under Section 501(c) (9) of the Internal Revenue Code. The Plan has been amended since receiving the exemption letters. However, the Plan Administrator believes that the Plan and related Trusts are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**4. INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments at Fair Value as of December 31, 2024 and 2023 included in the Statements of Net Assets Available for Benefits.
- Interest and Dividends and Net Change in Fair Value of Investments as reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.
- Investments as reported in the supplemental Schedule of Assets (Held at End of Year) at December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**5. DISCLOSURES ABOUT FAIR VALUE MEASUREMENT**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level I – Quoted prices in active markets for identical assets or liabilities.

Level II – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level III – Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

As of December 31, 2024 and 2023, all of the Plans investments were in mutual funds having daily quoted net asset values (NAV) in active markets and are considered Level I in the fair value hierarchy. The funds are valued by the Trustee and compared with quotes received from a third party. Appropriate procedures are undertaken by the Trustee to assure pricing of the funds is accurate. To provide further assurance, the Plan Administrator compares NAV provided by the Trustee with publicly available quotations. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**6. PARTY IN INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in assets managed by an affiliate of TIAA. Effective May 1, 2024, all proprietary mutual funds of TIAA were renamed from TIAA-CREF funds to Nuveen funds. TIAA acts as custodian for those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**7. PLAN TERMINATION**

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of applicable law. Effective January 1, 2014, the Employer chose to discontinue its contributions. In the event of plan termination, the net assets will be used for the payment of claims outstanding.

**8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through June 26, 2025, which is the date the financial statements were available to be issued.
