INDEPENDENT AUDITOR'S REPORT

To the Baldwin Family Health Center, Inc. Salary Savings Plan Participants

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Baldwin Family Health Care, Inc. Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Baldwin Family Health Care, Inc. Note 1. Description of the Plan

The following description of Baldwin Family Health Care, Inc. (Organization) Salary Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the organization. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee becomes a participant in the employee elective deferral portion of the Plan on his/her first day of employment with the employer. Participants become eligible in the employer match upon one year of service. There is no minimum age requirement for employee or employer contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation and have it contributed to the Plan up to a maximum allowed for calendar year 2024 of \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. An additional maximum deferral of \$7,500 was allowed for calendar year 2024. The plan allows employees to make Roth deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their and the organization's contributions into various investment options offered by the Plan. The Plan currently offers numerous mutual fund investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 6% of eligible compensation. The Organization may elect to contribute 100% up to the first 4% of base compensation that a participant contributes to the Plan.

Participants Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Organization's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Elections

The participant contributions and the company matching contributions are allocated to the various investment options offered by the plan as directed by participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 2.25% to 7.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions. The Plan limits the number of loans a participant may take out to one per year.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For hardship withdrawals, a participant is limited to withdraw any amount of his contributions plus earnings thereon.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$54,912 and \$20,096 respectively. These accounts will be used to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$0 and \$0 from forfeited nonvested accounts.

Note. 2 Summary of Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported assets and changes therein, and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note Three for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

All operating expenses of the Plan are paid by the Organization and are therefore excluded from these financial statements.

Date of Management's Review

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 inputs for the period presented.

The following is a description of the valuation methodologies used for assets measured at fair value.

Level 1 - A pooled separate account is an account separated from the insurance company's general account that holds assets allocated to that account. Principal Life uses a unit value system regarding the separate accounts. The net asset value (NAV) is available to current investors and is the basis for current transactions.

Level 3 – The guaranteed investment contract with an insurance company is not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed investment contract is contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Note 5. Tax Status

The Internal Revenue Service has determined and informed Principal Life Insurance by a letter dated March 31, 2014, that the Plan and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code (IRC). Although, the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 6. Party-In-Interest Transactions

Plan investments are shares of investments owned by Principal Global Investments and Principal Financial Advisors. Principal is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions under ERISA. Fees paid by the Plan for the investment management services amounted to \$107,029 and \$89,744 for the periods ended December 31, 2024 and 2023.

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee fees are paid directly by the Organization.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the organization has the right under the Plan to amend any or all provisions of the Plan, as well as discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks, as well as valuations assumptions based on earnings and cash flows. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
