Independent Auditor's Report

To the Plan Administrator of
Screen Actors Guild - Producers Pension Plan 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Screen Actors Guild - Producers Pension Plan 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Screen Actors Guild - Producers Pension Plan 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan

Description

The following brief description of the Screen Actors Guild - Producers Pension Plan 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan's operations.

General

The Plan is a single-employer defined contribution plan covering employees of the Screen Actors Guild - Producers Pension Plan (the "Plan Sponsor"). The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Employees are immediately eligible upon hire to make contributions to the Plan. The Plan is operated in accordance with adoption of the American Funds Distributors, Inc. Prototype Standardized Profit Sharing Plan with a Cash or Deferred Agreement ("CODA").

Contributions

Each year a participant may contribute on a pre-tax and post-tax basis through regular payroll deductions up to the Internal Revenue Service ("IRS") maximum of \$23,000 for December 31, 2024 and \$22,500 for December 31, 2023 or such lesser amounts as determined by the discrimination tests for the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRS maximum of \$7,500 for December 31, 2024 and \$6,500 for December 31, 2023. The Plan permits rollover contributions from the following qualified plans described in the Internal Revenue Code ("IRC") Section 401(a) or 403(a), 403(b) plans, 457 plans and IRAs. Rollovers of after-tax employee contributions are not allowed. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan includes an auto escalation clause, whereby the deferral percentage will increase by 1% per year up to a maximum of 6% of compensation. Automatic deferral increases apply to all participants unless they affirmatively elect to opt out of this feature.

The Plan Sponsor may make discretionary, nonelective contributions allocated to participants employed at year end, based on a ratio of annual eligible compensation. Participants may receive the contribution if the participant dies, becomes disabled, or reaches normal retirement age during the year. Participants terminated during the year, who are credited with 501 or more hours of service during the year, are eligible for contributions. No such contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contribution, if applicable, and allocations of Plan earnings, and charged with benefit payments and administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, with a minimum of \$1,000 and a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest of 1% plus the prime rate, as published by the Wall Street Journal. The maximum term for a general loan is five years and the maximum term for a residential loan is ten years. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's account or annual installments for a set period of time, not to exceed the participant's assumed life expectancy. If a terminated participant's total vested account balance does not exceed \$5,000, a de minimis distribution will occur. As of December 31, 2024 and 2023, there were no participants who had elected to withdraw from the Plan but had not yet received payment.

Participants may also elect to withdraw in cash certain vested amounts within their contribution account to the extent necessary to meet a financial hardship in accordance with the regulations and rulings of the IRC. Effective for all Plan years beginning after December 31, 2018, the Plan allows participants to continue making additional contributions to their account after the hardship withdrawal.

Expense Reimbursement Holding Account

The Plan had an expense reimbursement account as of December 31, 2024 and 2023. Expense reimbursement balances were \$4,240 and \$4,037, respectively. This account is used to reduce recordkeeping administrative fees.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value and are held by Capital Bank and Trust Company (the "Trustee"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. In accordance with the policy of presenting investments at fair value, net appreciation or depreciation (net realized and unrealized gain or loss) in value is reported for investments bought and sold, as well as held, on the statements of changes in net assets available for benefits for the period in which it occurs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based upon terms of the Plan document. The fixed interest rate on loans is the prime interest rate plus 1%. At December 31, 2024, interest rates range from 4.25% to 9.50%.

Excess Contributions Refundable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in the following plan year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivables from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment related expenses have been offset with net investment income and are not readily determinable.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024 for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through October 7, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure in these financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Money Market Funds: are valued at original cost plus accrued interest, which approximates fair value.

Registered Investment Companies: are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

4. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by the trustee, and therefore, these transactions qualify as party-in-interest transactions.

The Plan invests in American Funds registered investment companies. The Trustee for the Plan is a division of American Funds Retirement Services. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. To the extent that expenses are not covered by revenue sharing, the Plan is responsible for direct payment of fees relating to the Plan's operations with the exception of loan administration, investment fees and certain distribution expenses, which are deducted directly from the individual participants' accounts.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Capital Bank and Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan adopted a pre-approved plan offered by American Funds Distributors Inc. The pre-approved plan received an IRS Determination Letter dated June 6, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Determination Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Differences Between the Financial Statements and Form 5500

Notes receivable from participants differ between Form 5500 and the financial statements. Form 5500 does not include participant loans in default as part of net assets available for benefits, whereas the financial statements include defaulted loans as part of notes receivable from participants on the statements of net assets available for benefits.

Participant contributions differ between Form 5500 and the financial statements due to the excess contributions returned to participants. Excess contributions returned to participants are reflected as a liability on the statements of net assets available for benefits, whereas the Form 5500 includes these monies with participant contributions.
